

PROCEEDINGS OF 41ST ANNUAL SESSION

The 41st Annual Business Session of the Florida State DeMolay Association was called to order on July 28, 1974 at 9:08 a.m. by State Master Councilor Wallace J. Moneyhun; Deputy State Master Councilor Walter H. (Rickey) Ricks; State Senior Councilor Leland S. Cool, III; and State Junior Councilor Clyde Cooper.

Dad G. L. Hunt was presented to the members and guests of the 41st Annual State Conclave, after which he introduced the guest speaker, Dad G. L. Myers who is the Most Worshipful Grand Master of Masons in the State of Florida. Dad Myers spoke on the subject of DeMolay sponsorship and of the charitable functions that Masonry involves itself in.

The State of the Order Address was presented and read to the delegation by the State Master Councilor. (See copy attached p. 27

The meeting was declared in the state of recess at 9:30 a.m. so that the Advisors and Mother's Club members could attend their meetings.

At 9:50 a.m. the 41st Annual Business Session was duly and regularly opened for the transaction of business.

Brother Hess gave the Credentials Committee report which was as follows:

Brother Colegrove made a motion to allow smoking during the meeting. Seconded. Dad Bill Townsend, who was acting as the State Chapter Advisor for the business session ruled the motion out of order.

The meeting was declared in the state of recess at 10:23 a.m. so that the delegates may take a break to smoke if they wish.

The meeting was reconvened at 10:32 a.m. The State Scribe, Brother Reed Sourbeer, read the minutes of the previous Annual Business Session and moved that the minutes be accepted as read. Seconded.

Brother Colegrove rose and said that a formal protest was entered by Province 10 concerning Dad Hunt's remarks against Brother Balis and added that it should be entered into the Minutes on page 13, paragraph 3.

Brother Ward pointed out that on page 18, paragraph 8; it states that the motion made was defeated where in fact it was tabled.

A motion was made to accept the Minutes as amended. Seconded. Motion carried.

Brother Billy Gilley made a motion for the Association to revert back to Robert's Rules of Order from Sturgis' Rules of Parlimentary Procedure. Seconded.

The floor was opened for discussion. Several points were brought up on the fact that "Sturgis' Rules" is explained in a more understandable manner.

Brother Ward moved the previous question. Seconded. Motion carried. The motion to revert back to Robert's Rules of Order was passed.

Dad Hunt announced that a television and a push cart were missing from the hotel. He said that money will be acessed from the chapters if the merchandise is not returned.

Brother Moneyhun announced that everyone should register their guess of what the slogan "CUAP" means. The person who guesses properly will be reimbursed for their conclave registration. He said that further details will be announced later.

Brother McPhearson presented and read the State Constitutional Revisions Committee report. Brother McPhearson then moved that Article 3B section IV be accepted as read. Seconded.

Brother Smallwood asked why this article was being changed. Brother Moneyhun added that according to the present By-Laws the members couldn't go to Disney World on Tuesday because the Association has to hold State Elections on that day.

Brother Ward made a friendly amendment to Article 3B section IV that the following should be added to the end of the proposed amendment: ... "after the delegation has accepted the proposed time at the first business session." Amendment approved.

Brother McPhearson moved that Article 3B section IV be accepted as amended. Seconded. Motion carried.

Brother McPhearson moved that Article 3B section IX be accepted as read. Seconded.

There was discussion on the floor concerning the way abstentions alter the final vote.

The subject was cleared up and Brother Ward moved the previous question. Seconded. Motion carried.

Article 3B section IX was accepted as read.

Brother McPhearson stated that the proposed amendment, Article 3B section XV has been scratched. He then moved that the amendments become effective immediately. Seconded. Motion carried.

Brother Rose presented and read "The Florida DeMolay" Committee report to the delegation. (See copy attached p. 30)

Brother Ward moved that the report be accepted as read. Seconded.

Brother Samllwood objected on the point that he didn't have enough time to read the report entirely. Brother Ward withdrew the motion.

Brother Rose then read the "Special Conclave Edition" of "The Florida DeMolay." Brother Peck pointed out that on page 4 of the paper it states that he is a Past Scribe where in fact he is a Past Provincial Master Councilor.

A motion was made to accept the committee report as read. Seconded. Brother Smallwood asked that if "The Florida DeMolay" continues to lose money will it be discontinued.

Brother Moneyhun stated that Dad Hunt wants "The Florida DeMolay" to continue even if it loses money because he feels that it is beneficial to the State Association and to the members individually.

Motion to accept the committee report was passed.

Brother Rose commented on the article about the brothers in Province 7 who were involved in the car accident. He said that if anyone would like to (personally) send the brothers a card or flowers to ask him and he will tell you how to get in touch with them.

The meeting was recessed at 12:05 p.m. for lunch and reconvened at 2:00 p.m.

The Credentials Committee report was as follows:

Brother Moneyhun announced a telephone number to call if anyone would like to purchase a corsage for their date at the Grand Banquet. He also announced that Howard Freeze Chapter donated \$29.01 to the brothers involved in the car accident. They challenged all the chapters in the state to top the donation.

Brother Porterfield presented and read the State Public Relations and Publications Committee report to the delegation.

(See copy attached p. 32) In the context of the committee report were new ways of getting better public relations for DeMolay.

Brother Ward moved that the delegation accept the report as read. Seconded.

Brother Colegrove was opposed to the report because he felt that the State Association is trying to take away the chapter's right to plan out their own ideas for Public Relations.

Brother Mard commented that the report is only recommending to the chapters ways of helping to promote DeMolay in their areas and that the chapters themselves must vote whether or not they are going to participate in any of the ideas listed.

The report was then voted on and passed.

Brother Porterfield then read the rules and regulations for the State Newspaper Competition.

Many questions were asked on the judging of the competition. One question was that if the type of printing affects judging because offset style is clearer than a mimeograph copy.

Brother Porterfield stated that the judges aren't interested in the type of printing, but in the content of the articles, the number of typographical errors, interest, and the overall effect the paper has to keep the members informed on the activities of the chapter.

It was also asked, what happens in the case of a tie. After consideration to the question a friendly amendment was added to the rules as follows: ... "In the case of a tie both papers will be judged by the entire judging committee to determine the winner."

Brother Colegrove made a motion to refer the report back to the committee for further consideration. Seconded. Motion defeated.

Brother Ward moved the previous question. Seconded. Motion carried. The Rules and Regulations for the State Newspaper Competition were passed as amended.

The meeting was recessed at 3:06 p.m. for a short break. At 3:18 p.m. the meeting was reconvened.

Brother Moneyhun presented and read the State Conclave Committee report to the delegation on behalf of Brother Jay Kicklighter, chairman of the committee. (See copy attached p. 34)

Questions were raised to Brother Moneyhun as to why there is no information in the report. Brother Frank Cooper, who is a member of the committee, commented that there is some information but not enough for any important conclusions to be drawn. Brother Cooper moved that the committee report be accepted as read. Seconded.

Brother Moneyhun suggested to the delegation that if they have any ideas of have looked into places such as colleges to submit them to Dad Hunter and/or the State Conclave Committee for consideration.

Brother Mard moved the previous question. Seconded. Motion carried. State Conclave Committee report passed.

The Annual Report of the State Membership Committee was presented and read to the delegation by Brother Moneyhun on behalf of Brother Keleman, chairman. (See copy attached p. 35)

Brother Ward asked where the funds will come from to support the 10% yearly increase of funds for the committee.

Brother Moneyhun stated that the committee is allowed a certain amount of money per year, and if the committee needs more money they ask Dad Hunt and state their reasons for the deeded monies. Dad Hunt then decides whether or not to give the committee the extra funds.

Brother Ward moved to accept the report as read. Seconded. Brother Ward then again rose and moved that the phrase "with an annual 10% increasement..." be striken. Seconded.

Brother ward stated the reason for this is that if the committee needs more money the next year, they can ask the delegation at State Conclave for a bigger basic fund, otherwise, if the phrase was left in the committee would only be getting a 10% increase and the committee may need more funds than just 10% of \$300 which is only \$30.

The previous question was called and seconded. Passed. The motion by Brother Ward to strike out the phrase was striken.

Brother McNutt moved to add "and to increase the \$300 allowed as needed." where the other phrase was striken.

Brother Ward rose to a point of order and stated that the motion to amend by Brother McNutt is out of order.

Brother Colegrove requested a ruling by the State Parlimentarian on the validity of the motion.

Brother Mard stated using Sturgis' Rules of Parlimentary Procedure as a guide, quoted "an amendment may not be made that would alter a previous amendment which was passed."

Brother Mard then reclined his previous motion to strike out the phrase "with an annual 10% increasement..."

Brother McNutt then moved to amend the report as follows: Strike out the phrase "with an annual 10% increasement..." and replace it with "and to increase the \$300 allowed as needed." Seconded. Motion carried.

The State Membership Committee report was passed as amended.

The monthly publication of the Florida State DeMolay Association is a newspaper called "The Florida DeMolay."

As Editor-In-Chief for this past year, I have found that this newspaper has been a very rewarding experience for me, in trying to disseminate the news of the Florida State DeMolay Association to all of the Chapters, DeMolays, and Advisors.

We have had our difficulties in trying to get the necessary information, but we have had many rewards, with the quality of articles, and even having several of our state newspaper articles reprinted in the International DeMolay Cordon.

The following information on the operation of the newspaper is furnished per your request:

- A. The process that has been used for the past two years in the publication of this newspaper is as follows:
- 1. The information is gathered by the Editor-In-Chief, who at this time resides in Miami. The articles are received from various sources, but principally from the State Councilors and from a very few faithful reporters and advisors that constantly send in information for publication.
- 2. After the information is collected, it is edited and prepared for typing by the staff on special set-up sheets, so as to allow the typist flexibility in order to keep the square columns (even on both sides), and thereby making the paper easy to prepare.
- 3. After the sheets are prepared, a lay-out is used putting the articles on the various pages of the newspaper, so that the space available is used to the fullest extent.
- 4. Previously, the newspaper was then typed by the Administrative Assistant to the Executive Officer, but during the past few months, the paper has been sent to Jacksonville for typing and mimeographing by the Director of Publications.
- 5. After the typing and mimeographing, the newspaper is assembled and mailed out to over 450 addresses throughout the state. Also there are a few copies sent to other publication offices in the U. S.
- 6. This newspaper is published on monthly basis, and the target date for publication has been the 15th of the month.

B. The layout cost of the publication be computed as follows:

Stencils for the newspaper (average 6 pages per issue)	\$ 1.50
Paper for mimeographing (approximately 1500 sheets)	8.10
Postage (bulk rate)	7.65
Miscellaneous supplies and other postage expenses	2.50
AVERAGE MONTHLY EXPENSE	\$19.75

The estimated total newspaper expense for 12 issues would then be in the vicinity of \$240.00.

The average number of subscriptions has grown from approximately 40 to 65 during the past year, which would then bring an income of \$65.00 against the expense of \$240.00. The \$175.00 expenditure by the State Association is a small amount to pay for this extremely good means of communication, and with a good campaign on subscriptions, the amount needed from the State Association could be considerably less, and possibly the paper could be turned into a break-even situation.

C. The newspaper has proved to be a worthwhile project for the Florida State DeMolay Association since its inception two years ago by the State Senior Councilor at that time; Wally Moneyhun. It is hoped that during the next term, many more DeMolays, Advisors, Mothers and friends of DeMolay will participate by submitting articles for publication. The newspaper is for all of the members of Florida DeMolay in the dissemination of news, information, and what is happening in the state, and is not just for those few individuals who will take the time to prepare articles for publication.

If more members of the association will take advantage of this service, it is expected that this newspaper as it is now constituted, or even an enlarged publication will serve DeMolay in Florida as a necessary arm of the Florida State DeMolay Association.

- 1. Newspaper Competition shall be limited to regular publications of chapters and provinces within the Jurisdiction of Florida.
- 2. Three issues published since the preceeding State Conclave must be submitted to the Chairman of the Publications and Public Relations Committee of the State of Florida no later than 30 days prior to the beginning of State Conclave.
- Papers may be printed or mimeographed but must be published on a regular basis.
- 4. The Judging Committee shall consist of 5 judges, all DeMolays experienced in the feilds of journalism who will be nominated by the State Publication and Public Relations Committee and approved by the State Master Councilor.
- 5. The members of the Judging Committee shall remain anonymous. No Advisor or DeMolay who have submitted a newspaper for competition may be a member of the Judging Committee.
 - 6. The judging shall be done on the following basis:
 - A. LAYOUT
 - 1. Makeup
 - 2. Heads, Paper, Bindings
 - B. CONTENT
 - 1. Quality, Typographical accuracy
 - 2. Interest
 - 3. Publicity of State and ISC Programs
 - C. ARTWORK
 - D. EDITORIALS

Each of the four categories shall carry the same weight and be judged on a 1-10 scale, 10 being the highest possible achievement. Each judge will examine and judge each newspaper individually and the newsletter with highest score total will be declared the winner. In the case of a tie both papers will be judged by the entire judging committee to determine the winner.

STATE MEMBERSHIP COMMITTEE

Annual Report

Membership is the life blood of any organization, most especially ours. We are dependent upon new members by virtue of the finite age limits placed upon our Order. Accordingly, we the members of the State Membership Committee, in caucus have proposed the following:

- of \$300.00 was requested to finance the operations of the committee. No such funds were forthcomming. Consequently, we propose that such monies be made an intergral part of the State Association budget, and to increase the \$300.00 allowed as needed. These funds should be used to produce a series of short promotional pamphlets to be released on monthly intervals to each chapter. The suggestions concerning the compositions of these materials follows.
- 2. The committee further proposes that the pledge class concept be employed in a broader manner than that currently in use. Inasmuch as fewer and fewer chapters are having large membership classes, and in view of our Order is dedicated to brotherhood, this committee suggests that in each province a monthly pledge class be held in conjuction with a monthly membership class. This class would enable the Provinces to strengthen inter-chapter unity by:
 - A. Alloting each chapter a portion of the instruction
 - B. Introducing a uniformity to Ritual work
- C. Increasing interaction among the old as well as new Brothers.
- 3. It is proposed that the Florida State DeMolay Association devise and publish its own membership materials. An informal survey taken by the members of this committee indicates that many Florida DeMolays feel that the materials be applicable to our State. Apparently many of our members feel that the publications of the ISC are geared to a lower age group level than 13. As a trial project, the committee endorses the creation of new, Florida oriented materials for use in the next 12 month period.
- 4. As an appendent Order of the Masonic Bodies, DeMolay desires the full support of all Masonic Bodies. Often Masters and Wardens Associations, Blue Lodges, Consistories, and Encampment fail to respond to our membership drives. The committee feels that concerned effort should be made by all Chapter Advisory Councils to keep the name of the Order through publicity in and around Masonic Lodges. Our State Association should begin contacting the individual Worshipful Masters of each lodge and request the names of each Master

Mason who have sons between 13 and 21. These names would then be routed to the chapters in proximity of the lodges.

These proposals should be considered by the new Membership Committee and a six month pilot program developed in one area of our Jurisdiction. If successful the programs should be expanded on a state-wide basis.

- 1. The Sentinel may enter informally (without sounding an alarm) upon being informed that the chapter is opened on the DeMolay Degree. He may leave informally when his duties demand it.
- 2. The flag should be placed to the North of the Standard Bearer.
- 3. The chapter Banner should be placed to the South of the Marshal.
- 4. All visiting Master Masons who are not advisors must be recognised in accordance with the ritual at the end of the Initiatory Degree Opening Ceremony.
- 5. The grip only is collected when collecting the word of the day of password of a DeMolay.
- 6. Only the password is exchanged between the Senior Councilor and the Deacons.

AND

BY-LAWS

(REVISED)

DISPENSATION

Dispensation is hereby granted to the Chapters of the Order of DeMolay in the State of Florida, whether under permanent charter or Letters Temporary from the International Supreme Council of the Order of DeMolay, to be associated together in an organization known as the Florida State DeMolay Association for the purpose of working for the betterment and promotion of DeMolay Ideals and activities, also to promote harmony within the member chapters of the Order of DeMolay in the State of Florida.

Dispensation is further granted to the Florida State DeMolay Association to adopt such Constitution and By-Laws governing itself and to conduct such business as are consisent with the Constitution, General Statutes and Chapter Regulations of the International Supreme Council.

FLORIDA STATE DeMOLAY ASSOCIATION Constitution and By-Laws

Constitution

ARTICLE IC NAME, PURPOSE, COLORS

SECTION I
This organization shall be known as THE FLORIDA
STATE DeMOLAY ASSOCIATION, ORDER OF DeMOLAY (hereinafter, Association).

SECTION II

It shall be the purpose of this Association to work for the betterment and promotion of DeMolay ideals and activities in the State of Florida, to promote harmony within the member chapters and to assist those chapters in bringing DeMolay to the eligible youth of Florida.

The official colors of this Association shall be the royal colors of Purple and Gold.

ARTICLE IIC ALLEGIANCE AND AUTHORITY

SECTION I

The Association, its officers, advisors and the individuals of member chapters of this Association pledge their allegiance to the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary and the Executive Officer of the Order in the State of Florida.

SECTION II

This body is constituted with the power and authority to set forth laws and regulations to govern itself, its officers and delegates and to set forth standards of interchapter relations; and to levy fees and taxes, provided that these measures are in harmony with the International Supreme Council of the Order of DeMolay and the dispensation under which this Association operates.

SECTION III

This Association shall have one (1) seal, the design of which shall be the official emblem of the Order of DeMolay inscribed within two (2) concentric circles. This seal shallbe inscribed, "The Florida State DeMolay Association, Order of DeMolay" in the space between the circles. This seal shall be known as the Association seal, and shall be placed in the hands of the State Scribe.

ARTICLE IIIC MEMBERSHIP AND REPRESENTATION

SECTION I
The members of this Association shall be the
several duly constituted Chapters, and those holding Letters
Temporary of the Order of DeMolay, located in the State of Florida.

The members of this Association shall meet annually for the purpose of conducting business, electing officers, holding sports and ritual competition and all other activities provided for in the By-Laws of this Association.

SECTION III

In order for the delegation of a member chapter to attend Conclave and register, the said delegation must be accompanied be a Certitied Member of the Advisory Council or a Master Mason, approved by the Provincial Governor for each (10) DeMolays of fraction therof in attendance. No chapter shall be allowed to register its delegation if said chapter has not paid, in full, all assessments due this Association.

Each member chapter shall be entitled to be represented by three (3) delegates at the annual Conclave. Each delegate shall have one vote in all matters brought on the floor of the Conclave, providing he has been certified by his chapter advisor and has registered with the Credentials Committee prior to the opening of Conclave. In the event that less than three (3) delegates from a Chapter are in attendance at Conclave, any or all of the absent delegate votes may be given to a remaining delegate from that chapter. In order to accomplish this, the chapter advisor must submit written authorization to the Credentials Committee before the opening of each business session of the Conclave.

ARTICLE IVC OFFICERS

SECTION I

The officers of this Association shall consist of the State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, State Scribe, State Treasurer, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Chaplin, State Marshal, State Orator, State Standard Bearer, State Parlimentarian, Seven State Preceptors, State Editor, State Committee Chairmen and all others selected by the State Master Councilor and/or Executive Officer of the State of Florida.

SECTION II

The State Master Councilor, Deputy State Master Councilor, State Senior Councilor, and the State Junior Councilor shall be elected during the general business session of the Association, in Conclave assembled each year, and these officers shall serve until their sucessors are installed.

SECTION III

All candidates for elected State office must be Past Master Councilors, Representative DeMolays and have completed the Leadership Correspondence Course. They also must be active members of a Florida Chapter and must be residents of the State of Florida for at least six months prior to election.

SECTION IV

The State Scribe and State Treasurer shall be appointed by the Board of Administration from a list of nominations submitted to them by the State Master Councilor prior to the opening of State Conclave. These appointments shall be made prior to the first session at each Conclave. The State Scribe shall serve until the approval of his minutes at the first business session. The State Treasurer shall assume office following the approval of an audit submitted to the Executive Officer. This audit shall be performed by an accountant who has been approved by the Executive Officer and shall be completed within a week after the close of Conclave.

SECTION V

All other State Officers shall be filled by appointment by the State Master Councilor. These officers shall serve until the close of the following Conclave.

SECTION VI

No candidate shall be elected to a State Office who would reach the age of 21 years prior to June 1st of the year following his election. No State Officer may attend an out-of-state school or reside outside of the State of Florida during his term of office. Any violations of these provisions shall automatically create a vacancy in the office.

SECTION VII

In the case of a vacancy in the elective offices, each State Councilor shall advance to the next highest office and a State Junior Councilor shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer. Vacancies in all other State Offices shall be filled by the appointment of the State Master Councilor.

ARTICLE VIC AMENDMENTS

SECTION I

The procedure for amending this Constitution is

as follows:

a. It shall be the responsibility of any Florida DeMolay proposing an amendment to this Constitution to provide for the distribution of said proposal to the Committee on Constitutional Revisions, Committee on Jurisprudence, Elective State Officers, Executive Officer, Board of Administration and member chapters of this Association not less than 90 days prior to the opening of Conclave.

b. The proposed amendment after approval of the Committee of Jurisprudence and the Board of Administration shall be presented for consideration on the floor of Conclave. Upon the approval by two-thirds of the delegates present and voting it shall take immediate effect.

FLORIDA STATE DEMOLAY ASSOCIATION Constitution and By-Laws

By-Laws

ARTICLE IB

REVENUE

Each member chapter shall pay as dues on or before the due date of the annual report the sum of ten dollars (\$10.00) to the Florida State DeMolay Association, Inc. In addition, each member except those holding Letters Temporary issued since the due date of the last annual report shall pay thirty cents (\$.30) pre capita tax for each DeMolay in good standing as shown on the most recent annual report to the International Supreme Council. All income received by this Association shall be deposited in the Florida State DeMolay Association Inc. Account to be distributed to the proper funds as required herein, or by other competent authority.

SECTION II

The revenue of this Association shall be derived from the following sources:

1. Dues of the Association

- 2. Per capita tax for each active DeMolay as listed in each Member's Annual Report to the International Supreme Council
- 3. Registration fees for Annual State Conclave
- 4. Sale of items approved by the Executive Officer
- 5. Gifts and/or bequests from proper sources

ARTICLE II

STATE CONCLAVE

SECTION I

There shall be Ritual competition; Athletic competition; State Sweetheart competition; election of State Officers and any other business for the good of the Order in this Association.

SECTION II

There shall be ritual competition conducted at the State Conclave under the direction of the Executive Officer's Personal Representative for International Supreme Council Ritual and Awards. This competition shall be limited to the winners of the several regions in each category. The Executive Officer's Personal Representative of International Supreme Council Ritual and Awards shall appoint no less than three (3) judges for each.

competition, who solely shall have the authority to determine the winner of each competition. The rules and regulations governing the Ritual competition shall be published along with the official minutes of each Annual State Conclave for the governing of competition at the next Annual State Comclave.

SECTION III

There shall be athletic competition conducted at the State Conclave under the direction of the State Advisor of Athletics appointed by the Executive Officer. This competition shall be limited to the winners of the several regions in each category. The State Advisor of Athletics, appointed by the Executive Officer shall appoint for each competition qualified referees for each event who shall use the rules set by the Florida High School Activities Association and who solely shall have the authority to determine the winner of each competition.

SECTION IV

There will be sweetheart competition at each annual State Conclave for the purpose of determining the new State Sweetheart. The rules and regulations governing this competition shall be determined by the State Mother's Club President, in consultation with the State Master Councilor, one hundred and twenty (120) days prior to the annual conclave.

ELECTIONS ARTICLE IIIB

SECTION I

Any qualified Brother who desires to run for an elective office of this Association shall send a letter of intent to the Executive Officer and the Chairman of the Nominations Committee, within sixty (60) days prior to the opening of registration of the annual Conclave.

SECTION II

A candidate shall not cause any distribution of materials written or oral pertaining to his candidancy before he has submitted his letter of intention to the proper persons (as stated in AIIIB, SI). He will be authorized to distribute calling cards only. They will be printed on one side only. This card will be no larger than the standard DeMolay dues card in overall size, and will contain no information other than name, address, titles and/or honors and the title of office being sought by the candidate. This card will be the only authorized material which may be distributed in his behalf at Conclave or at any other time.

SECTION III

No candidate or individual (s) representing a candidate will make public statements either verbal, written or printed at any officially designated DeMolay function or activity as to the intentions of a candidate seeking any elective office in this Association until after a date sixty (60) days prior to

the opening of registration at the State Conclave and after receipt by the Executive Officer of the candidate's letter of intention.

SECTION IV

The election of officers of this Association shall take place at the discretion of the State Master Councilor during a regular business session at each annual State Conclave.

SECTION V

Not more than two (2) State Councilors shall be from the same member chapter of this Association.

SECTION VI

It being the purpose of the Order of DeMolay to develope leadership and a sense of responsibility among individual members of the Order, officers of this Association shall not suceed themselves.

SECTION VII

Any violation of these regulations shall be constituted reason for disqualification by act of the Nominations Committee. Notification to the Chairman of the Nominations Committee of any violation may be made by any DeMolay or Advisor. Such notification should include specific evidence when possible.

SECTION VIII

The election of officers shall be in the order of rank, the highest being first, the order as provided by this Constitution, by secret ballot of those entitled to vote, as otherwise provided in the Constitution, at each Annual Conclave of this Association. A majority of the ballots cast shall be necessary for a choice to elect.

SECTION IX

The ballots for the election of officers shall be prepared by the State Scribe for each Annual Conclave. ballots shall be distributed to each delegate entitled to vote, prior to the opening of elections, and the ballots shall be cast with the surname only of the candidate for the particular office, legibly written thereon; ballots shall be folded only once. Blank ballots, illegible ballots and otherwise deviating from the proper form provided herein shall be tabulated as abstentions.

DUTIES OF STATE OFFICERS ARTICLE IVB

SECTION I

The State Master Councilor shall be the duly elected head of this Association, and it shall be his duty to perform all duties which naturally pertain to such an office or which may devolve upon him from time to time.

SECTION II

The State Master Councilor shall preside at the annual Conclave and work in conjunction with the Board of Administration. He shall also work with the Conclave Committee in making arrangements for said Conclave.

SECTION III

The State Master Councilor shall appoint all committee Chairmen of this Association, and in consultation with each chairman, appoint the committee members.

SECTION IV

The State Master Councilor shall have an expense account with funds up to twelve hundred dollars (\$1,200.00) which shall be used for reasonable expenses incurred in the performance of his and the other State Councilor's duties, with the State Master Councilor's approval.

SECTION V

The State Master Councilor shall in person, or by Special Deputy, visit each provincial chapter in this state at least once during his term of office.

SECTION VI

The Deputy State Master Councilor, the State Senior Councilor and the State Junior Councilor shall represent the State Master Councilor as his Special Deputies when so ordered.

SECTION VII

The State Master Councilor shall report in writing to the Association at each Annual Conclave, all of his Official Acts, whether performed in person or by Special Deputy.

SECTION VIII

The State Senior Councilor shall serve as Chairman of the Jurisprudence Committee

SECTION IX

The State Junior Councilor shall serve as Chairman of the Conduct Committee.

SECTION X

The Deputy State Master Councilor, the State Senior Councilor and the State Junior Councilor shall assist the State Master Councilor in every way possible in the discharge of his duties.

SECTION XI

The Dpeuty State Master Councilor, the State Senior Councilor and the State Junior Councilor shall report in writing to this Association at each Annual Conclave, all of their Official Acts. SECTION XII

The State Scribe shall record the minutes of the Annual Conclave of this Association. He shall then within sixty (60) days have the aforesaid minutes together with the Constitution and By-Laws as of their latest revision, published together with the rules and regulations of the ritual and sweep-stakes competition to be distributed as follows:

- 1. One copy to each member of this Association
- 2. Copies to the Executive Officer, one copy to each member of the Supreme Council residing in the state, and one copy to any advisor appointed by the Executive Officer in a supervisory capacity, including the the Board of Administration
- 3. One copy to the State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, State Scribe and State Treasurer
- 4. One copy to the International Supreme Council

SECTION XIII

The State Scribe shall under the direction of the State Master Councilor and/or the Association, conduct all correspondence of this Association.

SECTION XIV

The State Scribe shall report in writing to the Association at each Annual Conclave all of his Official Acts.

SECTION XV

The State Treasurer shall make disbursements for this Association with the approval of the Personal Representative of Finance, appointed by the Executive Officer. The State Treasurer shall make an itemized report of all transactions in connection with this office at the Annual Conclave.

ARTICLE VB

STATE CABINET

SECTION I

Master Councilors of the several Provinces. This Cabinet will function at the will of the State Master Councilor. The Deputy State Master Councilor shall serve as Chairman.

SECTION II

This Cabinet shall help coordinate activities, help in the unification of this State, and act in the capacity of a grievance committee if need be.

ARTICLE VIB

COMMITTEES

SECTION I

The standing committees of this Association shall consist of those named in Article V, of the Constitution.

SECTION II

The duties of the Jurisprudence Committee shall be to determine the constitutionality of all motions, resolutions, and proposals presented by the standing committees or from the floor of the Conclave.

SECTION III

The duty of the Resolutions Committee shall be to bring to the delegates of the members resolutions that will benefit DeMolay in the State of Florida.

SECTION IV

The duty of the Nominations Committee shall be to review the qualifications of every candidate for an elective office of this State in order to determine if said candidates are constitutionally qualified to hold such offices. At the time of the elections the Nominations Committee shall present to the delegates at Conclave the list of qualified candidates seeking an elective office.

SECTION V

The Membership Committee shall study and promote an active program for the acquisition of eligible youth in this Jurisdiction.

SECTION VI

The duty of the Conduct Committee shall be the only State Committee to supervise the conduct of the DeMolays under the direction of the State Advisor of Conduct, appointed by the Executive Officer, assembled at any statewide DeMolay activity.

SECTION VII

The duty of the Credentials Committee shall be to validate the credentials of all delegates to Conclave in accordance with Article III, Section IV, of the Constitution. This committee shall be responsible for arranging the seating of said delegates.

SECTION VIII

The duty of the Public Relations and Publications Committee shall be to promote the image of DeMolay throughout the State of Florida and to oversee the publication of materials as the State Master Councilor deems necessary.

SECTION IX

The Ritual Committee shall promote uniformity in the ritual of the Order of DeMolay throughout this Association, and shall recommend to the Association for approval, procedures for the performance of ritualistic matters not specifically set forth in the Ritual of Secret Work of the Order of DeMolay and methods of receiving, intorducing and accommodating those who are entitled recognition in all conclaves, meetings and public ceremonies of the Association.

SECTION X

The Conclave Committee shall select from those presented to it at least two (2) proposals for the time and place of Annual Conclave, and present said proposals to the Executive Officer's Personal Representative in charge of Conclave.

SECTION XI

The Athletics Committee shall work with the State Advisor of Athletics in acquiring qualified officials for all state athletics competition. They will also review and submit any proposals to the Conclave Committee, for the athletics program.

SECTION XII

The duty of the Constitutional Revisions Committee shall be to recommend pertinent and necessary revisions to the Constitution and By-Laws.

SECTION XIII

The State Master Councilor shall announce the names of the Committee Chairmen for the comming year at the close of the last business session of Conclave no later than fifteen (15) days after the close of Conclave. The names of the chairmen shall be published in the current minutes of the Association.

SECTION XIV

(5) members appointed by the State Master Councilor, the first named members being chairmen.

SECTION XV

It shall be the duty of each committee chairman to submit to the State Master Councilor a report upon request.

SECTION XVI

The final committee reports shall be type written and submitted to the State Scribe no later than the beginning of the last business session at each Conclave.

SECTION XVII

The State Master Councilor shall have the power to establish additional committees as he deems necessary.

ARTICLE VIIB BOARD OF ADMINISTRATION

SECTION I

The body appointed by the Executive Officer in an advisory capacity for this Association shall be known as the Board of Administration. The Board of Administration shall be composed of Personal Representatives of the Executive Officer and other advisors as the Executive Officer may deem necessary to appoint. All legislative matters shall be submitted to the Conclave is subject to review by the Board of Administration. Action of the Board on any matter may be reviewed by the Executive Officer for approval or disapproval.

ARTICLE VIIIB AMENDMENTS

SECTION I

These By-Laws can be amended by the same procedure as outlined in Article VIC, Section I, except a simple majority is required for passage, an amendment may be submitted at any time prior to the first business session of Conclave.

JURISDICTION OF FLORIDA

RITUAL COMPETITION RULES

GENERAL:

- 1. Every contestant MUST have an Obligation Card and a current or Life Member card. This rule will be certified by the Chapter Advisor at the time of registration.
- 2. All contestants must be members of the Chapter they are representing and cannot have reached their majority.
- 3. Competing teams will submit the nemes of their members to the person in charge of the Ritual Competition. State Conclave, the Persona; Representative of Awards and Ritual; Region Competition, the Regional Coordinator of the particular Region; Province Competition, the Province Governor; or in any of the above, to the person designated by the person in charge of the Ritual Competition.
- 4. NO RITUALS or MONITORS will be permitted in the Chapter room where the contest is held, except those in possession of the judges. All ritual work must be from memory. The use of any aid to the memory devise will DISQUALIFY the team.
- 5. Prompting from any source will subject the team to a 50 point penalty for each prompting. A judge will not prompt under any circumstances.
- 6. Spectators may be permitted if the competing Chapter has no objection but must not in any manner disturb or distract those in competition.
- 7. Contestants waiting on preparation for their scheduled appearance will not create a disturbance or distraction in the area outside the Chapter room.
- 8. Necessary properties will be furnished by a local Chapter, except robes.
- 9. The "Ritual of Secret Work of the Order of DeMolay" to be used by the judges will be the TWELFTH EDITION dated "1974" and the "Monitor of Public Ceremonies", FOURTH EDITION dated "1974", will be used for the Flower Talk.
- 10. A penalty may be invoked by the panel of judges for tardiness in appearing as scheduled after 15 minute grace period has expired.
- 11. Judges will rate each team according to their own impression without consulting each other except for rule 10.
- 12. Judges MUST NOT divulge the scoring results to any person or persons at any time. Judging score sheets will be submitted

- to the person incharge of the Ritual Competition, or to the person designated by him to handle the Ritual Competition; as defined in Rule 3.
- 13. No appeals will be accepted on Judge's scoring. Appeals will be heard only on cases involving violation of rules; substantiation to disqualify a competitor. Deadline for appeal will be 24 hours after competition.

INITIATION DEGREE

- I. A line of 22 officers is recommended, a minimum of 18 will be required for competition.
- II. The Initiatory Degree ONLY will be exemplified. Opening and closing of Chapter will be omitted.
- III. Judging will begin with the rap of the gavel in the East.
- IV. In considering Chapter dress, the use of the type robes recommended by the Supreme Council is not mandatory, neatness and uniformity are the prime consideration.
- V. If music is used, it shall be considered in the light of creating atmosphere. It should never interfere or detact from the Ritual.
- VI. Haximum time limit 50 minutes per team.
- VII. A candidate for degrees may be initiated by a team in competition. An active member may be substituted if desired.

Deliolay DEGREE

- I. A degree team of 15 members is recommended, a minimum of 12 will be required for competition. Non-speaking parts (such as guards) referred to but not limited by the Ritual may be used, as long as the entire cast does not exceed 20 in number.
- II. Only the first section of the DeMolay Degree will be presented. Begin with the Orator's part and conclude with the Lord Constable's last line.
- III. If special effects, such as robes, music, lights and makeup (as permitted by the Ritual) are used to increase the impact, they shall be considered as embellishment to presentation, not to interfere or detract from the Ritual.
- IV. Maximum time limit 30 minutes per team.

FLOWER TALK

- I. A Marshall and Candidate(s) are not required in competition.
- II. A Chapter room setting is not required for delivery of the Flower Talk. An article of furniture symbolic of an Alter will be considered adequate.

III. Maximum time limit for each competitor - 15 minutes. Rule 6 also applies.

ORATORICAL CONTEST

- I. The subject for the oration will be selected by the Personal Representative of Awards and Ritual, and will be promulgated prior to Provincial Competition.
- II. Each contestant will deliver a typed copy of his oration to the judges prior to competition. This copy to be retained by the State Association. It is understood the permission is granted to publish those orations deemed worthy of recognation.
- III. Subject matter important, thus the same copy cannot be used by more than one contestant.
- IV. Presentation may be made from memory, use of notes or read.
- V. Material used must be from the contestants own creativeness. However, quotations may be used in moderation.
- VI. Minimum time 5 minutes. Jaximum time 8 minutes for each competitor.

FINAL SCORING SYSTEM FOR RITUAL COMPETITION

To achieve the final score that will be equitable to all competitors, the following system has been evolved.

<u>DELIVERY</u>: Contestant receiving the highest grade will be rated with a final score of 100, other contestants will have their grade divided by the highest grade to acquire the final score:

Assuming the grades assigned were 50, 65, 80, and 42. Highest grade of 80 would equal the score of 100. Grade of 65 would be divided by 80 to get final score.

i.e. $\frac{65}{80}$ = 81.25 and thusly the grade of 50 would result in a score of 62.5 and 42 a score of 52.5

RITUAL: To acquire a final score on the basis of 100 for this area of competition, add all the points that the contestants received and use the result as a divisor. For a quotient, multiply the individual contestant's (team) points by 100 and subtract the result from 100.000

Assuming the contestants received the following point count for errors: 14, 06, 01, 02, and 0, added together = 23.

$$\frac{100 \times 14}{23}$$
 = 60.869 thus 100.000 - 60.869 = 39.131

 $\frac{100 \times 02}{23}$ = 8.695 thus 100.000 - 8.695 = 91.305

accordingly 06 = 73.914, 01 = 95.653 and 0 - 100.000.

The final score would be the contestant's combined score for delivery and ritual, the highest combination would determine the winner of the contest.

INTERNATIONAL STEEPSTAKES AMARD

GENERAL RULES

Each year the International Supreme Council rates the various jurisdictions according to their participation in the ISC programs. The plaques that are awarded are symbolic of the best all-around jurisdictions in the specified categories.

There are four Sweepstakes awards presented annually with one award for each size category. All jurisdictions are listed in one of four categories, thus each jurisdiction is competing with those juridictions more nearly its own size.

The four categories are: small, for up to 500 members; medium, for 501-2000 members; medium large for 2001-3500 members; and large, for over 3500 members. The number of members will be based on the jurisdictional total as of the end of the DeMolay Year on December 31st.

The is only one international championship in each competition (if there are no ties), but a weighted grading system is utilized in most of the competitions which gives equal weight to both percentage of preformance as well as quantity of effort.

Sweepstakes points will be awarded for points credited in the 10 International competitions, consisting of Jurisdictional Membership, Chapter Membership, Blue Honor Key, Representitive DeMolay Awards, PMC Meritorious Service Award, Leadership Correspondence Cource, ISC Reports, International DeMolay Week, Chapter Publications and New Chapters.

The 10 competitions are divided into three areas of importance, with points for the first through the tenth place as indicated.

Area I (100 to 10 points)

Jurisdictional Membership Blue Honor Key Representative DeMolay PMC Meritorious Service Award Leadership Correspondence Course ISC Reports

Area II (50 to 5 points)

DeMolay Week Chapter Membership New Chapters

Area III (30 to 3 points)

Chapter Publications

The weighted system of judging is used for any competition where total number is involved, which incolves all competitions except Chapter Membership, DeMolay Week, ISC Reports and Chapter Publications.

An example of the system is shown below. ****

This weighted system of judging is used for any competition and quantity effort and the lowest resulting score of all the jurisdictions occupies first place in the contest rankings for the period being figured. A perfect score for a final ranking is 2, which means a jurisdiction scored first in both the percentage and quantitative categories.
