

The Florida DeMolay Association was officially opened at 8:10 PM on Monday July 28, 1997 with Mark D. Griffis, State Master Councilor, presiding in the East.

The Chair called for comments from the representatives of the appendant Masonic bodies, including:

The State Orator, Bro. Matthew Jefferson, gave his inspiring Grand Oration, entitled "What is a Brother?"

Dad William A. Marti, Executive Officer of the Jurisdiction of Florida, gave an inspiring lecture of the renewal of interest throughout the State regarding the Masonic Youth Groups.

Most Worshipful Grand Master of the Grand Lodge of Florida, Sam Cowan, presented Dad Marti with a beautiful Grand Lodge medallion. His following speech was truly an inspiration, and even included excerpts from the renowned "salt of the earth" speech.

Bro. Mark Griffis, State Master Councilor, gave the State of the Order address. (For text, see Page 3 of these proceedings)

Bro. Griffis declared the Association in a state of recess at 8:53 PM.

The Florida DeMolay Association was opened ritualistically at 9:20 PM on Monday July 28, 1997 with Bro. Mark Griffis, State Master Councilor, presiding.

The roll call of State Officers was called.

The State Chapter Dad, Dad Oscar Griffis, was introduced and escorted to the east.

The State Master Councilor called for any announcements, which included the report of a lost wallet.

Bro. Griffis placed the Association into a state of recess at 9:25 PM.

The Florida DeMolay Association was brought out of a state of recess at 8:14 PM on Tuesday July 29, 1997, with Bro. Mark Griffis presiding.

The Chair recognized Bro. Chris McKenney, State Credentials Committee Chairman, who delivered the following report.

CREDENTIALS COMMITTEE REPORT

This is the report of the Credentials Committee as set forth in Section 5.05 of the Florida DeMolay Association Statutes. The Chairman of this committee was Christopher McKenney, appointed at Mini-Conclave in 1997. There were no recommendations in the report of the past year.

As the duties of this committee were fairly straightforward, the Chairman served as its only member.

This year, the committee created a delegate certification card, containing the delegate's name, advisor's signature, and signature of the committee chair or his representative. This enables the Credentials Committee Chairman to quickly determine the validity of each delegate, and to prevent extra ballots being distributed during elections.

The following information regarding the number of delegates at the time of this report is as follows. There are fourteen (14) chapters registered with this committee, for a total of thirty four (34) delegates forty two (42) delegate votes. In addition, the State Senior Councilor, State Junior Councilor, and State Scribe / Treasurer are present for one vote each, raising the total to forty five (45) delegate votes. Assuming no changes in the number of registered delegates, a quorum to conduct business will be twenty three (23) votes, a simple majority will be twenty three (23) votes, and a two thirds majority will be thirty (30) votes. A list of delegates exists in the records of the State Credentials Committee Chairman.

The committee recommends that next year's committee continue the delegate registration cards in order to ensure proper order in delegate sessions.

Pursuant to Section 5.01 of the statutes of this Association, the recommendations of this report are physically and fiscally feasible.

The Chair entertained a motion to pass the report as read. Bro. Chris Cook, St. Petersburg Chapter, made the motion. Bro. Richard Salazar, Paul Revere Chapter, seconded. The motion passed.

The Chair recognized Bro. Jody Meguiar, State Nominations Committee Chairman, who presented the following report:

NOMINATIONS COMMITTEE REPORT

To the Delegates of the 64th Annual Conclave:

This is the report of the State Nominations Committee, as set forth in Section 5.03 of the Florida DeMolay State Statutes.

The members of this Committee are as follows:

- Brother Jody Meguiar, Chairman
- Brother Joseph C. Earnhardt, Jr., State Senior Councilor
- Brother Chris Richards, State Master Councilor's Representative - Area V
- Brother Michael Sullivan, State Junior Deacon

The State Nominations Committee met three times this past year. The first time was on January 19, 1997 at Mini-Conclave in Gainesville, Florida, and Brothers Meguiar, Earnhardt, and Richards were present. The second meeting was on June 28, 1997, in Tampa, Florida, and Brothers Meguiar, Earnhardt, and Sullivan were in attendance. The final meeting was before the Grand Opening of Conclave in Gainesville, Florida, and all members of the Committee were present.

At Mini-Conclave, we discussed possible candidates, and looked over the requirements for elected state office, as stated in Chapter 3 of the State Statutes. We also reviewed the due-dates for letters of intent, and concluded that the letters for State Master Councilor must be postmarked by, or on, June 25, 1997.

At our meeting on June 28th, we reviewed the letter received by Brother Joseph Earnhardt, regarding his candidacy for the office of State Master Councilor. At that time, since the deadline for such letters had already past, Brother Earnhardt was declared to be the sole candidate for the Office of State Master Councilor.

On July 28, we discussed the remainder of the letters which were received regarding other state line offices. Said letters included one from Christopher Cook and one from Cleve Fowler, declaring their intent to run for the office of State Senior Councilor. We also received a letter from Brother Jerry L. Tillman, Jr. for consideration for candidacy for the office of State Junior Councilor.

After our meeting, we received one additional letter of intent for the office of State Junior Councilor. This letter was from Brother Robert Ware, Jr. The letter was received before the said deadline, reviewed, and Brother Ware's credentials were approved by this Committee.

In summary, the following Brethren have submitted letters of intent, which were reviewed and approved by this Committee for candidacy:

The Chair entertained a motion to accept the report as read. Bro. Luke Melendez, Ralph Buck Chapter, made the motion. Bro. Jerry Tillman, Sem-I-No Chapter, seconded. The motion passed.

Bro. Griffis declared the Association to be in a state of recess at 8:21 PM.

The Florida DeMolay Association was brought out of recess at 8:30 PM on Tuesday July 29, 1997 for the purpose of Nominations.

The State Master Councilor opened the floor for nominations for the office of State Master Councilor.

The Chair recognized Bro. Jody Meguiar, State Nominations Committee Chairman, who read the letter of intent of Bro. Joseph C. Earnhardt, Jr. Bro. Christopher McKenney of Jupiter-Tequesta Chapter, gave Bro. Earnhardt's nomination speech, and Bro. Earnhardt accepted the nomination.

The State Master Councilor, with no further nominations, closed nominations for the office of State Master Councilor.

The State Master Councilor opened the floor for nominations for the office of State Senior Councilor.

The Chair again recognized Bro. Jody Meguiar, who read the letter of intent of Bro. Christopher Cook. Bro. Luke Melendez of Ralph Buck Chapter, gave Bro. Cook's nomination speech, and Bro. Cook accepted the nomination.

Bro. Jody Meguiar was then called to read the letter of intent from Bro. Cleve Fowler. Bro. Chuck Giallombardo of Sarasota Chapter, gave Bro. Fowler's nomination speech, and Bro. Fowler accepted the nomination.

The State Master Councilor, with no further nominations, closed nominations for the office of State Senior Councilor.

The State Master Councilor opened the floor for nominations for the office of State Junior Councilor.

The Chair then recognized Bro. Jody Meguiar, who read the letter of intent of Bro. Jerry L. Tillman, Jr. Bro. Larry Bernard of Sarasota Chapter, gave Bro. Tillman's nomination speech, and Bro. Tillman accepted the nomination.

Bro. Jody Meguiar was then called to read the letter of intent of Bro. Robert "BJ" Ware, Jr. Bro. Josh Marti of Sarasota Chapter, gave Bro. Ware's nomination speech, and Bro. Ware accepted the nomination.

The State Master Councilor, with no further nominations, closed nominations for the office of State Junior Councilor.

The State Master Councilor declared nominations closed, and then opened the floor for general caucuses, in which each candidate would answer a total of five (5) questions.

This session was officially placed in a state of recess at 9:30 PM.

The Florida DeMolay Association was brought out of a state of recess at 1:48 PM on Wednesday July 30, 1997 with Bro. Mark Griffis, State Master Councilor, presiding.

The Credentials Committee reported a total of 26 delegate votes present, which constituted a quorum, with fourteen (14) being simple majority, and eighteen (18) to be a 2/3 majority.

The State Master Councilor introduced an esteemed panel of guests, which included:

- Dad Bill Marti, Executive Officer of the Jurisdiction of Florida
- Dad J. G. Kiglighter, Jr., Chairman of the Board of Administration
- Dad Don Crowley, Member of the Board of Administration
- Dad Tom Jenkins, Member of the Board of Administration
- Dad Jerry Meguiar, Member of the Board of Administration
- Dad Ed Walker, Member of the Board of Administration

Bro. Mark Griffis, State Master Councilor, brought up the "Zero Tolerance" concept for discussion and debate. He explained that an ongoing problem is occurring with DeMolays and Advisors bringing alcohol to Conclave and other State functions, and open drinking / intoxication is becoming more widespread.

Merek Jones, Mid-Pinellas Chapter, suggested that if a DeMolay is caught with alcohol, he should be immediately sent home. Also if Advisors are to be our role models, they should not bring alcohol either, and should be disciplined as well.

Chris Cook, St. Petersburg Chapter, requested statistics for this matter. No one was able to present said statistics, so Bro. Cook inquired as to how this could be considered a problem without statistics.

Luke Melendez, Ralph Buck Chapter, stated that he was in agreement with Bro. Jones regarding the discipline of Advisors with alcohol.

Jimmy Braddam, George Ulee Lord Chapter, stated that if the Advisors are of legal age, Florida DeMolay has no authority to go against their rights as per the Constitution of the United States. Bro. Braddam used himself as an example, as he smokes cigarettes, being above the said legal age.

Larry Bernard, Sarasota Chapter, clarified that according to the Statutes of the International Supreme Council, DeMolays are not permitted to drink or smoke at DeMolay functions.

The State Master Councilor explained the said I.S.C. Statutes, and explained that if a change is requested, DeMolays should speak their mind.

Merek Jones, Mid-Pinellas Chapter, stated that, in his opinion, the I.S.C. Statutes should be amended to include Advisors and Adult Workers.

Pat Patterson, Jupiter-Tequesta Chapter, stated that the careful selection process of Advisors should cut out heavy-drinkers, but that an occasional drink would not be out of line.

Joe Earnhardt, State Senior Councilor, requested a round number, or “guesstimate” in place of the statistics, requested by Bro. Cook.

Dad Marti, Executive Officer, summed up that since the problem has occurred in the past, no statistics or general numbers would be necessary for our discussion. He explained that such problems occur at almost every state DeMolay function, and that he and the Advisors had already discussed the problem.

Kurt Saltzgaver, Brandon Chapter, stated that he didn’t think that Advisors should be excluded where the rules are concerned.

Chris Cook, St. Petersburg Chapter, said that we should determine a form of deterrence, rather than a punishment, since a punishment has already been implemented.

Merek Jones, Mid-Pinellas Chapter, said that a zero tolerance policy would serve as a deterrent.

Chris Cook, St. Petersburg Chapter, explained that a zero tolerance policy would be stressing punishment, instead of deterrence.

Merek Jones, Mid-Pinellas Chapter, disagreed.

Dad Griffis, State Chapter Dad, stated that open drinking on the Advisor’s part should be stopped, but a question of privacy could arise when discussing what they do in their own rooms.

Matt Glymph, Winter Park Chapter, stated a point of inquiry: who would enforce the ban on drinking?

Dad Kicklighter, Chairman of the Board of Administration, answered that the State Conduct Committee would be in charge of it.

Chris Cook, St. Petersburg Chapter, moved to limit discussion to DeMolays and non-Masonic adults.

Jimmy Braddam, George Ulee Lord Chapter, seconded the motion.

The State Master Councilor called for discussion on the motion.

Merek Jones, Mid-Pinellas Chapter, asked for a clarification of the meaning of the motion.

Chris Cook, St. Petersburg Chapter, clarified that the discussion should be directed toward DeMolays only.

Joe Earnhardt, State Senior Councilor, asked what constitutes a “Masonic” adult, as stated in the original motion.

Dad Kicklighter, Chairman of the Board of Administration, recommended a restatement of the motion, limiting discussion to DeMolays only.

Joe Earnhardt, State Senior Councilor, objected because of the fact that we also have female guests and their chaperones at Conclave.

Chris Cook, St. Petersburg Chapter, re-stated the motion to limit the debate to anybody who is not an Adult Worker (i.e.: DeMolays, guests, and others, who are not Advisors).

Luke Melendez, Ralph Buck Chapter, felt that we should not accept the motion because our Advisors are part of the problem.

Matt Glymph, Winter Park Chapter, questioned whether we were discussing punishment or the problem itself.

The State Master Councilor summed up that we were still discussing both.

Glen Rager, Jupiter-Tequesta Chapter, asked why Senior DeMolays, who are over the age of 21, cannot have alcohol in their room, since the rules only apply to those under 21.

The State Master Councilor stated that the question was somewhat irrelevant to the motion on the floor.

Matt Glymph, Winter Park Chapter, moved the previous question.

Pat Patterson, Jupiter-Tequesta Chapter, seconded the motion.

The motion to limit debate to active DeMolays and guests who are not Advisors passed.

Merek Jones, Mid-Pinellas Chapter, put the zero tolerance policy up for discussion.

Jimmy Braddam, George Ulee Lord Chapter, stated that if Advisors are not responsible enough to drink in public, they should not be allowed to attend state functions.

Pat Patterson, Jupiter-Tequesta Chapter, stated that there already is a zero tolerance policy in existence.

The State Master Councilor said that the question under debate was how the rule was being interpreted, and that we may wish to change its interpretation.

Larry Bernard, Sarasota Chapter, asked how many knew about the zero tolerance rule, and what it stated. (All in delegation responded affirmatively).

Merek Jones, Mid-Pinellas Chapter, asked if we should use the zero tolerance rule, or should we just kick the guilty party out of the Order.

The State Master Councilor replied that it was currently under debate.

Jimmy Braddam, George Ulee Lord Chapter, called for a point of clarification on Bro. Jones' part.

Merek Jones, Mid-Pinellas Chapter, re-stated his question.

Jimmy Braddam, George Ulee Lord Chapter, explained to Bro. Jones that it is up to the State Conduct Committee to decide the punishment of guilty parties.

Pat Patterson, Jupiter-Tequesta Chapter, asked who had the authority to kick someone out of the Order, and argued that it is too harsh of a punishment for someone who may have made a mistake. (The State Master Councilor responded to Bro. Patterson's question by pointing to Dad Marti).

Chris Cook, St. Petersburg Chapter, offered an idea that other influential Advisors should explain the rules regarding alcohol at Conclave.

The State Master Councilor dictated the rules regarding the use and possession of controlled substances, including alcohol.

Kurt Saltzgeber, Brandon Chapter, offered his personal feeling, that people with alcohol should be kicked out of the Order, or at least suspended.

Luke Melendez, Ralph Buck Chapter, argued that people are human and are known to make mistakes.

Matt Glymph, Winter Park Chapter, called for a point of inquiry: what is the common procedure for someone who is caught with alcohol?

Dad Kicklighter, Chairman of the Board of Administration, explained that in the event of a DeMolay in possession of alcohol, the Conduct Committee would tell you to go home quietly, or could refer you to the Board of Administration, who would send you home, sending the matter to be handled at the DeMolay's home Chapter, who could then bring you up on DeMolay charges.

Chris Cook, St. Petersburg Chapter, made a motion to limit the discussion to methods of deterrence only.

Robert Gill, Albert J. Russell Chapter, seconded the motion.

The State Master Councilor called for discussion.

Joe Earnhardt, State Senior Councilor, declared that we need to discuss punishment, as a way of deterring the problem.

Luke Melendez, Ralph Buck Chapter, stated that we need to also discuss how the rules will be enforced.

Matt Glymph, Winter Park Chapter, called the previous question.

Chris Anderson, Paul Revere Chapter, seconded the motion.

The motion to call the previous question passed.

When the motion to limit this discussion to methods of deterrence only was voted upon, a division was called by the chair. The division reported a total of 15 yea's, 16 nay's, and 2 abstentions. The motion to limit debate failed.

Pat Patterson, Jupiter-Tequesta Chapter, provided examples of acceptable discussion topics and questioned our options as far as disciplining our Advisors.

Dad Meguiar, Member of the Board of Administration, asked if the DeMolays perceived a problem of open drinking on the part of the Advisors.

Since the majority of the responses to Dad Meguiar's question were negative, Joe Earnhardt, State Senior Councilor, asked if there was a current problem.

The State Master Councilor elaborated Bro. Earnhardt's question, and added the question: "What is the problem?"

Merek Jones, Mid-Pinellas Chapter, responded that there is a major problem with Advisors drinking in their own room while DeMolays are present.

Larry Bernard, Sarasota Chapter, stated that DeMolays perceive their Advisors as being drunkards, and that could take away from their level of respect.

Merek Jones, Mid-Pinellas Chapter, stated that a big problem is that it seems that the Advisors are condoning the use of alcohol at DeMolay functions.

Chris McKenney, Jupiter-Tequesta Chapter, argued that if an Advisor is drinking moderately, he is setting a good example to the younger DeMolays, because they are being responsible.

Dad Marti stated that he would be open to a statement of position of the use of alcohol by adults at State functions.

The State Master Councilor clarified Dad Marti's statement.

Dad Marti reminded the delegation that it was not a request; that he was only open for a statement of position.

Dad Kicklighter, Chairman of the Board of Administration, stated that the statement of position could be in the form of a resolution.

Matt Glymph, Winter Park Chapter, offered comments regarding such a statement.

Merek Jones, Mid-Pinellas Chapter, as a possible statement of position, moved to extend the interpretation of the rules, so that the Advisors were not allowed to consume alcohol in the presence of DeMolays.

Luke Melendez, Ralph Buck Chapter, seconded.

The State Master Councilor called for discussion.

Pat Patterson, Jupiter-Tequesta Chapter, stated that nobody has the right to say that an Advisor can't have a drink with his lunch, for example.

Matt Glymph, Winter Park Chapter, made a motion to amend the current motion on the floor to include the use of tobacco products.

Merek Jones, Mid-Pinellas Chapter, seconded the motion.

The State Master Councilor called for discussion regarding the motion to amend.

Jimmy Braddam, George Ulee Lord Chapter, offered his comments against the motion at hand.

Glen Rager, Jupiter-Tequesta Chapter, stated that Advisors should be able to do anything they want in the presence of DeMolays.

Larry Bernard, Sarasota Chapter, clarified that the statement being considered only states how we feel and does not necessarily mean that it will be made into a rule.

Dan Gorman, Jupiter-Tequesta Chapter, argued against the matter at hand, asking what the Advisors are supposed to do, "run and hide?"

John Reeder, Sem-I-No Chapter, stated that the Advisors should be allowed to smoke, but they should be have courtesy for those with breathing problems (i.e.: asthma).

Pat Patterson, Jupiter-Tequesta Chapter, agreed with Bro. Reeder, and added that there are a lot of good people who could have a lot to offer as Advisors, yet they smoke.

Chris Cook, St. Petersburg Chapter, moved to table the motion indefinitely.

Jimmy Braddam, George Ulee Lord Chapter, seconded the motion.

When voted upon, a division was called by Bro. Matt Glymph of Winter Park Chapter. The results of said division yielded 16 yea's and 16 nays, with 1 abstention. The State Master Councilor cast the deciding "nay" vote, which defeated the tabling of the motion.

Joe Earnhardt, State Senior Councilor, declared that the use of tobacco is bad, but it is not up to us to tell Advisors what they can or cannot do, as it should be a matter of respect.

Chris McKenney, Jupiter-Tequesta Chapter, called the previous question (to include / exclude the use of tobacco).

Pat Patterson, Jupiter-Tequesta Chapter, seconded the motion.

The motion to call the question passed.

The delegation voted on the question as to include the use of tobacco by the Advisors, and the motion failed.

Chris Cook, St. Petersburg Chapter, proposed an idea that we could designate a "smoking section" of the hotel for the Advisors.

The State Master Councilor stated that the resolution states that the Advisors can do whatever they want, as long as they don't do it in the presence of DeMolays, so the idea presented by Bro. Cook wouldn't be needed.

Larry Bernard, Sarasota Chapter, said that a “smoking section” would not be necessary, and that out of respect for Advisors, we shouldn’t need one to begin with.

Chris McKenney, Jupiter-Tequesta Chapter, called the previous question.

Matt Glymph, Winter Park Chapter, seconded.

The motion to call the previous question passed.

The motion to include the Advisors in the interpretation of the standing Florida State DeMolay Association Conclave Rules, regarding the use of alcohol failed unanimously.

Chris Cook, St. Petersburg Chapter, moved to adjourn.

The State Master Councilor declared Bro. Cook’s motion illegal.

Matt Glymph, Winter Park Chapter, moved to recess.

Glen Rager, Jupiter-Tequesta Chapter, seconded the motion.

When voted upon, a division was called by Bro. Jerry Tillman, State Parliamentarian. The results of said division yielded 29 yea’s, 4 nay’s, and 1 abstention.

The Florida DeMolay Association was placed into a state of recess at 3:10 PM.

The Florida DeMolay Association was brought out of recess at 8:15 PM on Wednesday July 30, 1997, with Mark Griffiths, State Master Councilor, presiding.

The Credentials Committee reported a total of 60 delegate votes present, constituting 31 to be the simple majority, and 40 to be 2/3 majority.

Dad Bill Marti, Executive Officer, was given the gavel and the chair, and since there was no competition, he appointed Bro. Joseph C. Earnhardt, Jr. as the State Master Councilor of the Florida DeMolay Association for the 1997-1998 year. Bro. Earnhardt accepted the appointment.

The floor was opened for the election of the State Senior Councilor. The Candidates were Bros. Christopher John Cook Cleveland Mitchell Fowler.

The results of the election were as follows:

The Chair declared Bro. Chris Cook to be the winner of the election. Bro. Cook accepted the results of the election.

The Chair opened the floor for the election of the State Junior Councilor. The candidates were Bros. Robert “BJ” Ware, Jr., Jerry L. Tillman, Jr., and Cleveland Fowler.

The Credentials Committee reported a total of 45 delegate votes present, leaving 23 votes to be the simple majority, and 30 to be 2/3 majority.

The Chair recognized Bro. Merek Jones to read the State Budget and Finance Committee report. Bro. Jones could not present his report, since it had not already received the approval of the Board of Administration.

The Chair recognized Bro. Joe Earnhardt to read the State Public Relations and Publications Committee report. The report read as follows:

have met and submit the following report for your approval.

Two members of the State Knighthood Committee, Zack Enos and Jerry Tillman, met at both the Grand Master's Class in February and the Festival of Spring in April and discussed ideas for the upcoming events. At the annual Convocation in June, Sir Knight Braddam was also in attendance along with Sir Knight Enos and Tillman for discussion of ideas. Sir Squire Bartlett was also in attendance with the above listed at this year's annual Conclave.

Col. James "Nick" Rowe Priory has gone through many positive changes in the past 12 months. At last year's annual Knighthood Cotillion in October, the Sir Knights, Advisors, and guests assembled were treated to an exciting night of food, medieval dancing courtesy of the SCA, and awards presentations. For the first time in its existence, all three trophies presented went to the same individual, Sir Knight Joe Earnhardt. The trophies presented are the Jean Kicklighter Memorial Trophy for outstanding performance of the Knight of Rose Degree, the George Chipouras

Trophy for outstanding ritual work, and the Joseph Aspley Trophy for the Outstanding Sir Knight of the year. Dad Jack Peterson was also presented with the Knighthood Grand Cross of Honor for his outstanding help with Florida Knighthood. The Knighthood Cotillion is truly the highlight of all Knighthood functions that occur every year.

At the annual Grand Master's Class in Jacksonville this past spring, it was both a joyous and exciting weekend with DeMolays and Knights from other states able to experience brotherhood at its best. While everyone who attended enjoyed the athletic and ritual events, once again the Grand Master's Cup was taken away from the State of Florida courtesy of South Carolina DeMolay. The Grand Master's Class is always an enjoyable time and full of both DeMolay and Knighthood activities.

A new event was added to the Knighthood calendar this year. The first annual Knighthood Festival of Spring was a great success and was enjoyed by all in attendance. The festival included outdoor medieval games, a camp-out, and a joyous, utensil-free feast. With the exception of a few scorpions and a raging bonfire, the camp-out and 1st Lady Coronation were a real twist to the already exciting weekend. Mom Diana "Rambo" Reeder was also crowned First Lady of the State Priory in front of a campfire ceremony. Changes are already being made in preparation for next year's Festival which guarantees to be even more exciting than the first one. Of the changes being made, some are different athletic events based on either physical strength or balance and skill and possibly a dance following the Coronation ceremony. Whether a Sir Knight, Squire, or DeMolay, if attended, the Festival of Spring will add new meaning to the term brotherhood.

Convocation this year proved to be just as important to Knighthood as in years past with the business meeting proving once again useful. We made a lot of changes this past year including changing the date of the Priory Princess and Illustrious Knight Commander elections to the Festival of Spring in order for a better turn out and more state wide voting. We also inducted 6 DeMolays into Knighthood who then became Sir Squires eager to help out in their local encampments. Miss Shanna Bunch was elected the new Priory Princess as well as myself, Zack H. Enos, being elected the new Illustrious Knight Commander of Col. James "Nick" Rowe Priory. Once all the business meetings and official business were taken care of, the Knights and guests assembled enjoyed a fun night of comradeship. We are considering possibly inviting DeMolays to Convocation next year in order to introduce them to Knighthood and how it works.

As for the future of the Priory, we are already implementing new ideas for next year's Festival of Spring as mentioned above. We are considering having individual Fall Festivals, one for each encampment, each weekend in November. They will be small in size, but we will be inviting chapters from across the state. The purpose of these Fall Festivals are to introduce Knighthood and gain attendance in the local Knighthood encampments. We are also hoping to revitalize the St. John's Encampment in Jacksonville during the next year.

The purpose of Knighthood is to help the Order of DeMolay and that is what we try to do on a daily basis. Since Knighthood only has four state wide functions each year, it becomes difficult to publicly show how Knighthood helps DeMolay with

most of the help coming from the local encampments or groups of Sir Knights. These are some of the events that the State Priory is doing in order to help the Order of DeMolay:

1. Knighthood is still in charge of the John Bates University, but we do not run the actual classes.
2. Rose Croix Encampment played a major role in the Installation and building of the newly formed Crawfordville DeMolay Chapter located south of Tallahassee by participating in the Installation service and offering help whenever requested.
3. Jean Kicklighter Encampment help get a D.A.D.'s course up to Floral City, when no one seemed interested in doing so, in order to better prepare to form a chapter in that area in the near future.

These are just a few recent examples of how Knighthood had helped the Order of DeMolay in the past few months. The Order of Knighthood demands the highest respect of a DeMolay and must show an active participation in at least 75% of their chapter's DeMolay meetings, be at least 16 years of age, and be a member in good standing in your home chapter. 9. The next State Master Councilor develop an incentive program for the chapter that donates the most money to the State Service Project.

Chuck Giallombardo of Sarasota Chapter and Bro. Luke Melendez of Ralph Buck Chapter. The recommendation was then referred to the Jurisprudence Committee for review and consideration for next year's Constitutional Revisions Committee.

The Chair recognized Bro. Zack Enos of George Ulee Lord Chapter, who recommended that State Statute 5.10 be amended to include ". . . and how the Order of Knighthood has assisted the Order of DeMolay on both the State and Chapter levels in the past 12 months" to finally read as follows:

BUDGET & FINANCE COMMITTEE REPORT

To the Delegates of the sixty-fourth Annual Conclave:

This is the report of the Budget and Finance Committee as set forth by Section 5.11 of the Florida DeMolay Statutes.

This committee met a total of seven times. On August 14, 1996 we met and discussed what this committee and its members will be required to do until next Conclave.

On August 25, 1996 we met and discussed the possibility of writing a Fundraising Book which will enable the individual Chapters to have a list of potential fundraising ideas that worked for other Chapters and ways of implementing these ideas in their own Chapter and Area.

On September 22, 1996, all suggested fundraising projects made by the members of this committee were collected, discussed and asked to be put in rough draft form by the next meeting.

On October 27, 1996 the rough draft was revised into a final copy. However, the committee felt that the current Fundraising Book was not up to the committee's expectations as to the current size and amount of ideas in the Book. The committee then sent out a letter across the state asking for Fundraising ideas that were implemented in the individual Chapters and Areas. No written response was given to the 63 letters sent out across the State.

On December 15, 1996 the committee decided to send out additional letters across the State once again in an effort to have the Fundraising Book completed for presentation and publication at the upcoming Conclave subject to the approval of the Board of Administration at Mini-Conclave. There was no response to the second set of letters either.

On January 15, 1997 the committee concluded that due to the lack of participation given to this committee from the Chapters, Areas, and other State individuals both advisory and DeMolay alike the Fundraising Book will not be able to be implemented this year.

On July 26, 1997 this committee met to discuss the Florida State Budget. As of July 26, 1997 no committees have reported to this committee any fiscal impact they might have pursuant to Section 5.01 of the Florida DeMolay State Statutes.

No recommendations were made last year to be carried out by this committee.

We the members of the State Guidance Committee having met at the Scottish Rite Temple, Valley of Tampa, in Tampa, Florida on April 13, 1997, at Northside Masonic Lodge, in St. Petersburg, Florida on May 21, 1997 and again on June 30, 1997, submit the following report for your approval.

Whereas the purpose of the Guidance Committee for the Florida DeMolay Association is to monitor the performance of State Officers and make proposals for the improvement of the Order of DeMolay.

Whereas, the Elected State Junior Councilor, Brother Jon James, resigned from the office to enter the United States Service. He was replaced by appointment of the State Master Councilor, with the approval of the Executive Officer of the Florida State DeMolay Association with Brother Joseph C. Earnhardt, on the 25th day of December, 1996.

Whereas the elected State Senior Councilor, Brother Andrew Jones, resigned from office to move out of the State with his family. He was replaced by the State Junior Councilor, Brother Joseph Earnhardt. Thereby creating a vacancy in the position of State Junior Councilor. This position was filled by appointment of the State Master Councilor by Brother Jason S. Webb, with the approval of the Executive Officer of the Florida State DeMolay Association, on March 1, 1997.

Whereas the following appointed officers were unable or unwilling to perform their offices to the satisfaction of the State Master Councilor, or through promotion or election to a different office, they are hereby listed along with their replacements. Whereas the State Guidance Committee, as part of it's duty, is to make suggestions for possible improvements to aid in the growth of DeMolay in the State of Florida. The following proposals are submitted for the consideration of the Board of Administration and Delegation.

As there was no State Guidance Committee last year, there are no suggestions from last year to report on.

In order for the Order to grow it requires public recognition; it is the understanding of this committee that a special fund organized through the DeMolay Alumni Association was set up strictly for the purpose of promoting the Order. Films which could be made available to local educational and public access channels promoting the Order of DeMolay should be made available to all Chapters for local distribution. The costs for these films, as is the understanding of this Committee should be covered by the Alumni Association. If the Alumni Association cannot be encouraged to produce these films, the International Supreme Council's Education Committee should be encouraged to pursue this project.

The individual Chapters should be encouraged to create their own Chapter Brochures, including the activities that are unique to their own areas. When prospective members can actually meet the DeMolays included in the brochure it becomes more accessible to them personally. Prospects in Utah cannot relate to a Beach Party in Florida. Funding for the individual Chapter brochures could be procured through Lodges, the Scottish Rite, the York Rite, the Shrines, fundraisers or advertisements in the brochures.

High profile events should be encouraged, along the lines of floats in local parades, teen dances that could include local Church groups and other Youth organizations that encourage high morals should be invited. Every local or State event with press coverage should have DeMolays in identifiable apparel, as long as the event has a positive connotation. For financing the dances, there should be a charge for admission large enough to cover all expenses and possibly make a profit for the Chapter.

DeMolay Week activities definitely need to be fully organized and all local news organizations should be provided with a copy in advance and followed up with additional letters and phone calls.

Obligatory Day observances should be moved from the Chapter level into a more highly visible forum. Again stressing press coverage.

To be a good DeMolay, you do not have to be born into an affluent family. Sponsor's Clubs can easily be set up for each Chapter. These Sponsor's Clubs provide a means for Master Masons which do not have the time to serve on an Advisory Council to sponsor a deserving young man into our Order who's family cannot afford our fees. This program not only helps in membership but provides these Master Masons with a DeMolay career they can follow with pride.

The DeNews should have a section on new ideas to be shared with all Chapters in the State. This section could include ideas on Fundraising, membership, Masonic Service, Civic service, and any other ideas helpful to all Chapters. We also suggest the sale of advertisements on a yearly basis to cover the costs of printing and distributing.

A Pledge program, such as the old Knights of Chivalry or the current program, "The Squires of the Round Table," currently being tested in Washington, should be pursued for the Florida DeMolay Association. The younger our precepts are taught the stronger the DeMolays of the future will be. Any pledge program to be

set up in the State of Florida should be organized in the same manner as a new DeMolay Chapter with the initial costs incurred by the sponsoring Masonic Body. A Past Master Councilor's forum for each area should be considered. The knowledge of our Past Master Councilors is remaining in the individual Chapters unless they choose to serve at the State level. Knowledge not shared is knowledge lost.

An area Masonic Youth Council to be headed by the Masonic Youth Committeeman in each Area or Areas for the purpose for the exchange of ideas and promoting the growth of DeMolay, Rainbow, and Job's Daughters, and the exchange of important dates for upcoming events.

We also suggest the designing of a Masonic supported Youth Brochure, to include DeMolay, Rainbow, and Job's Daughters. This to be handed out with all Masonic petitions. Funding for this project should be sought through the Most Worshipful Grand Lodge of Florida.

These are the suggestions of the State Guidance Committee.

Appendix B
Reference Material

Charter of The Florida DeMolay Association

The several Chapters of the Order of DeMolay in Florida are hereby granted authority to form an organization to be styled "The Florida DeMolay Association". This Association shall exist to further the programs and ideals of the Order of DeMolay, to promote the progress and well-being of the Chapters and their Members, and to provide a medium for education and communication throughout the Order in Florida provided , that this Association shall have no authority over the particular chapters within this jurisdiction; provided further, that this Association shall have the authority to exercise jurisdiction over the State Master Councilor's Representatives and other such officers as now exist, or may in the future be created, by the Executive Officer.

To accomplish these goals , the Florida DeMolay Association shall be authorized to exact such Constitution , Statutes, and resolutions as shall not be in conflict with the policies or orders of the Executive Officer, and shall have been approved in advance by the Board of Administration.

The "Board of Administration" is hereby created to serve the Florida DeMolay Association, its officers and members, in a general advisory capacity. It shall review and approve all legislation to come before the Association, shall have original jurisdiction over any proposition or grievance arising out of the activities of the Florida DeMolay Association. It shall have the authority to construe or dispense with any provision of the Constitution, Statutes, or rules of competition, when it deems such action to be in the best interest of the Order of DeMolay or this Association, and shall perform other such duties as may be enjoined upon it by the Executive Officer, and it shall serve at his Pleasure.

Constitution of The Florida DeMolay Association

Article I

Name, Purpose , Colors

Section 1: This organization shall be known as the Florida DeMolay Association, Order of DeMolay (hereinafter , Association).

Section 2: The purposes for which this organization are formed are exclusively educational, religious, and charitable. Not by way of limitation, such purposes shall encompass guidance of DeMolays in their physical, mental, and religious development through specific programs in the fields of physical education, sportsmanship, citizenship, public speaking and the arts, all designed to promote a keen sense of the principles of good citizenship, sportsmanship, of respect for parents and fellowman, and to establish and instill a philosophy of life that will sustain the members of each chapter in the future.

Section 3: The official colors of this Association shall be the royal colors of Purple and Gold.

Article II

Allegiance and Authority

Section 1: The Association, it's officers, advisors, and the individuals of member chapters of this Association pledge their allegiance to the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary and the Executive Officer in the State of Florida.

Section 2: This body is constituted with the power and authority to set forth standards in the inter-chapter relations; and to levy fees and dues, provided that these measures are in harmony with the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary and the Executive Officer in the State of Florida.

Article III

Members

Section 1: The members of this Association shall be all the Chartered Chapters, and those holding Letters Temporary of the Order of DeMolay located in the State of Florida.

Section 2: The members of this Association shall meet annually for the purposes of conducting business, electing officers, holding sports and ritual competition and other activities provided for in the statutes of this Association.

Section 3: In order for the delegation of a member chapter to attend and register, the said delegation must be accompanied by a certified member of the Advisory Council or a Master Mason, approved by the Zone Director for each ten DeMolays or fraction thereof in attendance. No Chapter shall be allowed to register its delegation if said chapter has not paid in full all assessments due this Association.

Section 4: Each member Chapter shall be entitled to be represented by three (3) delegates at the Annual Conclave. This Association shall provide by Statute the manner of voting at delegate sessions.

Article IV

Officers

Section 1: The officers of this Association shall consist of the State Master Councilor, State Senior Councilor, State Junior Councilor, State Parliamentarian, State Scribe/ Treasurer , State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Chaplain, State Marshall, State Orator, State Standard Bearer, Seven State Preceptors, State Committee Chairman, and all others selected by the State Master Councilor and/or Executive Officer of the State of Florida.

Section 2: The State Master Councilor, State Senior Councilor, and State Junior Councilor shall be elected during the general business session of this Association at Conclave assembled each year, and these officers shall serve until their successors are installed.

Section 3(a): The State Scribe/Treasurer shall be appointed by the Board of Administration from a list of two or more nominations submitted to it by the State Master Councilor. The State Scribe/Treasurer shall be appointed at the Annual Mini-Conclave of this Association, or as provided by Article IV Section 5 (c). He shall not be eligible to run for elected office for a period of one year after his appointment. All nominees for the Office of State Scribe/Treasurer must be a Past Master Councilor, have completed the Leadership Correspondence Course, and be a Representative DeMolay. All candidates for State Scribe/Treasurer must have a personal savings and/or checking account.

Section 3(b): The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration. The State Scribe/Treasurer shall obtain three (3) or more bids for the cost of printing the Conclave proceedings before the registration of said Conclave.

Section 4: All other State Officers shall be filled by appointment of the State Master Councilor. These officers shall serve until the close of the following Conclave.

Section 5(a): No candidate shall be elected to a State Office who would reach the age of 21 years prior to June 1 of the year following his election. No State Officer

may attend an out-of- state school or reside outside the State of Florida during his term of office. Any violation of these provisions shall automatically create a vacancy in the office.

Section 5(b): A vacancy in an appointed State Office may be declared by the State Master Councilor after evaluation of that State Officer's performance.

Section 5(c): A vacancy in an elective State Office may be declared by the State Master Councilor after evaluation of the of the State Officer's performance and with the approval of the Executive Officer. A vacancy will also occur in the State Scribe/ Treasurer upon the recommendation and approval of the State Master Councilor to the Board of the Administration.

Section 6(a): In the event of death, resignation or removal of a State Councilor, each lower State Councilor shall advance to the next highest office and a State Junior Councilor shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer.

Section 6(b): In the event of death , resignation or removal of the State Scribe/ Treasurer , a new State Scribe/ Treasurer shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer.

Section 6(c): Vacancies in all other State Offices shall be filled by appointment of the State Master Councilor.

Section 7(a): A Candidate's Letter of Intent to run for elective State Office must include the following statement:" I have read and am familiar with the Charter, Constitution, and Statutes of this Association."

Section 7(b): All candidates for the office of State Parliamentarian must include the following statement:" I have read and am familiar with ROBERT'S RULES OF ORDER".

Article V

Committees

Section 1: The following committees shall be considered as standing committees of this Association:

Article VI

Amendments

Section 1: The procedure for amending this Constitution is as follows:

(a) It shall be the responsibility of any Florida DeMolay proposing an amendment to this Constitution to provide for the distribution of said proposal to the Constitutional Revisions Committee, Jurisprudence Committee, Elective State Officers, Executive Officer, Board of Administration, and member Chapters of this Association not less than sixty days prior to the opening session of Conclave.

(b) The proposed amendment, after the approval of the Jurisprudence Committee and the Board of Administration, shall be presented for consideration on the floor of Conclave. Upon the approval of two-thirds (2/3) of the delegates present and voting, it shall take effect upon the close of the Annual Conclave.

Statutes of the Florida DeMolay Association

Chapter 1

Section 1.01:

Each chapter shall pay as dues the sum of fifteen (\$15.00) dollars for each initiate to the Florida State DeMolay Association, Inc., and shall be payable with the Form 10 reporting the initiation.

Section 1.02:

The revenue derived from the initiation fee in Section 1.01 shall be distributed as follows; 33 1/3 % to the General Account, 33 1/3 % Savings Account, 33 1/3 % as provided in Chapter 4 , Section 4.04.

Chapter 2

State Conclave

Section 2.01:

There shall be Ritual Competition, Athletic Competition, State Sweetheart Competition, Election Of State Officers and any other business for the Good of the Order of this Association.

Section 2.02:

There shall be Ritual Competition conducted under the direction of the Executive Officer's Personal Representative for Ritual, assisted by the Chairman of the State Ritual Committee. This competition shall be governed by the rules and regulations of the Old South Tournament.

Section 2.03:

There shall be Athletic Competition conducted under the direction of the State Director of Athletics assisted by the State Athletics Committee. The State Director of Athletics appointed by the Executive Officer, shall appoint for each competition referees for each event who shall use the playing rules established by the Florida State High School Athletics Association.

Section 2.04:

There shall be State Sweetheart Competition. The rules and regulations as determined by the Executive Officer shall be published in the proceedings of the year's Conclave.

Section 2.05:

For the purpose of participation in the activities and/or competitions sanctioned by this Association, any person who has not yet reached the age of 21 years before the opening of Conclave shall be entitled to participate as an active DeMolay, and at any

subsequent level of competition; provided that they have not been certified as an Advisor.

Section 2.06:

There shall a Mini-Conclave, to be held annually in or about the month of January at a specific time and place to be determined by the Executive Officer and State Master Councilor.

The Mini- Conclave shall consist of:

- Such meetings of the State Officers as are deemed necessary by the State Master Councilor.
- All State Committees shall be required to meet and report to the State Master Councilor.
- Any other Ritual and/or Athletic Competitions social activities which are deemed necessary and appropriate.
- The Installation of the State Scribe/Treasurer.

Section 2.07

Any Active DeMolay, Senior DeMolay, Advisor, or Master Mason, may attend any business session of this Association, unless their presence is prohibited as provided for in the Statutes of the International Supreme Council. (1995)

Chapter 3

Elections

Section 3.01:

Any qualified DeMolay who desires to run for an Elective Office of this Association shall send a Letter of Intent to the Executive Officer, the State Master Councilor and the Chairman of the Nominating Committee prior to midnight of the first day of Conclave, with the exception of candidates for the office of State Master Councilor, who shall submit their letters by the deadline for Conclave registration. The Letter Of Intent will be read aloud before the DeMolay Delegation by the Nominations Chairman prior to elections. (1995)

Section 3.02(a):

All candidates must be residents of the State of Florida for at least six months prior to the election and shall be members in good standing of a member Chapter of this Association. All candidates for elective State Office must possess at the time of filing for their Letter of Intent, proof being a Representative DeMolay, Past Master Councilor and having completed three of the five parts of the Leadership Correspondence Course, copies of such proof shall accompany said letter. (1995)

Section 3.02(b)

The candidates for an elected State Office shall show, to the approval of a Ritual Evaluator, or a panel of Evaluators, designated by the Director of Ritual, his proficiency in the Opening and Closing Ceremonies in the Ritual of Secret Work for

his sought Office. The criteria for the approval of said evaluation shall be determined by the Director of Ritual for the State of Florida. The approval shall be granted no earlier than the Mini-Conclave prior to his candidacy. (1996)

Section 3.03:

All candidates for the Office of State Master Councilor must be a high school graduate or its equivalent and have been a member of this organization for at least two (2) years. (1995)

Section 3.04:

A candidate shall not cause any distribution of materials written or oral pertaining to his candidacy before he has submitted his Letter of Intent to the proper persons (as stated in Chapter 3, Section 3.01). The date of submission shall be determined by the Letter of Intent's postmark. He will be authorized to distribute calling cards only. This card will be no larger than the standard Life Membership Card in overall size, and will contain no information other than the name, address, phone number , emblem of the Order of DeMolay, title and / or honors, and the title of the office being sought by the candidate. This card will be the only authorized material which may distributed in his behalf at Conclave or at anytime.

Section 3.05:

The election of Officers of this Association shall take place at the discretion of the State Master Councilor during a regular business session at each Annual State Conclave.

Section 3.06:

The election of Officers shall be in order of rank, the highest being first, the order as provided by this Constitution , by secret ballot of those entitled to vote, as otherwise provided in the Constitution , at each Annual Conclave of this Association. A majority of the ballots cast shall be necessary for a candidate to be elected.

Section 3.07:

Any qualified candidate who is not elected to the office for which he has submitted a Letter of Intent, may be nominated for a lower office from the floor during elections. (1995)

Section 3.08:

The ballots for the election of Officers shall be prepared by the State Scribe/Treasurer for each Annual Conclave. Prior to the opening of elections, the ballots shall be distributed to each delegate entitled to vote. Ballots shall be cast with the full name of the candidate for the particular office legibly written thereon and shall be folded only once. Blank ballots, ineligible ballots, and those otherwise deviating from the proper form provided herine shall be tabulated as abstentions.

Section 3.09(a):

Each member Chapter shall be entitled to be represented by three delegates at the Annual Conclave. Each delegate shall have one vote in all matters brought on the floor of the Conclave, providing he has been certified by his Chapter Advisor and has been registered with the Credentials Committee prior to the Opening Session of Conclave. In the event that less than three (3) delegates from a Chapter are in attendance at Conclave, any or all of the absent delegate votes may be given to a remaining Delegate from that Chapter. In order to accomplish this, the Chapter Advisor must submit written authorization to the Credentials Committee before the opening business section of Conclave.

Section 3.09(b):

All of a Chapter's delegates must be members of said Chapter.

Section 3.10(a):

Every Past State Master Councilor who has not reached the age of twenty-one (21) years and is properly registered will be entitled to one (1) delegate vote on all matters at the Annual Conclave.

Section 3.10(b):

The State Senior Councilor, the State Junior Councilor, and the State Scribe/Treasurer will be entitled to one (1) delegate vote on all matters at the Annual Conclave.

Section 3.11:

Each Chapter Delegation shall elect a Delegation Chairman during the business sessions, the vote of the delegation shall be announced by the Chairman of the delegation with the exception of secret ballot for State Officer Elections.

Chapter 4

Duties of State Officers

Section 4.01:

The State Master Councilor shall be the duly elected head of this Association, and it shall be his duty to perform all duties which naturally pertain to such an office or which may devolve upon him from time to time.

Section 4.02:

The State Master Councilor shall preside at the Annual Conclave.

Section 4.03(a):

The State Master Councilor shall appoint all committee chairmen of this association, and in consultation with each chairman, appoint the committee members.

Section 4.03(b):

When a vacancy in any committee chairmanship occurs, an interim chairman shall be elected by the remaining members of the committee to serve until such a time as a new chairman is appointed by the State Master Councilor.

Section 4.04:

The State Master Councilor shall have an expense account equal to 33 1/3 % of the amount collected for each initiate reported to the Florida State DeMolay Association Inc, on Form 10's which shall be used for reasonable expenses incurred in the performance of his and other State Officers's duties, with the State Master Councilor's approval.

Section 4.05:

An Elected State Officer shall in person, visit each Chapter in this state, at least once during his term of office. (1996)

Section 4.06:

The State Master Councilor shall report in writing to the Association at each Annual Conclave, all of his official acts, whether performed in person or by Personal Representative.

Section 4.07:

The State Senior Councilor, State Junior Councilor, and the State Scribe/Treasurer shall represent the State Master Councilor when so ordered, assist the State Master Councilor in every way possible in the discharge of his duties, and shall report to this association at each Annual Conclave, all of their official acts.

Section 4.08:

The State Scribe/Treasurer's records shall be subject to an audit conducted by the Executive Officer.

Section 4.09(a):

The State Scribe/Treasurer shall record the minutes of the Annual Conclave of this Association and any official State meeting. He shall then within sixty (60) days have the aforesaid minutes, together with the Constitution and Statutes of their latest revision, published with the rules of the Sweepstakes Competition, and distributed as follows:

- One copy to each member Chapter of this Association.
- Copies to the Executive Officer, one copy to each member of the Supreme Council residing in the state, and one copy to any advisor appointed by the Executive Officer in a supervisory capacity, including the Board of Administration.
- One copy to the State Master Councilor, State Senior Councilor, State Junior Councilor, and the State Parliamentarian.
- One copy to the International Supreme Council.

- One copy to of the State Committee Chairmen.
- One copy to each Jurisdiction in Region 3 of the International Supreme Council, sent to the Executive Officer.

Section 4.09(b):

The State Scribe/Treasurer with the approval of the State Scribe/Treasurer Advisor, shall have the authority to correct any grammatical and typographical errors as he deems necessary and appropriate.

Section 4.09(c):

The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration. The State Scribe/Treasurer shall obtain three (3) or more bids for the cost of printing the Conclave Proceedings before the Registration of said Conclave.

Section 4.10:

The State Scribe/Treasurer shall, under the direction of the State Master Councilor, and/or the Association conduct all correspondence of this Association.

Section 4.11

The State Scribe/Treasurer shall keep and maintain a true copy of the Constitution and Statutes of the Florida DeMolay Association. He shall also supply a copy for the Board of Administration, and one for the Executive Officer of Florida.

Section 4.12:

The State Scribe/Treasurer shall make disbursement for this Association with the approval of the Executive Officer. The State Scribe/Treasurer shall make an itemized report of all transactions in connection with this office at the Annual Conclave.

Chapter 5

Committees

Section 5.01:

All committees shall be responsible for reporting on the fiscal and physical feasibility of their proposals.

Section 5.02:

The duties of the Jurisprudence Committee shall be to determine the constitutionality of all motions, resolutions, and proposals presented by the standing committees or from the floor of Conclave. The State Parliamentarian shall act as Chairman of the Jurisprudence Committee.

Section 5.03:

The duties of the Nominations Committee shall be to receive and review letters of intent filed by person(s) seeking qualification as (a) candidate(s) for Elective State

Office; upon completion of the review the Chairman shall notify the prospective candidate of approval or shall notify him of deficiencies therein; such review and notification shall be completed within twenty (20) days after receipt of the letter by the Chairman; a candidate may submit an amended Letter of Intent which shall also be reviewed as specified herein above.

Section 5.04:

The Membership Committee shall study and promote an active program for the acquisition of eligible youth in this Jurisdiction.

Section 5.05:

The duties of the Credentials Committee shall be to validate the credentials of all Delegates to Conclave in accordance with Chapter 3, Sections 3.11 and 3.12 of the Statutes. This committee shall be responsible for arranging the seating of said delegates.

Section 5.06:

The duty of the Public Relations and Publications Committee shall be to promote the image of DeMolay before the general public. It shall also be the duty of this committee to inform and assist member Chapters in the Annual DeMolay Week program. This committee shall oversee any publication of this Association and any related programs.

Section 5.07:

The State Ritual Committee shall promote uniformity in the ritual of the Order of DeMolay throughout this Association, and shall recommend to the Association for approval procedures for the performance of ritualistic matters not set forth specifically in the Ritual of Secret Work of the Order of DeMolay and methods of receiving introducing and accommodating those who are entitled to recognition in all Conclaves, meetings, and public ceremonies of the Association. It shall also develop, review, and revise any State ceremonies which may be used by this Association.

Section 5.08:

The Athletics Committee shall work with the State Sports Director in acquiring qualified, unbiased judging officials for all State Athletics Competitions. They are also to make certain that no Advisors shall judge their own Chapters. They shall also review and submit any proposals to the State Master Councilor.

Section 5.09:

The duty of the Constitutional Revisions Committee shall be to recommend pertinent and necessary revisions to the Constitution and Statutes.

Section 5.10:

The Knighthood Committee shall report to the Delegates on the activities of the State Priory.

Section 5.11:

The Budget and Finance Committee shall review the financial status of this Association and report the same to the Delegates of the Annual Conclave. Any proposals, including committee recommendations, containing fiscal impact shall be submitted to this committee for its review and recommendation. It shall also be the committee's responsibility to put together the Conclave Program and such advertisements necessary for its production. This committee shall also present a proposed comprehensive budget for this Association to the delegates and, upon approval, present the proposed budget for this Association to the Executive Officer. The expenditures of this Association shall not exceed its income from Conclave to Conclave.

Section 5.12:

The Guidance Committee shall be the duly appointed State Master Councilor's Representatives of the of the several Areas and the State Appointed Line Officers and Committee Chairman. This Committee will function at the will of the State Master Councilor. It shall act in an advisory capacity to relay to the State Master Councilor the suggested needs of the individual zones and the State as a whole.

Section 5.13:

The Executive Committee shall be composed of the Elected State Officers, State Scribe / Treasurer, and all Past State Master Councilors who have not reached their majority. It shall be chaired by the State Master Councilor, and shall meet at his discretion. In addition to other duties deemed appropriate by the State Master Councilor, it shall be this committee's duty to work with the Conclave Director in planning and executing all miscellaneous activities at Conclave. (1995)

Section 5.14:

The State Master Councilor shall announce the names of the appointed Committee Chairman, Appointed State Officers, and State Master Councilor's Representatives at the last business session of the State Conclave. The names of the Chairmen shall be published, with the exception of the State Credentials Committee Chairman, in the current proceedings of this Association.

Section 5.15:

The State Master Councilor shall have the authority to appoint one advisor to each committee with the consultation of the Committee Chairman and the Director, if one has been appointed.

Section 5.16:

It shall be the duty of each committee to submit to the State Master Councilor a report upon request. It shall also be the duty of each State Committee Chairman to gather suggestions and recommendations from the member Chapters and combine them with his own ideas and submit them to the State Master Councilor as a tentative agenda thirty (30) days prior to Conclave.

Section 5.17:

The final committee reports shall be typewritten and submitted to the State Scribe/Treasurer no later than the beginning of the last business session at each Conclave.

Section 5.18:

The final report from each state committee must be read and passed by a simple majority vote of the Delegates prior to the close of Conclave.

Section 5.19:

The State Master Councilor shall have the power to establish and abolish additional committees (with the exception of standing committees) as deemed necessary.

Section 5.20:

Each individual state committee shall be responsible for implementing the recommendations made by that committee and approved by the delegates, at the most recently conducted Conclave. The Executive Committee shall oversee and coordinate this implementation.

Section 5.21:

All committees shall physically meet at least three (3) times a year prior to the opening session of Conclave and submit minutes of these meetings to the State Master Councilor at the Annual Conclave, (with the exception of the Executive Committee).

Chapter 6

State Master Councilor's Representatives

Section 6.01:

It will be the duty of each State Master Councilor's Representative to promote Florida DeMolay and its communications to the members of this Association.

Section 6.02:

It will be the duty of each State Master Councilor's Representative to provide monthly reports to the State Master Councilor, Guidance Committee Chairman, and State Officer in charge of his area, concerning the progress, activities, and the needs of his chapter and area.

Section 6.03:

State Master Councilor's Representatives will be required to attend all meetings of the Guidance Committee of this Association.

Section 6.04:

State Master Councilor's Representatives shall act as personal representatives of the State Master Councilor, to serve on his behalf when no other ranking State Officer is present.

Section 6.05:

Each Area will have one (1) State Master Councilor's Representative for every three Chapters or fraction thereof. State Master Councilor's Representatives shall be appointed by the State Master Councilor to serve at his will.

Section 6.06:

State Master Councilor's Representatives shall be obligated to attend both Mini-Conclave and Conclave.

Section 6.07:

All State Master Councilor's Representative shall be required to begin working on their L.C.C. and R.D. within 30 days of their appointment, if they have not previously been completed. Proof of completion must be furnished by his Chapter Advisor.

Chapter 7

State Appointed Officers

Section 7.01:

State Appointed Officers shall include; the State Parliamentarian, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Orator, State Sentinel, State Chaplain, State Marshall, State Standard Bearer, State Almoner, and the State Seven Preceptors.

Section 7.02:

It shall the duty of each State Appointed Officer to promote the Florida DeMolay Association and its communications to the members of this Association.

Section 7.03:

It shall be said Officers duty to provide monthly reports to the State Master Councilor concerning the progress , activities and needs of their Chapter and Zone.

Section 7.04:

State Officers will be required to attend all meetings of the Public Relations and Publications Committee.

Section 7.05:

State Officers shall act as a Personal Representative of the State Master Councilor when no other ranking officer is present.

Section 7.06:

Said Officers will be required to memorize their portions of the Ritual Ceremonies.

Section 7.07:

Said officers shall be required to begin working on their L.C.C. and R.D. within thirty (30) after their appointment, if they have not previously completed them.

Section 7.08:

Said Officers shall be obligated to attend both Conclave and Mini-Conclave.

Section 7.09:

The State Parliamentarian shall decide the constitutionality of all motions, resolutions, and proposals presented by the standing committees or from the floor of Conclave, when so requested by the State Master Councilor.

Chapter 8

Amendments

Section 8.01:

These Statutes can be amended by a simple majority vote of the delegation, and such amendments may be substituted any time prior to the first Business Session of Conclave, and need only be submitted to the delegates of the Chapters in attendance at the Conclave.

Section 8.02:

These amendments, shall upon the approval of the Board of Administration and the delegation, take effect immediately.

**Charter of the Past State Officers' Association of the Order of
DeMolay in Florida**

The Past State Officers' Association of the Order of DeMolay in Florida, is hereby established subject to the following guidelines.

Purpose

The purpose of this Association shall be solely to aid and support the Order of DeMolay in Florida in any way (s) deemed appropriate by it's membership.

Membership

The membership of this Association shall consist of all Past Elected State Officers, Past State Scribes and Past State Scribe Treasurers of the Florida DeMolay Association who have reached the age of 21.

Meetings

This Association shall meet at least once each year at the Annual Conclave of the Florida DeMolay Association.

Officers

This Association shall have a Chairman, elected by a majority vote of the members present at the annual meeting, who shall serve for a term of one year. The Chairman shall preside at all meetings of this Association.

Rules and Regulations

General Conclave Rules

One of the best, most pleasant of the DeMolay year is our Annual State Conclave.

Everyone will have a much more enjoyable time if we all obey a few ground rules. Our Statutes prohibit behavior likely to bring disrespect upon the Order of DeMolay and conduct unbecoming that expected a member of our Order. Additionally, the Laws of the host city, the State of Florida and the United States, are to be obeyed at all times by everyone attending Conclave.

The following General Rules are for the protection of everyone at Conclave:

1. Our Statutes prohibit possession, use or consumption by DeMolays at Conclave of beer, liquor or controlled substances, including but not limited to cannabis, hallucinogens or other substances defined as "Controlled" by Florida Law.
2. No tobacco products. The use of any tobacco products, cigars, cigarettes, snuff or chewing tobacco, will not be allowed by any DeMolay during Conclave or at any other DeMolay function.
3. For your own protection and the protection of others, possession of firearms, fireworks, other explosives, switchblade knives and other like items or materials are prohibited.
4. No DeMolays are allowed on the floor where the Sweethearts are housed.
5. Dress for the evening meals will be shirt and tie, coats will be optional.
6. Shirt and tie are required for all Delegate Sessions and the General Opening. Dress for the banquet is formal or semi-formal.
7. Swimming suits are not allowed in the main lobby or in the video game room.
8. No Sweethearts or female guests are allowed in any DeMolay room.
9. Any damage to the hotel room will be billed to the persons registered in the room.
10. Room occupants are responsible for incidental charges such as telephone calls out of the hotel, special TV charges.
11. Anyone observing breach of these rules shall immediately report the activity to the Conduct Room or Conclave Office.

In the event that the Conduct Committee determines that a breach of these rules has occurred in any area at Conclave, all persons involved will be subject to being immediately sent home. Provided, that if the event is an isolated occurrence and no actual or constructive knowledge of the breach or infraction can be attributed to all persons in the area, only those involved in the event will be sent home. If a person (s) are sent home, his/her parents are responsible for all transportation charges and will be immediately advised of the reason for the individual's expulsion from Conclave. No refund will be made to those persons sent home.

Sweetheart Rules

All Sweethearts and their Chaperones must abide by the rules of the Executive Officer, Conclave Director, and Sweetheart Committee.

There must be an adult female chaperone or legal parent for every three Sweethearts to attend any Conclave function. Chaperones must be at least 25 (twenty-five) years of age. No Exceptions. Contestants for State Sweetheart must room with their Chaperones.

Chaperones should conform to all rules and regulations including the dress code for female Chaperones. All Sweethearts and their Chaperones must be officially registered through an active DeMolay Chapter with the approval of the Advisory Council.

1. In case of problems or questions, contact only the State Sweetheart Chairman or Committee. Do not contact the hotel staff.
2. Each Sweetheart must be a current Chapter Sweetheart, only one entry per Chapter will be accepted.
3. Sweetheart Contestants must be between the ages of fifteen (15) and twenty (20) years old as of July 1st of the year they compete and attending a Florida school or be a High School Graduate. They must wear name tags at all times and they are required to attend the first briefing session .
4. All Sweethearts should exemplify the highest DeMolay ideal of womanhood and conduct themselves in a lady-like manner.
5. Sweetheart Contestants cannot be engaged to be married, married, annulled, divorced, be or ever have been pregnant.
6. Sweetheart Contestants must have their parent's or guardian's approval in writing and submitted to the State Sweetheart Committee Chairman before the beginning of Conclave, together with a completed standard Florida DeMolay medical release form.
7. Each Sweetheart Contestant and her Chaperone must be registered and staying at Conclave (in the same room) the entire session. The Chaperone must know where her (his) Sweetheart is at all times. A Sweetheart Contestant Chaperone may not chaperone anyone else.
8. Sweetheart Contestants will be permitted to run no more than twice for State Sweetheart. Any girl who has been State Sweetheart is ineligible to run again.
9. A suitable 5 x 7 photo, preferably in color, must be submitted to the State Sweetheart Chairman the first day of Conclave. No other size photo will be accepted, and the photo will not be returned. (Photos with crown and sash will be permitted).
10. Pictures, cards, brochures, or any other campaign materials will not be distributed by a sweetheart or for her by any others. Sweethearts or female guests will not campaign in any way for candidates running for DeMolay State Office.

11. Any infraction of these rules by anyone may cause a Sweetheart Contestant to be disqualified from competition.
12. Sweetheart Contestants may not leave the hotel premises without a Chaperone and permission from a member of the State Sweetheart Committee.
13. No DeMolay will be permitted to enter a Sweetheart's room .
14. Sweetheart Contestants are not permitted in the vicinity of the ballot box while DeMolays are voting for State Sweetheart.
15. Each DeMolay will vote for three (3) girls for State Sweetheart, indicating their first, second, and third choice. Each first choice vote will receive three (3) points; second choice will receive two (2) points; and third choice will receive one (1) point. The girl receiving the highest number of points will be the State Sweetheart. There must be three different, eligible Sweetheart names on each ballot.
16. A member of the B.O.A. shall be present at the counting of the votes to assist the Sweetheart Committee.
17. The State Sweetheart cannot concurrently serve as a Chapter Sweetheart. She must resign from her chapter position upon election as State Sweetheart.
18. The State Sweetheart must notify the State Sweetheart Chairman within 15 Days of her election who her official Chaperone will be; any time the State Sweetheart attends any function wearing her Florida State Sweetheart sash and/or crown, she is under the State Sweetheart rules. The State Sweetheart must be Chaperoned from the time she leaves her home until the time she returns home.
19. It is the duty of the State Sweetheart to keep the State Sweetheart Chairman informed on all of her official activities.
20. Any engraving done on the State Sweetheart trophy or plaque will be paid for immediately by the F.S.D.A Sweetheart fund on presentation of a bill to the State Sweetheart Chairman.
21. The State Sweetheart is responsible for the crown, sash, cape, and crown box which will be returned to the State Sweetheart Chairman, in the same condition they were received in, at the beginning of conclave of upon request.
22. State Conclave registration for the out going State Sweetheart will be paid for by the Florida DeMolay association. (Contact the State Sweetheart Chairman.)
23. If the State Sweetheart marries, becomes engaged to be married, moves out of Florida, becomes pregnant, or leaves for 30 days, she must resign and return all State Paraphernalia. The first runner-up will replace her.
24. The State Sweetheart should be willing and able to travel to various parts of Florida to DeMolay activities, and also, to State DeMolay Functions when invited.

Dress Code

1. Contestants should at all times be dressed in good taste and appropriately for the occasion.
2. Dresses are recommended for most functions. It is understood that at all times bras, panties, slips, and hose will be worn with all dresses.

3. Backless dresses are acceptable must have bra and slip. Extremely tight clothing, skirts or dresses with high slits or low cut tops are unacceptable. When in doubt, don't wear it.
4. Slacks or dress jeans (not bare midriff or hiphugger type) may be worn to sports events or special activities. Shorts (not short shorts) will be permitted only if the occasion (sports, pool parties, etc.) warrants.
5. Bikini bathing suits (in good taste) may be worn. Robes must be worn over suits to and from the pool.
6. Formals will be worn at all formal functions -- Formal Introductions, Grand Banquet, or upon the request of the State Sweetheart Chairman.
7. Chapter sashes and crowns will not be worn at state conclave. Sashes will be provided. Sashes will not be worn with slacks or shorts.
