# DEMOLAY FLORIDA

From your Executive Officer

To the Officers, members, advisors & friends of Florida DeMolay:

Recently, I had a discussion with our State Senior Councilor, Bro. Hunter Hancock, in which he advised me of his plans to relocate to the State of Alabama for the purpose of attending Auburn University this fall in a contractual agreement pursuing a future career with the United States Navy.



As indicated in the Rules & Regulations of the Florida Jurisdictional Chapter, **"No State Officer may attend an out of state school or reside outside the State of Florida during his term of office. Any violation of these provisions shall automatically create a vacancy in the office."**

Pursuant to this clause of the Rules & Regulations, if installed, Bro. Hancock would automatically vacate the office of State Master Councilor upon his relocation. As such, through lengthy discussion and planning, a course of action was decided between Bro. Hancock and the progressive state line, and was approved by the Executive Staff of Florida.

Effective immediately, Bro. Hancock has tendered his resignation as the State Senior Councilor. Thanks to his exemplary service to Florida DeMolay and the purposes leading to his resignation, Bro. Hancock will retain the title of Past State Senior Councilor and Past Jurisdictional Officer.

Also per the Florida DeMolay Rules & Regulations, Bro. Hancock's resignation causes for Bro. Casey Ryan, the State Junior Councilor, to automatically advance to the office of State Senior Councilor. With the approval of the Executive Staff, Bro. Ryan will be installed as the next State Master Councilor of the Florida Jurisdictional Chapter at summer Conclave.

This advancement also causes a vacancy to be declared for the office of State Junior Councilor.

It is the recommendation of the State Master Councilor, as approved by the Executive Staff, that Bro. Dylan Myers of George Ulee Lord Chapter is hereby appointed as the State Junior Councilor for the remainder of the term. Bro. Myers will not be afforded the claim as a Past State Junior Councilor based on these few days of service, but will have all of the rights and privileges afforded his office until his successor is installed.
