Sunday, August 17, 1975

Brother Walter Hobbs Ricks, State Master Councilor of the Florida State DeMolay Association opened the 42nd Annual Florida State DeMolay Association Conclave honoring Dad Joseph G. Roberts at 7:15 P.M. on the Initiatory Degree. The Florida State DeMolay Association Chapter was opened on the DeMolay at 7:25 P.M. Immediately after opening on the DeMolay Degree, Brother Ricks and Dad Hunt informally welcomed all of the DeMolays present to the Conclave and the State Chapter was put in a state of recess so that all visitors and sweethearts could enter.

At 7:45 P.M. Dad Wallace J. Moneyhun welcomed all present to the Conclave and introduced Dad Townsend, the State Chapter Dad for the 42nd Annual Conclave. Dad Moneyhun also introduced Brother Larry Gillespie, State Junior Councilor; Brother Terry Moores, State Senior Councilor; Brother Warren Peck, Deputy State Master Councilor; and Brother Walter Hobbs Ricks, State Master Councilor of the Florida State DeMolay Association. Brother Ricks welcomed everyone to the Conclave and introduced Dad G. Lawrence Hunt, Executive Officer in the Jurisdiction of Florida; Dad Joseph G. Roberts, Past Executive Officer of the Jurisdiction of Eastern Florida and an Active Member of the International Supreme Council; and Dad John L. Crofts, 1974-1975 Grand Master of the Order of DeMolay.

Brother Warren Peck gave the Benediction and spoke on the DeMolay Experience.

Brother Tom Stoddard, State Orator, from Bahia Chapter gave the Ceremony of Lights.

Brother Ricks introduced Miss Holly Giroir, State

Sweetheart; Mrs. Frances James, President of the State Mother's Club; Mrs. Carol Brann, Coordinator of Women's Activities for Florida; Miss Marilyn Horst, Grand Honored Queen of Job's Daughters; Mrs. Dee Wagner, Bethel Guardian and Mr. Al Johnson, Associate Bethel Guardian of the Grand Bethel of Job's Daughters in Florida; Miss Kim Frazier, Grand Worthy Advisor of the Grand Assembly of Florida of the Order of the Rainbow for Girls.

Brother Ricks introduced Past State Councilors Brother Clyde Cooper, and Dad Rusty Glendinning. Brother Ricks then introduced Past State Master Councilors Dad Moneyhun and Dad Buchanan.

Brother Ricks introduced the four Regional Coordinators and the ten Provincial Governors. Dad Moneyhun, Governor of Province Seven announced that he and his wife were expecting a child and formally turned his Provincial Governor's Jewel over to his Lt. Governor, Dad Bill Townsend.

Brother Peck, acting Marshal, introduced the State Staff, Directors and Members of the Board of Administration, and Personal Representatives of the Executive Officer. Next, Brother Peck introduced the ten Province Master Councilors. Brother Peck then introduced State Scribe, Brother Joe Cravens and State Treasurer, Brother Jim Rose.

This public meeting of the Florida State DeMolay Association was closed by Brother Ricks at 9:15 P.M.

Monday, August 18, 1975

The 42nd Annual Conclave of the Florida State DeMolay Association was formally opened at 9:07 A.M. by Brother Ricks, State Master Councilor. The Chapter was immediately put into a state of recess so that the visitors could enter.

Dad William C. Hill, Grand Master of Masons in Florida made an address to the DeMolays and Advisors present.

The meeting was concluded at 10:09 A.M.

Tuesday, August 19, 1975

The 42nd Annual Conclave of the Florida State DeMolay Association was reconvened at 9:12 A.M. by the State Master Councilor, Brother Walter Hobbs Ricks.

Dad Joseph G. Roberts was introduced at the altar and escorted to a seat in the East.

Dad Earnest P. Quarterman was presented in the East to make an announcement about the Masonic Youth Activities Program to give Lapel pins to go along with the certificates for being the Outstanding DeMolay of the Year in a particular Chapter. He said that the pins would be mailed to the DeMolays or would be given to them by the District Chairman of the Masonic Youth Activities Committee. He said that in the future that the lapel pins would be given out along with the certificates.

Several delegates arrived late and were seated in their respective places.

The Credentials Committee Chairman, Brother Moores, took a roll call of the Chapters.

Brother Ricks read parts of the Florida State De-Molay Association by-Laws which were pertinent to the number of delegate-votes from a chapter in the case that one or more delegates registered and attending conclave were absent from a session.

Credentials Committee Report

Delegates (Total) - 79 Simple Majority - 40 2/3 Majority - 53

Brother Cravens, State Scribe, moved that the proceedings of the 41st Annual Conclave of the Florida State DeMolay Association be accepted as printed and distributed. Seconded. Motion carried.

Brother Ricks stated that upon the approval of the State Minutes that the new State Scribe, Brother Ricky Mays would take over.

Brother Ricks introduced Dad G. Lawrence Hunt for a rap session with the delegates.

Brother Ricks announced that all those who would like to submit a resolution to the Conclave, should turn it in to Brother Rick Brown by 1:30 P.M. Tuesday.

Brother Tom Giroir, Chairman of the State Membership Committee was presented in the East in order to make the State Membership Committee Report. Proposal 1 of the Membership Committee Report was objected to. Proposal 2 of the Membership Committee Report was not objected to. Proposal 3 of the Membership Committee Report was objected to. Brother Teretka objected to Proposal 4 of the Membership Committee. Proposal 5 of the Membership Committee was not objected to. Brother Marcel Mazeau objected to Proposal 6 of the Membership Committee Report. Brother Rusty Harmon objected Proposal 7 of the Membership Committee Report. Proposal 8 of the Membership Committee Report was not object ed to. Proposal 9 of the Membership Committee Report was not objected to. Brother Giroir moved that the Proposals 2,5,8, and 9 being unobjected to be accepted. Seconded. Motion carried. Brother Heise made an amendment to Proposal 1 that the word Province be deleted and that the word Regional be substituted in its place. Seconded. The amendment was defeated. Proposal 1 was voted on and passed. Proposal 3 was voted on and passed after Brother Pederson withdrew his

objection. Brother Teretka, in reference to Proposal 4, asked how much the pamphlets were going to cost. Brother Ricks, State Master Councilor, replied that the pamphlets would probably be printed on the Florida State DeMolay Association mimeograph machine on the Florida State De-Molay Association paper and that the amount of money necessary would be decided by the new State Councilors. Brother Teretka then withdrew his objection. Proposal 4 was voted on and passed. Brother Mazeau asked for a brief explanation of exactly what the Golden Spike Award was. Brother Mazeau then withdrew his objection and Proposal 6 was voted on and passed. Brother Harmon made an amendment to Proposal 7 that the words Florida State DeMolay Association be deleted and that the words "Four State Councilors" be added in their place. The amendment was seconded. Motion carried. An amendment was made that the number "2" in the third sentence of Proposal 7 be changed to the number "5". Seconded. Motion defeated. Proposal 7 was then voted on and passed. Brother Giroir moved that the Membership Committee Report be accepted as amended. Seconded. Motion carried.

Brother Donn Derry, Chairman of the State Knight-hood Committee, was presented at the East for the reading of the Knighthood Committee Report. Paragraphs 1, 2, and 3 of the Knighthood Committee Report were not objected to. Brother Donn Derry, Knighthood Committee Chairman moved that the Knighthood Committee Report be accepted as read. Seconded. Motion carried.

Action Committee was presented at the East for the reading of the Community Action Committee Report. Proposal 1 of the Community Action Committee Report was objected to by Brother Teretka. Brother Trout objected to Proposal 2 of the Community Action Report. Proposal 3 was not objected to. Brother Wardell objected to Proposal 4. Brother Roberts moved that the unobjected to portion of the Community Action Committee Report be accepted. Seconded. Motion carried. Brother Teretka asked Brother Roberts if he was aware that in some parts of the State that there are ordinances against having road blocks as mentioned in Proposal 1. Brother Roberts replied that that was the reason for having more than

one suggestion. Brother Teretka then withdrew his objection. Proposal 1 was then voted on and passed. Brother Trout made an amendment to Proposal 2, that the word "parade" be changed to the word "hike". Seconded. Amendment defeated. Proposal 2 was then voted on and passed.. Brother Wardell withdrew his objection to Proposal 4. Proposal 4 was then voted on and passed. Brother Roberts moved that the Community Action Committee Report be approved as amended. Seconded. Motion carried.

Brother Ricks, State Master Councilor, introduced Dad Robert Young, Central Regional Coordinator. Dad Young announced the "Masons for America Day" on Sept. 20th in Melbourne. He said that there would be a parade and that he hopes that all chapters would enter a float. Dad Young said that there will be a free fish fry after the parade. Later, there would be an Honorary Initiatory Degree which would be followed by a Legion of Honor Investiture. He said that that night there will be a dance with a live band. Dad Young said that there would be some kind of program, whereby the DeMolays could go to Disney World. He said that for the DeMolays that had to travel a long distance to get to the celebration, housing could be arranged for little or no fee.

Brother Sasser was presented at the East in order to read the State Athletics Committee Report. Brother Barker objected to Proposal 1 of the Athletics Committee Report. Brother Harmon objected to Proposal 2. Brother McNutt objected to Proposal 3. Brother Prettyman objected to Proposal 4. Brother Harmon objected to Proposal 5. Brother McNutt objected to Proposal 6-A. There was no objection to Proposal 6-B. Brother Wardell objected to Proposal 7. Proposal 8 was not objected to. Proposal 9 was not objected to. Brother Harmon objected to proposal 10. Brother Burdett objected to Proposal 11. Proposal 12 was not objected to. Brother Tucker objected to Proposal 13. Proposal 14 was not objected to. Brother Barker objected to Proposal 15. Brother Sasser moved that the unobjected to portions of the Athletics Committee Report be accepted. Seconded. Motion carried. A general discussion was held on the advantages and disadvantages of introducing a wrestling program into the State Competition level as stated in Proposal 1. Proposal 1 was then voted on and passed. The State Chapter was then put into a state of recess, to be reconvened at 3:30 P.M.

The State Chapter was reconvened at 3:30 P.M. by Brother Peck, Deputy State Master Councilor. A chapter roll call was made. The chapter began work on finishing up the State Athletics Committee Report. There were no objections to Proposal 2. Proposal 2 was passed. Brother Sasser moved that Proposal 3 be accepted. Seconded. Brother Wardell made an amendment to Proposal 3 to delete the word "paid". Seconded. Motion carried. Proposal 3 was accepted as amended. Brother Sasser moved that Proposal 4 be accepted. Seconded. Proposal 4 was voted on. Division of the house was called. A stand-up vote was taken. Results: 43 in favor, 44 against. Motion defeated. Brother Sasser moved that Proposal 5 be accepted. Seconded. Motion carried. Brother Sasser moved that Proposal 6-A be accepted. Seconded. Teretka asked how much extra it would cost to extend Conclave by a day. Proposal 6-A was voted on. Division of the house was called. The Motion was defeated. Brother Wardell moved that Proposal 7 be deleted. Brother Ricks, State Master Councilor declared him out of order. Brother Sasser moved that Proposal 7 be accepted. amendment was made by Brother Wagner that the word "another" in Proposal 7 be changed to the word, "same". Seconded. Amendment carried. Proposal 7 was voted on. Division of the house was called. Motion defeated. Brother Sasser moved that Proposal 10 be accepted. Seconded. Motion defeated. Brother Sasser moved that Proposal 11 be accepted. Seconded. Motion carried. Brother Sasser moved that Proposal 13 be accepted. Seconded. Brother Burdett made an amendment to Proposal 13 that the last sentence be deleted and that the following sentence be put in its place: "The competition will be for all active DeMolays." Seconded. Amendment carried. Brother Ricks, State Master Councilor stated that the program stated in Proposal 13 was not instituted to be a sports' program per se, but that it was just to be an activity for the younger guys. Motion carried. Brother Sasser moved that Proposal 15 be accepted. Seconded. Brother Barker withdrew his objection. Motion carried. Brother Sasser moved that the State Athletics Committee Report be accepted as amended. Seconded. Motion carried.

Brother Zwass, the Chairman of the State Public Relations and Publications Committee, was presented at the East to read the State Public Relations and Publications Committee Report. There were no objections to Proposal 1-A of the Public Relations and Publications Committee Report. Brother Harmon objected to Proposal 1-B. Proposal 1-C was not objected to. Proposal 2 of the Public Relations and Publications Committee Report was not objected to. Proposal 3-A was not objected to. Brother Burdett objected to Proposal 3-B. There were no objections to Proposal 3-C. There were no objections to Proposal 4. There were no objections to Proposal 5. Brother Zwass moved that the unobjected to portions of the State Public Relations and Publications Committee Report, Proposals 1-A, 1-C, 2, 3-A, 3-C, 4, & 5, be approved. Seconded. Motion carried. Brother Harmon made an amendment that Proposal 1-B be changed to read as follows: "We would like to make it plain that two papers be sent to the Chapter Dad and one paper be sent to the Chapter Scribe and that they be displayed for the membership to read." Seconded. Amendment carried. Brother Zwass moved that the State Public Relations and Publications Committee Report be approved as amended. Seconded. Motion carried.

Brother Larry Gillespie, State Junior Councilor was presented at the East to read the State Conduct Committee Report. There were no objections to any part of the State Conduct Committee Report. Brother Gillespie moved that the State Conduct Committee Report be approved as read. Seconded. Motion carried.

Brother James Rose, State Treasurer was presented at the East for the reading of the State Finanacial Committee Report. Brother Trout moved that the State Financial Committee Report be approved as read. Seconded. Brother Mazeau stated that several of the chapters that donated to the Sheriff's Boy's Ranch were not listed as having donated. The motion to approve the report as read was carried.

Brother Peck, State Deputy Master Councilor, was presented in the East to read the State Cabinet Committee Report. There were no objections to the State Cabinet Committee Report. Brother Giroir moved that the State Cabinet Committee Report be approved as read. Seconded. Motion carried.

A roll call of Provincial Master Councilors was taken. Brother Ricks, State Master Councilor thanked Dad Joseph G. Roberts for sitting in on the meeting. The State Chapter was placed in a state of recess at 5:25 P.M.

The State Chapter was reconvened at 8:05 P.M. by Brother Ricks, State Master Councilor. A roll call of chapters was made.

Brother John Boone was presented in the East to read the State Ritual Committee Report. There were no objections to Proposal 1-A of the State Ritual Committee Report. Brother Ettinger objected to Proposal 1-B of the report. Brother Teretka objected to Proposal 1-C. There were no objections to Proposal 2. There were no objections to Proposal 3. Brother Wardell objected to Proposal 4. Brother Teretka objected to Proposal 5. Brother Trout moved that the unobjected to Proposals of the State Ritual Committee Report be approved as read. Seconded. Motion carried. Brother Ettinger withdrew his objection and moved that Proposal 1-B be accepted. Seconded. Motion carried. Brother Teretka withdrew his objection to Proposal 1-C. Brother Burdett moved that Proposal 1-C be accepted. Motion carried. Brother Ettinger moved that Proposal 4 be accepted. Seconded. Brother Wardell asked whether, if this Proposal was accepted, would it change the S.O.P. Brother Ricks, State Master Councilor, stated that this would only be a recommendation and that the Executive Officer is the only one who has the authority to change the S.O.P. Brother Wardell withdrew his objection. Proposal 4 was then voted on. Motion carried. Brother Champoux moved that Proposal 5 be accepted. Seconded. Brother Teretka said that if the ritual classes were for the purpose of teaching of the ritual and that it was to be on a Provincial level, that the Provinces should be the ones to decide whether to have

The Proposal was then voted on. Motion carried. Brother Stoddard moved that the State Ritual Committee Report be accepted. Seconded. Motion carried. Brother Kelley, Chairman of the State Conclave Committee, was presented at the East to read the State Conclave Committee Report. Brother Teretka objected to Proposal 1 of the State Conclave Report. Brother Trapp objected to Proposal 2 of the Report. Brother Miller objected to Proposal 3. Brother Merrit objected to Proposal 4. There were no objections to Proposal 5. There were no objections to Proposal 6. Brother McNutt objected to Proposal 7. Brother Miller moved that the unobjected to Proposals of the State Conclave Committee Report be approved. Seconded. Motion carried. Brother Pederson moved that Proposal 1 be accepted. Brother Teretka stated that he felt that the Conclave should not be extended one day, because it would just cost more money, and if the Conclave was planned well that all the events could be fitted in efficiently. Brother Pederson stated that Conclave should be extended one day for the purpose of sports events. Brother Wardell moved the previous question. Second-Motion carried. The main motion was voted on. Division of the house was called for. A standing vote was taken. 74 for, 68 against. Motion carried. Brother Trapp moved that Proposal 2 be accepted. Seconded. Motion carried. Brother Kelley moved that Proposal 3 be accepted. Seconded. Division of the house was called for. A standing vote was taken. Motion carried. Brother Kelley moved that Proposal 4 be accepted. Seconded. Brother Merritt stated that with the DeMolays split up that there would be less of a chance for trouble to start, but if trouble did start that a smaller number of DeMolays would be in the area. Brother Stokes stated that it would be easier for the Conduct Committee to cover the DeMolays if they were all in the same place, but when they are spread all over the place they are harder to watch and harder to control. Brother Pederson stated that DeMolays come to Conclave for comradeship and fellowship and that if they split us up, there won't be that comradeship and fellowship. Proposal 4 was then voted on. Motion carried.

Brother McNutt moved that Proposal 7 be accepted. Seconded. Brother McNutt withdrew his objection. Brother McNutt moved that the Proposal be amended to read as follows: "7. The Committee finally proposes that a more complete and informative dress code be distributed to all attending the conclave along with the registration forms when they go out." Seconded. Amendment passed. The main motion as amended was voted on. Motion carried. Brother Kelley moved that the State Conclave Committee Report be approved as amended. Seconded. Motion carried.

A chapter roll call was taken. Brother Ricks, State Master Councilor opened up the floor for questions to Brother Warren Peck and Brother Brett Dolar, candidates for the office of State Master Councilor. Brother Ricks read parts of the State By-Laws which pertained to the election of the state officers. Brother Ricks, State Master Councilor, stated that the Provincial Master Councilors would be distributing the ballots. Brother John Hess, Chairman of the State Nominations Committee was presented at the East to make the State Nominations Committee Report. Brother Hunt moved that the State Nominations Committee Report be accepted as read. Seconded. Motion carried. Brother Ricks, State Master Councilor then announced that the floor was open for the purpose of elections. He stated that a ballot was going to be taken for the office of State Master Councilor.

Credentials Committee Report:

Total Number of Votes - 171 Simple Majority - 86 2/3 Majority - 114

Brother Warren Peck and Brother Brett Dolar were the candidates for the office of State Master Councilor. The results are as follows:

Motion carried. Brother Stokes moved that Article IIB, Section III be accepted as amended. Seconded. Brother Ricks stated that this amendment would mean that in competition only the playing rules not the rules on eligibility, etc., would be used. Motion carried. Brother McNutt moved that Article IIIB, Section V be accepted as amended. Seconded. There was no discussion on the motion. Brother Garrick moved that Article VC, Section I be approved as amended. Seconded. Brother Ricks stated that this amendment would delete the Conclave Committee. Brother McNutt stated that if the State Association was taking bids and not the State Conclave Committee then the State Association was going against the Constitution. He suggested that the State Association start following the Constitution rather than change the Constitution to go along with the State Association. Brother Ricks stated that the way that the Conclave Committee planned to get the bids for the hotels for the upcoming conclave was not the way that the State Association worked and that it was not economically feasible. Motion defeated. Brother Ricks stated that he hoped that the next chairman of the Conclave Committee for the first time would do his job. Brother Woods moved that Article VC, Section I be accepted as amended. Seconded. There was no discussion. Motion carried. Brother Williams moved that Article VIC, Section I be accepted as amended. Seconded. Brother Ricks stated that the change to sixty days would only pertain to the Constitution. Brother McNutt asked why they wanted to knock off the thirty days. Brother Ricks stated that was so the people who wanted to propose the changes to the Constitution would have more time to work up the changes. Motion carried. Brother Garrick moved that Article IVB, Section II be accepted as amended. Seconded. Brother Ricks stated that if the last sentence of the section was deleted that the State Master Councilor would not be forced to work with the Conclave Committee Chairman. Brother McNutt stated that if the State Master Councilor did not have to work with the State Conclave Committee Chairman that the two groups would probably be fighting all the time and would not get anything done. Motion defeated. Brother Ettinger moved that Article IVB, Section be accepted as amended. Seconded. Brother McNutt.

asked Brother Ricks whether he thought fifteen hundred dollars would be enough. Brother Ricks stated that it would not but that the Board of Administration would not approve anything higher. Motion carried. Brother McNutt moved that Article IVB, Section XV be accepted as amended. Seconded. There was no discussion on the motion. Motion carried. Brother McNutt stated that he felt that the amendment in question was to be acted upon in the case that the Conclave committee was deleted from the list of standing committees and since the Conclave was not deleted from the list of standing committees that he felt that Article VIB, Section X should not be amended. Division of the House. Motion defeated. Brother McNutt moved that Article VIB, Section XV be accepted as amended. Seconded. Brother Ricks stated that this amendment would further explain the duties of the committee chairmen. Brother Ricks stated that when the word "member" is mentioned in the Constitution and By-Laws that it meant member chapters of the Florida State DeMolay Association. Motion carried. Brother Ricks stated that the next amendment would be to add a new section to Article VIB. Brother Fox moved that Article VIB, Section XVIII be accepted. Seconded. Brother Hutchinson asked what committee the Deputy State Master Councilor was at present the chairman of. Brother Ricks stated that he was the chairman of the State Cabinet Committee. There was no further discussion. Motion carried. The State Chapter was placed in a state of recess by Brother Ricks at 12:30 to be reconvened after the installation of officers.

The State Chapter was reconvened at 2:50 pm by Brother Ricks. Dad Hunt spoke on the accusation by individuals that the Past State Officers had embezzled money from the Association.

Brother Giroir moved that Article IIB, Section IV be accepted as amended. Seconded. Brother McNutt asked if he was correct in assuming that the amendment would cause the State Mother's Club would have nothing to do with the Sweetheart Competition. Brother Gillespie stated that his assumption was correct.

Brother McNutt stated that he felt that the DeMolays should make the rules for the competition. Brother Gillespie stated that Dad Hunt had already said that he was going to make the rules for next year's Conclave. Brother Teretka moved the previous question. Seconded. Motion carried. The main motion was carried. Brother McNutt moved that Article IIIB, Section II be accepted as amended. Seconded. Brother Ricks asked for a motion that the State Constitutional Revisions Report be accepted as amended. Brother Melvin moved that the State Constitutional Revisions Report be accepted as amended. Seconded. Motion carried. Brother Ricks stated that "it is with great humility, pride, and pleasure that I now close this Forty-second Annual Conclave."

ARTICLE IVC, Section VI

- (a) No candidate shallin the office.
- (b) The vacancy of an appointed State Office may be declared by the State Master Councilor after an evaluation of that State Officer's performance. A vacancy will also occur in the office of State Scribe upon the recommendation of the State Master Councilor and with the approval of the Board of Administration.

ARTICLE IVC, Section VIII (New Section)

The State Treasurer shall be elected during the general business session of this Association and shall serve until his successor has been installed and an audit has been performed by an accountant who has been approved by the Executive Officer. This audit shall be completed within a week after the close of Conclave.

ARTICLE IVC, Section IX

All candidates for the office of State Treasurer shall be Past Master Councilors, shall hold the Representative DeMolay Award, and have completed the Leadership Correspondence Course. He shall also have either a personal checking account or a personal savings account.

ARTICLE IIIB, Section X (New Section)

Any qualified brother who desires to run for the office of State Treasurer shall submit a letter of intent to the Executive Officer and the Chairman of the State Nominations Committee within 60 days prior to the opening of registration of the Annual Conclave. Only those brothers who submit a letter of intent for this office shall be eligible to run.

ARTICLE VIB, Section VIII

Change to read, "The duty of the Public Relations and Publications Committee shall be to promote the image of DeMolay through programs of public interest and to put

the name of DeMolay before the general public. It shall also be the duty of this committee to inform and assist member chapters in the Annual DeMolay Week Program. This committee shall oversee any publication of this Association and any related programs.

ARTICLE VIB, Section XV

After much consideration, we of the Public Relations and Publications Committee have come to realize the following points to be of primary consideration:

- 3. The Bicentennial Celebration
- 4. Contacting the News Media
- 5. Miscellaneous Recommendations

The Florida DeMolay:

It was found that not enough articles were being written and sent to the Editor.

A. Recommendation: The recommendation of this committee to the State Master Councilor is that this committee be retained in tact because of their interest, and because of their desire to get the job done.

It was reported that the newspaper was not reaching the individual chapters.

- B. We would like to make it plain that two (2) papers be sent to the Chapter Dad and one (1) paper be sent to the Chapter Scribe, and be displayed for the membership to read.
- C. The subscription fee for the "Florida DeMolay" shall remain \$1.00.

2. The Florida DeMolay Radio and T.V. Jingle

We recommend extensive usage of the Florida De-Molay Jingle. We have found this to be a very valuable tool for the publicizing of your chapter events.

Copies of this tape may be purchased for a nominal fee of \$10.00.

3. The Bicentennial Celebration

Following the recommendations of the 6th, 7th, and 8th DeMolay Congress,

- A. We recommend that all of our chapters participate in the American Revolution Bicentennial. License plates promoting the Bicentennial Celebration, and publicizing DeMolay, may be purchased for \$5.00.
- B. This committee recommends the institution of a Bicentennial Committee, to be a branch of the Public Relations and Publications Committee.
- C. We of the Publications and Public Relations
 Committee are in unanimous support of the availability
 of the publication "Dynamic Freedoms". These have
 been donated by the Supreme Council 33° of the Ancient
 and Accepted Scottish Rite of the Southern Jurisdiction
 of the United States of America.

4. Contacting the News Media

We recommend that every chapter have a working relationship with its' news media. (City Editors for newspapers, and news Directors for Radio and T.V.)

5. Miscellaneous Recommendations

CONCLAVE COMMITTEE REPORT

We, the members of the Athletics Committee for the 42nd Annual Florida State DeMolay Conclave, realizing the need to improve sports competition on all levels of the Jurisdiction, do hereby recommend the following to the Legislators of the 42nd Annual Conclave.

We recommend:

- 1. The introduction of wrestling on a Statewide competition level. Rules of the Florida High School Athletic Association will be the standard. Wrestling tournaments will be held on province and regional levels, with regional winners going on to the state tournaments. At the State Tournament there will be individual champions and a team championship.
- 2. The introduction of golf into state competition. There would be province tournaments with the top two scorers going on to a regional tournament. This regional tournament need not necessarily take place at regional conclave. The top two scores at the regional tournament will compete in the state tournament. There will be no team championship; competition will be only on an individual basis.
- 3. That regulation referees and umpires be mandatory for all championship games on a province, regional, and state level.

Dispensation is further granted to the Florida State DeMolay Association to adopt such as Constitution and By-Laws governing itself and to conduct such business as are consistent with the Constitution, General Statutes, and Chapter Regulations of the International Supreme Council.

Florida State DeMolay Association Constitution and By-Laws (revised)

Constitution

Article IC Name, Purpose, Colors

Section I

This organization shall be known as The Florida State DeMolay Association, Order of DeMolay (hereinafter, Association).

Section II

It shall be the purpose of this Association to work for the betterment and promotion of DeMolay ideals and activities in the State of Florida, to promote harmony within the member chapters and to assist those chapters in bringing DeMolay to the eligible youth of Florida.

Section III

The official colors of this Association shall be the royal colors of Purple and Gold.

Article IIC Allegiance and Authority

Section I

The Association, its officers, advisors and the individuals of member chapters of this Association pledge their allegiance to the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary, and the Executive Officer of the Order in the State of Florida.

Section II

This body is constituted with the power and authority to set forth laws and to set forth standards of inter-chapter relations; and to levy fees and taxes, provided that these measures are in harmony with the International Supreme Council of the

Order of DeMolay and the dispensation under which this Association operates.

Article IIIC Membership and Representation

Section I

The members of this Association shall be the several duly constituted Chapters, and those holding Letters Temporary of the Order of DeMolay, located in the State of Florida.

Section II

The members of this Association shall meet annually for the purpose of conducting business, electing officers, holding sports and ritual competition and all other activities provided for in the By-Laws of this Association.

Section III

In order for the delegation of a member chapter to attend Conclave and register, the said delegation must be accompanied by a Certified Member of the Advisory Council or a Master Mason, approved by the Provincial Governor for each ten (10) DeMolays or fraction thereof in attendance. No chapter shall be allowed to register its delegation if said chapter has not paid, in full, all assessments due this Association.

Section IV

Each member chapter shall be entitled to be represented by three (3) delegates at the Annual Conclave/ Each delegate shall have on vote in all matters brought on the floor of the Conclave, providing he has been certified by his chapter advisor and has registered with the Credentials Committee prior to the opening of Conclave. In the event that less than three (3) delegates from a Chapter are in attendence at Conclave, any or all of the absent delegate votes may be given to a remaining delegate from that chapter. In order tp accomplish this, the chapter advisor must submit written authorization to the Credentials Committee before

the opening business session of the Conclave.

Article IVC Officers

Section I

The officers of this Association shall consist of the State Master Councilor, Deputy State Master Councilor, State Senior Councilor, State Junior Councilor, State Scribe, State Treasurer, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Chaplain, State Marshal, State Orator, State Standard Bearer, State Parlimentarian, Seven State Preceptors, State Editor, State Committee Chairmen, and all others selected by the State Master Councilor and/ or Executive Officer of the State of Florida.

Section II

The State Master Councilor, Deputy State Master Councilor, State Senior Councilor, and the State Junior Councilor shall be elected during the general business session of the Association, in Conclave assembled each year, and these officers shall serve until their successors are installed.

Section III

All candidates for elected State Office must be Past Master Councilors, Representative DeMolays and have completed the Leadership Correspondence Course. They must also be residents of the State of Florida for at least six months prior to election.

Section IV

The State Scribe shall be appointed by the Board of Administration from a list of nominations submitted to them by the State Master Councilor prior to the opening of the first business session or as provided by Article IV, Section VI-B.

Section V

All other State Offices shall be filled by appointment by the State Master Councilor. These officers shall serve until the close of the following Conclave.

Page 59

Section VI

(a) No candidate shall be elected to a State Office who would reach the age of 21 years prior to June 1st of the year following his election. No State Officer may attend an out-of-state school or reside outside of the State of Florida during his term of office. Any violation of these provisions shall automatically create a vacancy in the office.

(b) The vacancy of an appointed State Office may be declared by the State Master Councilor after an evaluation of that State Officer's performance. A vacancy will also occur in the office of State Scribe upon the recommendation of the State Master Councilor and with the approval of the Board of Administration.

Section VII

In the case of a vacancy in the elective offices, each State Councilor shall advance to the next highest office and a State Junior Councilor shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer. Vacancies in all other State Offices shall be filled by the appointment of the State Master Councilor.

Section VIII

The State Treasurer shall be elected during the general business session of this Association and shall serve until his successor has been installed and an audit has been performed by an accountant who has been approved by the Executive Officer. This audit shall be completed within a week after the close of Conclave.

Section IX

All candidates for the office of State Treasurer shall be Past Master Councilors, shall hold the Representative DeMolay Award, and have completed the Leadership Correspondence Course. He shall also have either a personal checking account or a personal savings account.

Section I

The following committees shall be considered as standing committees of this Association:

- 1. Jurisprudence
- 2. Resolutions
- 3. Nominations
- 4. Finance
- 5. Membership
- 6. Conduct
- 7. Credentials

- 8. Public Relations and Publications
- 9. Ritual
- 10. Conclave
- ll. Athletics
- 12. Constitutional Revisions
- 13. State Cabinet
- 14. Community Action

Article VIC Amendments

Section I

The procedure for amending this Constitution is as follows:

(a) It shall be the responsibility of any Florida DeMolay proposing an amendment to this Constitution to provide for the distribution of said proposal to the Committee on Constitutional Revisions, Committee on Jurisprudence, Elective State Officers, Executive Officer, Board of Administration and member chapters of this Association not less than 60 days prior to the opening of Conclave.

(b) The proposed amendment after approval of the Committee of Jurisprudence and the Board of Administration shall be presented for consideration on the floor of Conclave. Upon the approval by two-thirds of the delegates present and voting it shall take immediate effect.

Florida State DeMolay Association Constitution and By-Laws(revised)

By-Laws

Article IB Revenue

Section I

Each member chapter shall pay as dues on or before the due date of the Annual Report the sum of ten dollars (\$10.00) to the Florida State De-Molay Association, Inc. In addition, each member except those holding Letters Temporary issued since the due date of the last Annual Report shall pay forty five cents (\$.45) per capita tax for each De-Molay in good standing as shown on the most recent Annual Report to the International Supreme Council. All income received by this Association shall be deposited in the Florida State DeMolay Association Inc. Account to be distributed to the proper funds as required herein, or by other competent authority.

Section II

The revenue of this Association shall be derived from the following sources:

- (1) Dues of the Association
- (2) Per Capita tax for each active DeMolay as listed in each Member's Annual Report to the International Supreme Council
- (3) Registration fees for Annual State Conclave
- (4) Sale of items approved by the Executive Officer
- (5) Gifts and/or bequests from proper sources

Article IIB State Conclave

Section I

There shall be ritual competition;
Athletic competition; State Sweetheart competition;
election of State Officers and any other business for
the good of the Order in this Association.

Section II

There shall be ritual competition conducted at the State Conclave under the direction of the Executive Officer's Personal Representative for the International Supreme Council Ritual and Awards, assisted by the Chairman of the State Ritual Committee. This competition shall be limited to the winners of the several regions in each category. The Executive Officer's Personal Representative of International Supreme Council Ritual and Awards shall appoint no less than three (3) judges for each competition, who solely shall have the authority to determine the winner of each competition. The rules and regulations governing the Ritual competition shall be published along with the official minutes of each Annual State Conclave for the governing of competition at the next Annual State Conclave. The ritual competition shall be composed of the Initiatory Degree, Opening and Closing Ceremonies (including the Nine O'clock Interpolation), Flower Talk, and Oratorical Competition.

There shall be athletic competition conducted at the State Conclave under the direction of the State Advisor of Athletics appointed by the Executive Officer assisted by the Chairman of the Athletics Committee. This competition shall be limited to the winners of the several regions in each category. The State Advisor of Athletics, appointed by the Executive Officer shall appoint for each competition qualified referees for each event who shall solely have the authority to determine the winner of each competition.

Section IV
There shall be State Sweetheart
competition at State Conclave. The rules and regulations as determined by the Executive Officer
shall be published in the proceedings of that year's
Conclave.

Article IIIB Elections

Section I

Any qualified brother who desires to run for an elective office of this Association shall send a letter of intent to the Executive Officer and the Chairman of the Nominations Committee, within sixty (60) days prior to the opening of registration of the Annual Conclave.

Section II

A candidate shall not cause any distribution of materials written or oral pertaining to his candidancy before he has submitted his letter of intention to the proper persons (as stated in Article IIIB, Section I). He will be authorized to distribute calling cards only. They will be printed on one side only. This card will be no larger than the standard DeMolay dues card in overall size, and will contain no information other than name, address, titles and/or honors and the title of office being sought by the candidate. This card will be the only authorized material which may be distributed in his behalf at Conclave or at any other time.

Section III

No candidate or individual(s) representing a candidate will make public statements either verbal, written or printed at any officially designated DeMolay function or activity as to the intentions of a candidate seeking any elective office in this Association until after a date sixty (60) days prior to the opening of registration at the State Conclave and after receipt by the Executive Officer of the candidate's letter of intention.

Section IV
The election of officers of this Association shall take place at the discretion of the State Master Councilor during a regular business session at each Annual State Conclave.

Section V No two (2) State Councilors shall be from the same member chapter of this Association.

Section VI It being the purpose of the Order of DeMolay to develop leadership and a sense of resposibility among individual members of the Order, Officers of this Association shall not succeed themselves.

Section VII Any violation of these regulations shall be constituted reason for disqualification by act of the Nominations Committee. Notification to the Chairman of the Nominations Committee of any violation may be made by any DeMolay or Advisor. Such notification should include specific evidence when possible.

Section VIII The election of officers shall be in the order of rank, the highest being first, the order as provided by this Constitution, by secret ballot of those entitled to vote, as otherwise provided in the Constitution, at each Annual Conclave of this Association. A majority of the ballots cast shall be necessary for a choice to elect.

Section IX

The ballots for the election of officers shall be prepared by the State Scribe for each Annual Conclave. The ballots shall be distributed to each delegate entitled to vote, prior to the opening of elections, and the ballots shall be cast with the surname only of the candidate for the particular office. legibly written thereon; ballots shall be folded only once. Blank ballots, illegible ballots and otherwise deviating from the proper form provided herein shall be tabulated as abstentions

Section X

Any qualified brother who desires to run for the office of State Treasurer shall submit a letter of intent to the Executive Officer and the Chairman of the State Nominations Committee within 60 days prior to the opening of registration of the Annual Conclave. Only those brothers who submit a letter of intent for this office shall be eligible to run.

Article IVB Duties of State Officers

Section I

The State Master Councilor shall be the duly elected head of this Association, and it shall be his duty to perform all duties which naturally pertain to such an office or which may devolve upon him from time to time.

Section II

The State Master Councilor shall preside at the Annual Conclave and work in conjunction with the Board of Administration. He shall also work with the Conclave Committee in making arrangements for said Conclave.

Section III

The State Master Councilor shall appoint all committee Chairmen of this Association, and in consultation with each chairman, appoint the committee members.

Section IV

The State Master Councilor shall have an expense account with funds up to fifteen hundred dollars (\$1,500) which shall be used for reasonable expenses incurred in the performance of his and the other State Councilor's duties, with the State Master Councilor's approval.

Section V

The State Master Councilor shall in person, or by Special Deputy, visit each provincial chapter in this state at least once during his term

of office.

Section VI

The Deputy State Master Councilor, the State Senior Councilor, and the State Junior Councilor shall represent the State Master Councilor as his Special Deputies when so ordered.

Section VII

The State Master Councilor shall report in writing to the Association at each Annual Conclave, all of his Official Acts, whether performed in person or by Special Deputy.

Section VIII

The State Senior Councilor shall serve as Chairman of the Jurisprudence Committee.

Section IX

The State Junior Councilor shall serve as Chairman of the Conduct Committee.

Section X

The Deputy State Master Councilor, the State Senior Councilor, and the State Junior Councilor shall assist the State Master Councilor in every way possible in the discharge of his duties.

Section XI

The Deputy State Master Councilor, the State Senior Councilor, and the State Junior Councilor shall report in writing to this Association at each Annual Conclave, all of their Official Acts.

Section XII

The State Scribe shall record the minutes of the Annual Conclave of this Association. He shall then within sixty (60) days have the aforesaid minutes together with the Constitution and By-Laws as of their latest revision, published together with the rules and regulations of the ritual and sweepstakes competition to be distributed as follows:

1. One copy to each member of this Association

- 2. Copies to the Executive Officer, one copy to cach member of the Supreme Council residing in the state, and one copy to any advisor appointed by the Executive Officer in a supervisory capacity, including the Board of Administration.
- 3. One copy to the State Master Councilor, State Deputy Master Councilor, State Senior Councilor, State Junior Councilor, State Scribe, and State Treasurer.
 4. One copy to the International Supreme Council.

Section XIII

The State Scribe shaol under the direction of the State Master Councilor and/or the Association, conduct all correspondence of this Association.

Section XIV

The State Scribe shall report in writing to the Association at each Annual Conclave all of his official Acts.

Section XV

The State Treasurer shall make disbursements for this Association with the approval of the Executive Officer. The State Treasurer shall make an itemized report of all transactions in connection with this office at the Annual Conclave.

Article VB State Cabinet

Section I

The members shall be the duly elected Provincial Master Councilors of the several Provinces. This Cabinet will function at the will of the State Master Councilor. The Deputy State Master Councilor shall serve as Chairman.

Section II

This Cabinet shall help coordinate activities, help in theunification of this State. and act in the capacity of a grievance committee if need be.

Article VIB Committees

Section I

The standing committees of this Association shall consist of those named in Article of the Constitution.

Section II

The duties of the Jurisprudence Committee shall be to determine the constitutionality of all motions, resolutions, and proposals presented by the standing committees or from the floor of the Conclave.

Section III

The duty of the Resolutions Committee shall be to bring to the delegates of the members resolutions that will benefit DeMolay in the State of Florida.

Section IV

The duty of the Nominations Committee shall be to review the qualifications of every candidate for an elective office of this State in order to determine if said candidates are constitutionally qualified to hold such offices. At the time of the elections the Nominations Committee shall present to the delegates at Conclave the list of qualified candidates seeking an elective office.

SectionV

The Membership Committee shall study and promote an active program for the acquisition of eligible youth in this Jurisdiction.

Section VI

The duty of the Conduct Committee shall be the only State Committee to supervise the conduct of the DeMolays under the direction of the Chairman of the State Conduct Committee and the State Advisor of Conduct, appointed by the Executive Officer, assembled at any statewide DeMolay activity.

Section VII

The duty of the Credentials Committee shall be to validate the credentials of all delegates to Conclave in accordance with Article III, Section IV of the Constitution. This committee shall be responsible for arranging the seating of said delegates.

Section VIII

The duty of the Public Relations and Publications Committee shall be to promote the image of DeMolay through programs of public interest and to put the name of DeMolay before the general public. It shall also be the duty of this committee to inform and assist member chapters in the Annual DeMolay Week Program. This committee shall oversee any publication of this Association and any related programs.

Section IX

The Ritual Committee shall promote uniformity in the ritual of the Order of DeMolay throughout this Association, and shall recommend to the Association for approval, procedures for the performance of ritualistic matters not specifically set forth in the Ritual of Secret Work of the Order of DeMolay and methods of receiving, introducing, and accommodating those who are entitled recognition in all conclaves, meetings and public ceremonies of the Association.

Section X

The Conclave Committee shall select from those presented to it at least two (2) proposals for the time and place of Annual Conclave, and present said proposals to the Executive Officer's Personal Representative in charge of Conclave.

Section XI

The Athletics Committee shall work with the State Sports Director in acquiring qualified officials for all state athletics competition. They shall also review and submit any proposals to the State Master Councilor.

Section XII

The duty of the Constitutional Revisions Committee shall be to recommend pertinent and necessary revisions to the Constitution and By-Laws.

Section XIII

The State Master Councilor shall announce the names of the Committee Chairmen for the coming year at the close of the last business session of Conclave no later than fifteen (15) days after the close of Conclave. The names of the chairmen shall be published in the current minutes of the Association.

Section XIV

All committees shall consist of at least five (5) members appointed by the State Master Councilor, the first named members being the chairmen.

Section XV

It shall be the duty of each committee chairman to submit to the State Master Councilor a report upon request. It shall also be the duty of each State Committee Chairman to gather suggestions and recommendations from the member chapters and combine them with his own ideas and submit them to the State Master Councilor as a tentative agenda 30 days prior to Conclave.

Section XVI

The final committee reports shall be type written and submitted to the State Scribe no later than the beginning of the last business session at each Conclave.

Section XVII

The State Master Councilor shall have the power to establish additional committees as he deems necessary.

Section XVIII

The Deputy State Master Councilor shall serve as Chairman of the State Membership Committee.

Article VIIB Board of Administration

Section I

The body appointed by the Executive Officer in an advisory capacity for this Association shall be known as the Board of Administration. The Board of Administration shall be composed of Personal Representatives of the Executive Officer and other advisors as the Executive Officer may deem necessary to appoint. All legislative matters to be submitted to the Conclave are subject to review by the Board of Administration. Action of the Board on any matter may be reviewed by the Executive Officer for approval or disapproval.

Article VIIIB Amendments

Section I

These By-Laws can be amended by the same procedure as outlined in Article VIC, Section I, except a simple majority is required for passage, and amendment may be submitted at any time prior to the first business session of Conclave.

GENERAL:

- 1. Every contestant MUST have an Obligation Card and a current or Life Member card. This rule will be certified by the Chapter Advisor at the time of registration.
- 2. All contestants must be members of the Chapter they are representing and cannot have reached their majority.
- 3. Competing teams will submit the names of their members to the person in charge of the Ritual Competition. State Conclave, the Personal Representative of Awards and Ritual; Region Competition, the Regional Coordinator of the particular Region; Province Competition, the Province Governor; or in any of the above, to the person designated by the person in charge of the Ritual Competition.
- 4. NO RITUALS or MONITORS will be permitted in the Chapter room where the contest is held, except those in possession of the judges. All ritual work must be from memory. The use of any aid to the memory devise will DISQUALIFY the team.
- 5. Prompting from any source will subject the team to a 50 point penalty for each prompting. A judge will not prompt under any circumstances.
- 6. Spectators may be permitted if the competing Chapter has no objection but must not in any manner disturb or distract those in competition.
- 7. Contestants waiting on preparation for their scheduled appearance will not create a disturbance or distraction in the area outside the Chapter room.
- 8. Necessary properties will be furnished by a local Chapter, except robes.

- 9. The "Ritual of Secret Work of the Order of peMolay" to be used by the judges will be the TWELFTH EDITION dated "1974" and the "Monitor of public Ceremonies", FOURTH EDITION dated "1974", will be used for the Flower Talk.
- 10. A penalty may be invoked by the panel of judges for tardiness in appearing as scheduled after 15 minute grace period has expired.
- 11. Judges will rate each team according to their own impression without consulting each other except for rule 10.
- 12. Judges MUST NOT divulge the scoring results to any person or persons at any time. Judging score sheets will be submitted to the person in charge of the Ritual Competition, or to the person designated by him to handle the Ritual Competition; as defined in Rule 3.
- 13. No appeals will be accepted on Judge's scoring. Appeals will be heard only on cases involving violation of rules; substantiation to disqualify a competitor. Deadline for appeal will be 24 hours after competition.

INITIATORY DEGREE

- I. A line of 22 officers is recommended, a minimum of 18 will be required for competition.
- II. The Initiatory Degree ONLY will be exemplified. Opening and closing of Chapter will be omitted.
- III. Judging will begin with the rap of the gavel in the East.
- IV. In considering Chapter dress, the use of the type robes recommended by the Supreme Council is not mandatory, neatness and uniformity are the prime consideration.
- V. If music is used, it shall be considered in the

- light of creating atmosphere. It should never interfere or detract from the Ritual.
- VI. Maximum time limit 50 minutes per team.
- VII. A candidate for degrees may be initiated by a team in competition. An active member may be substituted if desired.

DEMOLAY DEGREE

- I. A degree team of 15 members is recommended, a minimum of 12 will be required for competition.

 Non-speaking parts (such as guards) referred to but not limited by the Ritual may be used, as long as the entire cast does not exceed 20 in number.
- II. Only the first section of the DeMolay Degree will be presented. Begin with the Orator's part and conclude with the Lord Constable's last line.
- III. If special effects, such as robes, music, lights and make-up (as permitted by the Ritual) are used to increase the impact, they shall be considered as embellishment to presentation, not to interfere or detract from the Ritual.
- IV. Maximum time limit 30 minutes per team.

FLOWER TALK

- I. A Marshall and Candidate(s) are not required in competition.
- II. A Chapter room setting is not required for delivery of the Flower Talk. An article of furniture symbolic of an Altar will be considered adequate.
- III. Maximum time limit for each competitor 15 minutes. Rule 6 also applies.

ORATORICAL CONTEST

The subject for the oration will be selected by

the Personal Representative of Awards and Ritual, and will be promulgated prior to Provincial Competition.

- II. Each contestant will deliver a typed copy of his oration to the judges prior to competition. This copy to be retained by the State Association. It is understood the permission is granted to publish those orations deemed worthy of recognition.
- III. Subject matter is important, thus the same copy cannot be used by more than one contestant.
- IV. Presentation may be made from memory, use of notes or read.
- V. Material used must be from the contestants own creativeness. However, quotations may be used in moderation.
- VI. Minimum time 5 minutes. Maximum time 8 minutes for each competitor.

FINAL SCORING SYSTEM FOR RITUAL COMPETITION

To achieve the final score that will be equitable to all competitors, the following system has been evolved.

<u>DELIVERY</u>: Contestant receiving the highest grade will be rated with a final score of 100, other contestants will have their grade divided by the highest grade to acquire the final score:

Assuming the grades assigned were 50,65,80, and 42. Highest grade of 80 would equal the score of 100. Grade of 65 would be divided by 80 to get final score.

i.e. $\frac{65}{80}$ = 81.25 and thusly the grade of 50 would result in a score of 62.5 and 42 a score of 52.5

RITUAL: To acquire a final score on the basis of

100 for this area of competition, add all the points that the contestants received and use the result as a divisor. For a quotient, multiply the individual contestant's (team) points by 100 and subtract the result from 100.000

Assuming the contestants received the following point count for errors: 14, 06, 01, 02, and 0, added together = 23.

$$\frac{100 \times 14}{23} = 60.869 \text{ thus } 100.000 - 60.869 = 39.131$$

$$\frac{100 \times 02}{23}$$
 = 8.695 thus 100.000 - 91.305

accordingly 06 = 73.914, 01 = 95.653 and 0 - 100.000.

The final score would be the contestant's combined score for delivery and ritual, the highest combination would determine the winner of the contest.

INTERNATIONAL SWEEPSTAKES AWARD

GENERAL RULES

Each year the International Supreme Council rates the various jurisdictions according to their participation in the ISC programs. The Plaques that are awarded are symbolic of the best all-around jurisdictions in the specified categories.

There are four Sweepstakes awards presented annually with one award for each size category. All jurisdictions are listed in one of four categories, thus each jurisdiction is competing with those jurisdictions more nearly its own size.

The four categories are: small, for up to 500 members; medium, for 501-2000 members; medium large for 2001-3500 members; and large, for over 3500 members. The number of members will be based on the jurisdictional total as of the end of the DeMolay year on December 31st.

There is only one international championship in each competition (if there are no ties), but a weighted grading system is utilized in most of the competitions which gives equal weight to both percentage of performance as well as quantity of effort.

Sweepstakes points will be awarded for points credited in the 10 International competitions, consisting of Jurisdictional Membership, Chapter Membership, Blue Honor Key, Representative DeMolay Awards, PMC Meritorious Service Award, Leadership Correspondence Course, ISC Reports, International DeMolay Week, Chapter Publications and New Chapters.

The 10 competitions are divided into three areas of importance, with points for the first through the tenth place as indicated.

Area I (100 to 10 points)

Jurisdictional Membership
Blue Honor Key
Representative DeMolay
PMC Meritorious Service Award
Leadership Correspondence Course
ISC Reports

Area II (50 to 5 points)

DeMolay Week Chapter Membership New Chapters

Area III (30 to 3 points)

Chapter Publications

The weighted system of judging is used for any competition where total number is involved, which involves all competition except Chapter Membership, DeMolay Week, ISC Reports and Chapter Publications.

This weighted system of judging is used for any competition and quantity effort and the lowest resulting score of all the jurisdictions occupies first place in the contest rankings for the period being figured. A perfect score for a final ranking is 2, which means a jurisdiction scored first in both the percentage and quantitative categories.

The International Supreme Council publishes several pamphlets that may be of assistance in helping your chapter and jurisdictions in winning the Sweepstakes Award.

Each Chapter taking an active part in all ISC programs is the key to success in contributing toward its jurisdiction winning the Sweepstakes Award.

STATE SWEETHEART RULES
