

At 8:37pm, the State Master Councilor delivered the State of the Order Address.

At 8:55pm, the State Master Councilor declared the Florida DeMolay Association in a state of recess, for the purpose of opening the Association ritualistically.

The Florida DeMolay Association was opened ritualistically on the Initiatory Degree at 9:05pm, and on the DeMolay Degree at 9:10pm.

The State Master Councilor appointed Brother Jacob Meister of Crawford Chapter to serve as the State Junior Steward for the remainder of Conclave.

The State Master Councilor placed the Florida DeMolay Association in a state of recess at 9:30pm.

# Minutes of the Business Session - - Tuesday, July 27, 1999

The State Master Councilor, Brother Chris Cook, rapped the gavel, and declared the Florida DeMolay Association out of a state of recess at 9:08pm.

Brother Joseph C. Earnhardt, Jr, State Credentials Committee Chairman was introduced, and took role of the Delegates present. The role call yielded 60 total Delegate Votes, with 31 needed for a simple majority vote, and 40 votes being 2/3 majority.

Brother Earnhardt then continued, and read the following report of the Credentials Committee:

# STATE CREDENTIALS COMMITTEE REPORT

To the delegates of the 66th Annual Conclave:

This is the report of the Credentials Committee, as set forth in Section 5.05 of the Statutes.

This year, this committee continued the use of the Delegate registration cards and found

them very useful. We would recommend that they continue to be used for the foreseeable future.

The following information regarding the number of Delegates for this report is as follows:

There are nineteen (19) Chapters registered with this Committee, with a total of 51 Delegates, and a total of 57 Delegate Votes. In addition, the State Senior Councilor, State Junior Councilor and State Scribe/Treasurer are entitled to one vote each, raising the total to 60 Delegate Votes.

Assuming no changes in the number of registered Delegates occur, the quorum to conduct business will be 31 votes, a simple majority will be 31 votes, and a two-thirds majority will be 40 votes.

A list of Delegates exists in the records of the State Credentials Committee Chairman.

Recommendation #1: This Committee recommends that next year's Committee continue to use the Delegate registration cards.

Recommendation #2: This Committee recommends the adoption of the attached form, so as ensure that Credentials are in order on time, and done properly. It will be sent out with Conclave registration, and we believe that it will make Conclave easier on everyone.

Pursuant to Section 5.01 of the Statutes of this Association, the recommendations of this report are both physically and fiscally feasible.

Brother Earnhardt then stated that copies of the aforementioned form had not been made for disbursement, but the basic idea of the form was to pre-register the Chapter Delegates with the Conclave registration, as to eliminate confusion at the beginning of Conclave.

The State Master Councilor then opened the floor for discussion.

Brother Jody Meguiar, Paul Revere Chapter, made a motion to accept the report as read. The motion was seconded, and passed.

The State Master Councilor then called for the State Scribe/Treasurer, Brother Chris Gatewood, to read the agenda for the rest of the business session. The agenda read as follows:

- 1. Pass the Credentials Committee Report (had already been done)
- 2. Pass the Nominations Committee Report
- General Business
- Nominations Speeches and Acceptance Speeches

Brother Jacob Meister, Crawford Chapter, made a motion to pass the agenda as read. The motion was seconded. The State Master Councilor called for discussion, and Brother Herb Rodgers, Jupiter-Teguesta Chapter and State Nominations Committee

Chairman, recommended to amend the agenda to exclude the State Nominations Committee report, since the report had not yet been completed. Brother Nishant Koleskar, Gainesville Chapter, made such a motion, to amend the agenda as per Brother Rodgers' recommendation, and pass the amended agenda. The motion to amend the agenda, and to pass the agenda as amended was seconded and passed.

The State Master Councilor then called for general business. He brought up the issue of general caucuses, where the candidates for State Office are asked general questions from the Conclave population, on their views about certain aspects of our State Association. The State Master Councilor stated that in the past, the State Sweetheart was allowed to ask a question of the candidates, and then anybody could ask the remainder of the questions. But, he reported that someone had recommended that only active DeMolays should be allowed to ask the questions at general caucuses.

Brother Ralph Dietzman, State Junior Councilor, said that active DeMolays, as well as female guests, and the general Conclave population, should be able to ask the questions of the candidates, but would not make such a motion.

Brother Jody Meguiar, Paul Revere Chapter, stated that since DeMolays have their own caucuses for the candidates, the Area caucuses, it is only proper that the ladies and guests be allowed to participate in the caucuses. He then made a motion to allow the ladies, guests, and general Conclave population to be allowed to take a part in the general caucuses. The motion was seconded and passed.

The State Master Councilor then declared the Florida DeMolay Association open for Nominations, since there was no further general business.

The State Master Councilor called for Brother Herb Rodgers, State Nominations Committee Chairman, to read the letters of intent that he had received from the various candidates.

Brother Herb Rodgers, State Nominations Committee Chairman, then read the following letter of intent, from Brother Corey Allshouse, who was running for the honorable office of State Master Councilor.

### To My DeMolay Brothers:

This is my letter of intent to run for the honorable office of State Master Councilor of the Florida DeMolay Association. I declare that I have read and understand the Statutes, Charter, and Constitution of our Association. I confirm on my honor that I am qualified to hold this prestigious office pursuant to chapter 3, section 3.02(a) of the statutes declaring that I am eligible, due to the fact that:

- ➤ I have been a member of J. Edwin Larson Chapter since May of 1993.
- ➤ I have been a member of Crawford Chapter since the beginning of its existence in May of 1997, and am a member in good standing of both.
- > I am a Past Master Councilor of both Chapters.
- > I am a recipient of the Representative DeMolay award.
- A holder of the Lamp of Knowledge

- > A resident of the state of Florida, and have been since 1980
- > I am a high school graduate of Wakulla High School in Crawfordville, Florida.

If elected State Master Councilor, I plan to travel to each member Chapter of our Association, not only to promote our Order, but to prove to my Brothers that our State Officers do care about their needs and well being. I plan to emphasize the Masonic heritage, and the need for a continuing relationship between us and our Masonic family.

Thank you for your time and for considering me for this honorable office.

After Brother Rodgers had declared that the candidate was qualified for the office of State Master Councilor, and that the letter of intent was in correct form, the State Master Councilor recognized Brother Joe Earnhardt, Past State Master Councilor, who gave the following nomination speech for Brother Allshouse:

My Brothers, I stand before you this evening to speak to you on a truly important subject. know you haven't had to listen to me for quite a while, and not a one of you missed it. I didn't want to stand up here this evening, and ruin your week by talking, and keeping you away from the things you enjoy. But what I have to talk to you about is too important not to say something. As we come together this week, not only to have a good time, but also to decide the future of the Order of DeMolay in Florida. I know you hear people stand up here and say that every year, but this time I am the one saying it, and I have never been more serious in my life. Look around you. Not at your Brothers who are here, but the ones who are not. Every year for the better part of the last decade, our Conclaves have been getting smaller and smaller. But what I want to know from you is, do you have any idea why? Have you ever put any thought into why it is that things have been getting so much worse for so very long? I know that every last one of you has an answer, and the important thing is that every last one of you is right. There isn't one problem, but a dozen. We have a chance to take one giant leap towards fixing those problems, however. Except we are forgetting our state's glory. A step towards being greater than we ever were. We have a chance to choose Brother Corey Allshouse to be our next State Master Councilor. This is an opportunity we cannot overlook, because believe me, a leader of his caliber comes along once in a lifetime. Corey is a truly great man. He's the kind of DeMolay that I wish I could be. He's the kind of DeMolay that I believe Dad Land wanted all of us to be. I say this because I know Corey, because I know him well enough to call him one of my closest friends, well enough to truly call him a Brother. I have watched him over the years work tirelessly for our Order, watched him make sacrifices for his DeMolay Brothers, watched him live his entire life as a DeMolay. Think about that. A man who lives his entire life by the precepts of our Order, who has let his vows dictate every conscious action he has ever made. And that is what we need. Someone who will not give up on us, no matter how hard it gets, and believe me, it is going to get a lot harder before it gets easier. And if anyone would know, it's me. This is a job I wouldn't wish upon my worst enemy, but it's also one I wouldn't trust with anyone but my best friend. So it with all of this in mind, and with more honor than I have felt in my short life, that I nominate Brother Corey Alan Allshouse for the office of State Master Councilor.

The State Master Councilor called for Brother Corey Allshouse's acceptance. Brother Allshouse thanked Brother Earnhardt for the spectacular nomination, and then gave the following acceptance speech:

My Brothers, when I joined DeMolay back in 1993, I didn't join a fraternity, I didn't join a social club. I banded together with a group of young men, striving to prove their devotion to each other. I joined a brotherhood. No, I became part of a brotherhood. DeMolay isn't just a group that you join. It's a world you become a part of, a wave that washed over you and takes you in. It's a puzzle, and we are the pieces. This is what impressed me about the Order when I joined. There are so many facets to DeMolay, and there is one for each of us. That may not be why we all joined, but that is why we all stick with it. We have each found something truly special in the Order of DeMolay. A secret that we need to share. If we don't, then this Order will stagnate and die. And that is something that none of us can afford. We have all given too much, sacrificed too much, given too much of ourselves, to let all this disappear. Most people would believe that what we are all talking about is a dream, that what I am talking about is a dream. But I believe that it is a vision. A vision of what we can make of this Order, and of this world, our world. This is a vision that we cannot allow to fade. We all have far too much to offer, and if they are right, if this is a dream, then personally, I hope that it is one that I never wake up from. With that, I will gladly and with deep humility, accept my nomination for the honorable office of State Master Councilor.

The State Master Councilor then closed nominations for the office of State Senior Councilor, and ordered the reading of the letters of intent for the office of State Senior Councilor. Brother Herb Rodgers, State Nominations Committee Chairman, then read the following letter of intent, from Brother Jason Miller, who was running for the honorable office of State Senior Councilor.

To my DeMolay Brothers,

I am writing this letter to inform you of my intent to run for the honorable office of State Senior Councilor. I certify that I am a Past Master Councilor of Mid-Pinellas Chapter, and I hope to receive my RD and LCC in the near future. I have served this Association in numerous positions throughout my DeMolay career, and I currently hold the office of SMCR for Area 5, and Athletics Committee Chairman. I attended the Leadership Training Conference 2 in 1998, where I where I gained the solemn understanding of the duties and responsibilities of leadership. After Brother Rodgers had deemed Brother Miller qualified for the office of State Senior Councilor, since the Board of Administration had waived the eligibility requirements for 60 days to entitle members of the Association to run, he declared that the letter of intent was in correct form. The State Master Councilor recognized Brother Frank McGrath, Arlington Chapter, who gave the following nomination speech for Brother Miller:

Brother Herb Rodgers, State Nominations Committee Chairman, then read the following letter of intent, from himself, Brother Herb Rodgers, who was running for the honorable office of State Senior Councilor.

After Brother Rodgers had declared that he was also qualified for the office of State Senior Councilor, he declared that the letter of intent was in correct form, and the State Master Councilor recognized Brother Chris McKenney, Jupiter-Tequesta Chapter, who gave the following nomination speech for Brother Rodgers:

My Brothers, tomorrow night, you will make a serious decision that will affect the path of this Association. Decisions that will affect the Order of DeMolay in this state, not only for the year to follow, but also for many years to come. It is not a light responsibility, and one

that I trust will be taken seriously. We trust our State Officers will live up to their promises and exceed our expectations. We need a State Line that will shift our way of thinking, and focus our efforts for the benefit of this Order. We need State Officers who have admirably fulfilled their duties in the past. Past performances, not empty promises, are the only gauge we have to predict their likely performance as a future State Officer. Let's see what Herb Rodgers has done for this Order in the past. Over the past several years, Herb has worked hard for the continued success of Jupiter-Tequesta Chapter, and the results of his work are obvious in the brotherhood, and turnout of his Chapter at this Conclave. He is an experienced leader, but he can make DeMolay fun and rewarding to those who follow his leadership. As an example, he is the personal engineer of the famous Jupiter dance, often imitated, but never matched. The State Master Councilor called for Brother Rodgers' acceptance. Brother Rodgers then gave the following acceptance speech:

After Brother Rodgers had declared that Brother Reeder was qualified for the office of State Senior Councilor, he declared that the letter of intent was in correct form, and the State Master Councilor recognized Brother Lee White, Sem-I-No Chapter, who gave the following nomination speech for Brother Reeder:

You know John Reeder, as an active DeMolay. I know John Reeder as a Brother. He has been Master Councilor of Sem-I-No Chapter for two terms. And I have had the honor to serve under him as his Senior Councilor. John Reeder, along with Sem-I-No Chapter, has succeeded in bringing our Chapter as of three years ago at Conclave to a well recognized Chapter, which became known as the "Dash Dash" Chapter. By working together, we have received the RD Trophy, and earned five first-place awards. We initiated four Brother Knights, three Squires, and opened our own Encampment: Excalibur. John has held the offices of Page Commander, Squire Commander, and also acting EKC. But, in order to further his DeMolay dream, he has resigned as Page Commander to run for the honorable office of State Senior Councilor, to help raise the awareness of DeMolay, and help all of our younger Brothers. After Brother Rodgers had declared that Brother Doyal was qualified for the office of State Senior Councilor, he declared that the letter of intent was in correct form, and the State Master Councilor recognized Brother Jody Meguiar, Paul Revere Chapter, who gave the following nomination speech for Brother Doyal:

My Brothers, I am here to nominate my friend, Grant Doyal, for the office of State Senior Councilor of the Florida DeMolay Association. Now then, when Grand decided to run for this office, he and I talked about who would nominate him. We went over a lot of different people from a lot of different Chapters, but we then realized something very important. Not too many people can give you a better picture of Grant than I can. Russell Chapter, who gave the following nomination speech for Brother Ferenchik:

My Brother DeMolays, I have the honor of nominating Brother Tim Ferenchik, this evening, for the office of State Junior Councilor. State Junior Councilor is an office of service, an office of little praise, but a great deal of hard work. My Brothers, it gives me great pleasure to stand here tonight to say a few kind words in nomination for my kid brother, Doug Allshouse, for the honorable office of State Junior Councilor. I don't know how long all of you all have been around, but Doug has been around for as long as I have been around, and he's been at every Conclave since 1993. He's trodded behind all of the wonderful Sweethearts of the past, and he's had a good time. Doug was initiated in 1993 into J. Edwin Larson Chapter, oh, actually, he was initiated in 1997, and served as Master Councilor for a year and a half, for a total of three terms. He was elected at the age of fourteen. Through his hard work and never-ending commitment to Larson, he truly held the Chapter together during a time of need. The truth is, Doug did all of this without much help from me. It seemed like I was always trying to go out and be everybody else's brother in DeMolay, and I seem to forget about Doug. For that, Doug, you should be commended. We need a core of Officers with experience and who know how to act for the good of the Order. As stated in my letter of intent, I am a PMC of my Chapter. Brother Herb Rodgers, State Nominations Committee Chairman, then read the following letter of intent, from Brother Scott Chicco, who was running for the honorable office of State Junior Councilor.

I intend on running for the office of State Junior Councilor. I have all of the necessary qualifications for this office. I have read and am familiar with the Statutes, Constitution and Charter of the Florida State DeMolay Association.

Scott Chicco

After Brother Rodgers had declared that Brother Chicco was qualified for the office of State Junior Councilor, he declared that the letter of intent was in correct form, and the State Master Councilor recognized Brother Dan Resto, St. Petersburg Chapter, who gave the following nomination speech for Brother Chicco:

Scott decided to run about a half an hour ago, not leaving me with much time to write a speech. But, the only reason why Scott decided to run was because he saw an opportunity to help the Order of DeMolay. I remember one time when I was going through some hard times, and I wasn't very active in DeMolay, and I probably hadn't talked to Scott in over two months, but I called him at about 3 o'clock in the morning to talk to him, and he gave me no trouble. He was there for me when I needed him, and I think that's the kind of guy we need in State Office.

The State Master Councilor called for Brother Chicco's acceptance. Brother Chicco then gave the following acceptance speech:

I do accept. First of all, I would like to thank Dan, it was very last minute. I would like to tell you about myself. I was initiated in St Petersburg Chapter on February 4, 1996. I moved up through the appointed offices, into the line, and to Master Councilor, and I held that office for two consecutive terms, during which I earned my Past Master Councilor's Meritorious Service Award. Since I was initiated into DeMolay, I have been very active, going to as much as I can, and it has become a really important part of my life. The best times of my life have been with my Brothers. I've also gone through some really bad times, and my Brothers , Advisors, and everyone involved in DeMolay has helped me so much. I would like to have an opportunity to give something back to the Order, and I think that this would be a perfect opportunity to do it. And also, ever since I came to my first Conclave a few years back, I have always wanted to move up in the State Line. Therefore, I accept the nomination.

The State Master Councilor declared nominations for the office of State Junior Councilor closed. He asked Brother Herb Rodgers to read the list of the candidates for the honorable office of State Senior Councilor. The list read as follows:

- Brother Tim Ferenchik, Albert J. Russell Chapter
- Brother Douglas Allshouse, J. Edwin Larson Chapter
- Brother Scott Chicco, St. Petersburg Chapter

The State Master Councilor then declared all nominations closed.

The State Master Councilor then opened the floor to general caucuses. He stated that he was going to limit the responses from the individual candidates to three minutes,

allowing the State Sweetheart to ask the first question as a blanket question to all candidates. After their responses to the State Sweetheart's question, the Brothers and guests would line up at the microphones to ask their questions, in a "first come, first served" fashion. Such questions can be asked to all candidates, one candidate, or the candidates for a specific office. Each candidate will answer the State Sweetheart's question, and then a total of three questions afterwards.

The State Sweetheart, Miss Kelly Lynn Hill, asked the following of all candidates: "As an elected State Officer, how will you support the State Sweetheart, and the past State Sweetheart's program?"

Brother John Reeder, candidate for State Senior Councilor, stated: "As an State elected Officer, I would support the State Sweetheart and the State Sweetheart program. I would work with her, and do whatever she asks to bring her help with Chapter Sweethearts. I would encourage members of the Chapters to help their Sweetheart in any way necessary that it needs to be done."

Brother Mike Miller, candidate for State Senior Councilor, stated: "I would help the State Sweetheart program come to DeMolays. You know, Kelly, you were our Chapter Sweetheart, and every time she came to a dance, she was always there to take the people who were shy and sitting in the corner, to bring them out and make them stronger men. So, I think that we should take our Sweethearts, and put them on a pedistal. So, to help the State Sweetheart, I will do everything that she asks, and for everything that she needs, she doesn't need to hesitate to call. Thank you."

Brother Grant Doyal, candidate for State Senior Councilor, stated: "Helping the State Sweetheart and her fund raisers, I would be willing to travel along with the State Sweetheart and the Chapter Mom anywhere in the State of Florida that she would like to travel to. I would help to give suggestions for ideas for fund raisers to help the Sweethearts out, and the State Sweetheart out."

Brother Tim Ferenchik, candidate for State Junior Councilor, stated: "Well, I would say that I would help out any Sweetheart who ever needed any help with any activities, fund raisers, and would be glad to help them out. Thank you."

Brother "Stubby" Campbell, candidate for State Senior Councilor, stated: "How would I help the State Sweetheart? Good question, Kelly. Well, to tell you the truth, from talking to Kelly, I can tell that State Sweetheart is not that honorable of a job. I mean, she helps us out a lot, I've talked to her, and she has to lug around that forty-pound robe, or whatever. They are basically here to help us, and we help them as much as possible, probably not as much as we should, but the only thing I can say is to help the State Sweetheart would be to plan things with her. Communication is the key. Talk to her, travel with her, do whatever is needed to help the State, and help the Sweetheart plan."

Brother Jason Miller, candidate for State Senior Councilor, stated: "Ok, how would I help the Sweetheart? Let me start out with an anecdote. When I first was initiated into DeMolay, one of the main things that caught my attention, being that young and everything, was the chance to meet girls at social functions. And, of course, like most young men my age, my eyes lit up, and I was all for it. Well, then, soon after I was initiated, I really caught the idea of what DeMolay was, and I really took that entire world of DeMolay into myself, and really became a DeMolay. And then, as I looked and thought about it, I noticed that the Sweethearts and the females who participated with us, have that same feeling. They, too, were in the world of DeMolay. They were in our Order, maybe not as members, but every much a part of what we do, because of their support. So, I guess really the question that should have been asked is 'What wouldn't I do to support the Sweethearts?' And to that, I really couldn't give an answer, because there is not a thing that I wouldn't do. Thank you."

Brother Doug Allshouse, candidate for State Junior Councilor, stated: "How would I help the State Sweetheart? Well, the State Sweetheart is a very important part of the Order. They are basically our ambassadors to new members, and ISC and everything else. But anyway, to help the State Sweetheart, I would even sit down and plan her term for her. They have a service project, and I would travel to Chapters to make sure that they know about it and that they participate. Also, since I have been wandering around with Corey at Conclaves, the number of Chapter Sweethearts has gone down. I fought to get Chapter Sweethearts reinstated into our Chapter, and I would help you fight to get yours, because we had Advisors who did not approve of it. So, I would make sure that each Chapter would try to get a Chapter Sweetheart. They really, really, help out our Order."

Brother Herb Rodgers, candidate for State Senior Councilor, stated: "Well, I figure I could make up a dance for her or something. Maybe they'd beat us in the talent show, then. Oops, I'm sorry. (laughter) Since I have to say that Jupiter Chapter is also one of the ones without a Sweetheart, I would say, as many other Brothers have that Sweethearts are one of the keys to membership. Obviously not the only one, and not only does the Sweetheart come, if you have a dance or a function, not only does the Sweetheart come, but she can bring Job's Daughters and Rainbows, and that is a doorway into other functions that you can get into. It brings up more opportunities for fund raisers, more opportunities to bring in new members, and more opportunities to do basically everything that we do in DeMolay, except the rituals. So, as everyone else has said, I would do darn near anything to help the State Sweetheart, or any other Sweetheart. Thank you very much."

Brother Scott Chicco, candidate for State Junior Councilor, stated: "Well, I think that the whole Sweetheart program is an important part of DeMolay. Not just the State Sweetheart, but all the Sweethearts. And so, I'd be willing to help the State Sweetheart, or any Sweetheart with anything she needed. I'd do whatever I could, no matter what it is."

Brother Corey Allshouse, candidate for State Master Councilor, stated: "Ok, Chris, I'm not going to pick on you too much here, but everything you did this year, I would do exactly the opposite. Like everybody said, the Chapter Sweetheart program is very important. I agree with them, I agree whole-heartedly with them. The State Sweetheart, traditionally, always has great ideas of things to do, and a lot of times, it almost seems like she's not really in the picture. As State Master Councilor, I would listen to the next State Sweetheart of our Association, and try whole-heartedly to implement anything that she thinks would be a benefit to our Order, and to help us out. Thank you."

The State Master Councilor then recognized Brother Ralph Dietzman, State Junior Councilor, who asked the following question to all the candidates: "Very few of us in this room have this unique perspective, since very few of us have worn these collars, and so what I want to know from each and every one of you guys is what does this collar mean to you?"

Brother Corey Allshouse, candidate for State Master Councilor, stated: "Brother Dietzman, that is a very good question. I'm not going to stand up here and say, and I don't think that anyone who is elected to a State elected Office can say, that wearing the collar around and having a title is not why they want this office. Because no matter how much you love DeMolay, it is a small part of being an elected officer, to have the collar. Being State Senior Councilor this year has opened an opportunity to me to be able to expand to all of my Brothers in the state something that I have wanted to do for a long time. And it really means the world to me, and I don't know how I could have done that without being an elected officer. It really facilitates everything that I have ever wanted to do for DeMolay. And all of my Brothers who know me real close will know that. But even without this collar, I would still do all that I can do for our Order. And that is what this collar means to me."

Brother Scott Chicco, candidate for State Junior Councilor, stated: "Well, like Corey said, I don't think that any of us can say that the collar and the office means nothing, and I will be honest, that has a little something to do with it, but not very much. I have been working for the Order hard ever since I've been in. I love it. I give everything I have to it. So, whether I have the collar or not, since I haven't had a collar up till now, and if I have the collar, I will keep working just as hard, if not harder. And if I don't have it. I will still be working just as hard."

Brother Herb Rodgers, candidate for State Senior Councilor, stated: "The collar, to me, above all else, means that you guys thought that me, or whoever else is running, was the best guy for the job. And that is what is important. It doesn't mean that the one in the collar has the most awards, or the most titles, or has served as Master Councilor the longest, or has even been in the Order the longest. It means that that Brother is the guy who loves DeMolay and who you guys believe will give the most back to it; who will give the most service to you. And that's what the collar means to me."

Brother Doug Allshouse, candidate for State Junior Councilor, stated: "Like Brother Rodgers just said, it is a sign of democracy. It proves that you are the ones who pick that person wearing the collar. And it is basically voted on by you, it is your decision."

Brother Jason Miller, candidate for State Senior Councilor, stated: "Well, thinking about the collar, certain phrases come to mind. One is the 'weight of responsibility', which in literal terms you bear that upon your shoulder when you are elected. You bear the weight of the responsibility of the entire state, that you will succeed. It is also the privilege and the pride and the honor of achievement, that you've gone to the point where you've pushed yourself to the limit, so that you could still keep pushing and do a better good. But most of all, I guess that the collar is a symbol of trust. A trust that you Brothers have reposed in those elected, a trust in our dedication, a trust in our ability. And with that, there is no material value to it, but the trust is the value in itself. So, the collar is the symbol of everything that makes a DeMolay what they are and it shows as proof that they are willing to push that even farther, to make the Order stronger."

Brother Jason Campbell, candidate for State Senior Councilor, stated: "A collar is a material thing. I have never had a collar about my neck, I've never worn one. I've worked as hard as I can for DeMolay, and I plan to work as hard as I can still. The collar, basically, to me, is a sign of honor and trust. The honor is the fact that your Brothers believe in you, the trust is the fact that they put the weight of the state with you. Therefore, basically, to me the collar is a sign of honor and trust."

Brother Tim Ferenchik, candidate for State Junior Councilor, stated: "What the collar means to means to that whoever wears the collar needs to show the leadership to the DeMolays to lead them around, and help them out as best they can."

Brother Grant Doyal, candidate for State Senior Councilor, stated that: "With or without the collar, will still put 110% into the Order, and get 110% out of the Order."

Brother Mike Miller, candidate for State Senior Councilor, stated: "What the collar means to me, is that I have the opportunity to lead this Order into the next millennium, and that is an opportunity I don't want to pass up. And now that I have been given this opportunity, by the BOA to lead this Order into the next millennium, that's what this collar means to me, the chance to lead this Order into the next millennium. Thank you!"

Brother John Reeder, candidate for State Senior Councilor, stated: "I feel that the collar is a symbol of the trust reposed in the person wearing it, that they are capable of leading the Order in the best way they possibly could."

The State Master Councilor then recognized Brother Brian Dobson, South Miami Chapter, who asked the following question to the candidates for State Master Councilor and State Junior Councilor: "If you were a Street Sign, what would you be and why?"

Brother Corey Allshouse, candidate for State Master Councilor, stated: "In the words of Brother Joe Earnhardt, I would be 'Slippery When Wet'. Why? Because I'm very smooth."

Brother Tim Ferenchik, candidate for State Junior Councilor, stated: "I would have to say 'Caution', because if you've ever seen me drive, you'd know why."

Brother Doug Allshouse, candidate for State Junior Councilor, stated: "I think I would be a speed limit sign, 75 miles per hour, because that's how fast I talk when I get going on a subject I'm really good on."

Brother Scott Chicco, candidate for State Junior Councilor, stated: "How about a 'One Way' street sign, because I don't like anything coming from behind."

The following questions were then asked, for the remainder of the general caucus. The responses were lengthy, and are therefore not included in these Proceedings, for the essence of brevity, and also due to the fact that the audio tapes of this Delegate session was not long enough to contain all of the responses.

The State Master Councilor then recognized Brother Jacob Meister, Crawford Chapter, who asked the following question to the candidates for State Senior Councilor: "As you all know, membership and participation has gone down. My question is, what are you all planning to do to promote DeMolay?"

The State Master Councilor then recognized Brother Chris McKenney, Past State Scribe/Treasurer, who asked the following question to the candidates for State Senior and Junior Councilor: "My Brothers, as you know, the Chapters are the foundation of the State Association. I would like to know what you have done in the past year for your Chapter, and what you've contributed to its current state of success."

The Stare Master Councilor then recognized Miss Danielle Higginbotham, Past State Sweetheart, who asked the following question to the candidate for State Master Councilor: "What do you intend to do to improve relations between DeMolay and the other Masonic Youth organizations?"

The State Master Councilor then closed General Caucuses, at 10:45 pm, and instructed the candidates to approach the microphone and introduce themselves by name and sought office.

The State Master Councilor placed the Florida DeMolay Association in a state of recess, at 10:47 pm..

Minutes of the Business Session - - Wednesday, July 28, 1999

The State Master Councilor, Brother Chris Cook, rapped the gavel, and declared the Florida DeMolay Association out of a state of recess at 8:05 pm.

The State Master Councilor read aloud the evening's agenda, and called for a vote to accept the agenda. The motion was made by Brother Lee White, Sem-I-No Chapter, and seconded, and passed.

Brother Joe Earnhardt, Jr, State Credentials Committee Chairman, called the roles of Delegates present. The Delegate role yielded a total count of 51 Delegates, with a simple majority being 26 Delegate votes, and a 2/3 majority being 31.

Brother Jason Miller, State Athletics Committee Chairman, was introduced, and read the following Committee Report:

# STATE ATHLETICS COMMITTEE REPORT

To the Delegates of the 66th Annual Conclave:

This is the report of the Athletics Committee as set forth in Section 5.08 of the Florida State DeMolay Statutes. This committee is comprised of Brother Corey Allshouse, Brother Kristoffer Hendricks, Brother Jason Sinnott, and Brother Alan Warkentine. Brother State Master Councilor Christopher Crook is member *ex officio*. This committee was chaired by Brother Jason Miller.

This committee met at the 65th annual Conclave, all members listed above were in attendance. This committee met at Mini Conclave, all members were in attendance. This committee met in brevity for discussing progress at the Old South Tournament in New Orleans, LA. Brother Allshouse, Brother Cook, Brother Miller, and Brother Warkentine were in attendance. This committee met at the State Master Councilor's Banquet and Sweetheart's Ball. Brother Allshouse, Brother Cook, Brother Miller, and Brother Sinnott were in attendance.

The Committee reviewed the recommendations of the previous Committee and they were as follows:

Last year's recommendation #1: The Members of this committee were to look into the possibility of allowing area teams to compete in sports. Since the time of this recommendation, we have broadened it to include Sweethearts, female guests, mothers and advisors. We have implemented this recommendation by holding a mixed miniature golf competition at Mini Conclave. We have discussed area competitions and are still going over details. Such details include limiting participation on a team exclusively to area members and allowing guests and advisors to participate in certain competitions.

Last year's recommendation #2: The Members of this committee were to look into the possibility of paintball as an event at Mini Conclave. Our survey at last Mini Conclave's rap session displayed a lack of interest in paintball, yet a strong interest in flag football. It has been this committee's primary task to provide information on implementing flag football as an event at a future Conclave/Mini Conclave. FHSAA rules and guidelines governing flag football can be obtained through the public school system. A final budget must still be drawn up, though the track/field venues will provide the facilities and the equipment costs should be minimal. This even will be offered next year at the 67th Annual Conclave.

Last year's recommendation #3: The Members of this committee were to continue to explore options that would alleviate the conflicts between Ritual and Sports competitions. At the 66th Annual Conclave's planning session, held at the 1999 Mini Conclave, a new format was proposed suggesting that Sports competitions be held during the mornings, and Ritual competitions be held during the afternoons and evenings throughout Conclave. This suggestion was made to substitute for the previous format, which left multi-level competitions prone to interfere with Ritual competitions. This new format will take effect at the 66th Annual Conclave.

This year's Committee makes the following recommendations:

Recommendation #1: The Members of this committee recommend that we finalize the details regarding area competitions as well as advisor and guest participation. In the opinion of the Chair, due to the recent lack of participation in softball, two-man and sixman volleyball and team track, allowing quests, advisors, Sweethearts, mothers and members of different Chapters and areas to participate in team sports will stimulate activity in team sports.

Recommendation #2: The Members of this committee recommend that we continue the Mixed Miniature Golf competition at Mini Conclave.

Recommendation #3: The Members of this committee recommend that we look into the possibility of holding a "State Sports Weekend" in the spring/fall. A separate weekend for sports could relieve further scheduling conflicts at Conclave/Mini Conclave.

This is the report of the State Constitutional Revisions Committee, as set forth in Section 5.09 of the Statutes of this Association.

Whereas the Chairman of the Constitutional Revisions Committee appointed at Conclave, Brother Chris Anderson, could not fulfill his duties, he relinquished his position, and Brother Meguiar was appointed by the State Master Councilor on January 9<sup>th</sup>, 1999.

The members of this Committee met on the evening of January 15th, 1999, in Daytona Beach, Florida, and discussed possible changes to the Constitution and Statutes of this Association. Brother Meguiar distributed copies of the Proceedings of the 1998 summer Conclave, so that all Committee members could have a voice in the discussion. He advised the Committee members to review the said Constitution and Statutes and report any procedural, grammatical, or structural change recommendations at the next meeting of the Committee.

The Committee met again on June 19th, 1999 in Fort Walton Beach, Florida. Brothers Meguiar, Gatewood, and Allshouse were in attendance, as was Dad Zack H. Enos, Committee Advisor. The members of the Committee again reviewed the Constitution and Statutes of this Association, and found several cosmetic changes which needed to be made. Since the deadline had not passed for recommendations from members of Florida DeMolay, we could not make the final recommendations for next year's Committee. The recommended changes were listed for further discussion, to be held when the further recommendations may have been received. There were no pending recommendations from last year's Constitutional Revisions Committee.

The Committee met again in Lakeland, Florida on Friday, July 2nd, 1999, and Brothers Meguiar, Allshouse, Chicco and Cuthbertson were in attendance. Since the deadline had already past, and no further recommendations had been made by the general membership of Florida DeMolay, we felt the need to proceed with the listing of our recommendations for next year's Committee.

The Committee had its final meeting on July 26th, 1999, in Tampa, Florida at the 66th Annual Summer Conclave. The members of this Committee were informed as to the recommendations being made, and read a copy of the report, and since none of them had any problem with the recommendations, the report was passed by the members present.

The following recommendations are yielded to the 1999-2000 Constitutional Revisions Committee: (the recommended additions are underlined in the report)

Recommendation #1: Amend Article IV, Section 3(b) of the Constitution to read as follows: "The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration, as well as a Past State Scribe/Treasurer, also satisfactory to the Board of Administration who can offer guidance and assistance to the current State Scribe/Treasurer in the execution of the tasks of his office. The State Scribe/Treasurer shall obtain three (3) or more bids for the cost of printing the Conclave proceedings before the registration of said Conclave."

Recommendation #2: Delete Article V, Section 7(b) of the Constitution, which reads "All candidates for the office of State Parliamentarian must include the following statement: 'I have read and am familiar with ROBERT'S RULES OF ORDER'". This section is no longer necessary in our Constitution, since the State Parliamentarian is not an elected office, and the candidates need not submit a letter of intent.

The remaining recommendations are presented to the Delegation for immediate implementation, upon the passage of this report:

Recommendation #1: Amend Section 3.01 of the State Statutes, deleting the section from the word "prior" through the word "letters," so that the Statute shall read as follows: "Any qualified DeMolay who desires to run for an Elective Office of this Association shall send a Letter of Intent to the Executive Officer, the State Master Councilor and the Chairman of the Nominating Committee by the deadline for Conclave registration. The Letter of Intent will be read aloud before the DeMolay Delegation by the Nominations Committee Chairman prior to elections." This change is recommended so as to give the Nominations Committee Chairman proper time to review a candidate's qualifications, and to notify the said candidate, as stated in Section 5.03.

Recommendation #2: Since Section 4.09(c) of the Statutes is identical to Article IV Section 3(b) of the Constitution, the Committee recommends that Section 4.09(c) either be deleted, as to avoid redundancy, or amended as stated in Recommendation #1.

Recommendation #3: In conjunction with the recommendation of the 1997-98 Executive Committee's report, the 1999-2000 Constitutional Revisions Committee should amend Section 5.01 of the Statutes to include 5.01(b): "All Committees shall be responsible for presenting an interim report to the Board of Administration at the Mini Conclave during their term. This interim report should describe the actions of the Committee, up to the date of presentation to the Board of Administration."

Pursuant to Section 5.01 of the Statutes of this Association, this report is both physically and fiscally feasible.

Brother Herb Rodgers, State Nominations Committee Chairman, was introduced, and read the following Committee report:

# STATE NOMINATIONS COMMITTEE REPORT

To the Delegates of the 66th Annual Conclave:

This is the report of the Nominations Committee as set forth in section 5.03 of the Florida State DeMolay Statutes. It is hereby submitted for your approval.

The committee has consisted of: Brother Herb Rodgers III, Chair Brother Jon Richter, Vice-Chair Brother Kevin Gorman Brother Chris McKenney The Committee has met four times over the course of the year. The first meeting was directly following Brother Rodgers' appointment as Nominations Committee Chairman (after 65th annual Conclave), the second was after the letter of intent for Corey Allshouse was received (5 March 1999), the third took place before the 66th annual Conclave, and the fourth, on Monday night if the 66th annual Conclave, after the letters of intent for Brother Doyal and Brother Ferenchik were received.

At the first meeting of the committee, after the 65th annual Conclave, all members attended, and the possibilities for candidates were discussed.

The second meeting, after Corey Allshouse's letter of intent was received, was attended by all members, and Brother Richter was appointed to gain proof of Brother Allshouse's validity. It was later determined that Brother Allshouse is a valid candidate for the office of State Master Councilor.

The third meeting took place on July 25th, 1999, before the 66th Annual Conclave. All members were able to attend. We also reviewed the fact that we had only one nomination for the office of State Master Councilor, and no nominations for either State Senior Councilor or State Junior Councilor. We discussed possibilities of brothers to run for these offices.

All members except Brother Gorman attended the fourth meeting, on the night of July 26th, 1999, and he was excused because he was not in attendance at Conclave. At this meeting we reviewed the letters of intent for Brothers Doyal and Ferenchik, noting that both letters were amazingly similar. We also noted that we had no actual proof as to the validity of either candidate.

Because neither Brother Doyal nor Brother Ferenchik enclosed proof of their validity with their letter(s) of intent as required under Section 3.02a, the Nominations Committee cannot declare the eligibility of either candidate.

The committee, upon reviewing last year's committee recommendations, decided that the recommendation was actually directed towards the Constitutional Revisions Committee, and not the Nominations Committee.

The following letters on intent were received all within the deadlines applying to their offices:

At this time, the Nominations Committee makes no recommendations.

The Chair entertained a motion to accept the supplemental report as read. The motion was made by Brother Chris McKenney, Jupiter-Tequesta Chapter. The motion was seconded and passed.

The State Master Councilor called for any general business before Elections.

The State Master Councilor noted that some people had recommended that the candidates should be allowed to speak for one minute, prior to elections, and he then called for discussion.

Brother Ralph Dietzman, State Junior Councilor, stated that all of the candidates had more than adequate time to express their views in general and area caucuses.

Brother Jacob Meister, Crawford Chapter, stated that the candidates should have another opportunity to speak.

Brother Lee White, Sem-I-No Chapter, made a motion to not allow the candidates to speak again. The motion was seconded and passed.

There was a second, and under discussion, Brother Herb Rodgers asked if that was something within the power of the State Nominations The State Master Councilor proclaimed that removal is Dad Marti's decision, and that all the delegation can do is amend the report to recommend such action. Brother Nishant Koleskar, Gainesville Chapter, asked if the delegation should recommend replacements. The State Master Councilor told him that the replacement is up to the State Master Councilor, with the approval of the Executive Officer. # Minutes of the Business Session - - Friday, July 30, 1999

We the members of the State Membership Committee have met in accordance with sections 5.04 and 5.21 of the Florida DeMolay Association Statutes.

The Florida DeMolay Association was then put back into a State of Recess at 3:00pm, and then closed at the Friday evening Grand Banquet.

# Appendix B: Reference Material Charter of The Florida DeMolay Association

The several Chapters of the Order of DeMolay in Florida are hereby granted authority to form an organization to be styled "The Florida DeMolay Association". This Association shall exist to further the programs and ideals of the Order of DeMolay, to promote the progress and well-being of the Chapters and their Members, and to provide a medium for education and communication throughout the Order in Florida, provided that this Association shall have no authority over the particular chapters within this jurisdiction; provided further, that this Association shall have the authority to exercise jurisdiction over the State Master Councilor's Representatives and other such officers as now exist, or may in the future be created, by the Executive Officer.

To accomplish these goals, the Florida DeMolay Association shall be authorized to exact such Constitution, Statutes, and resolutions as shall not be in conflict with the policies or orders of the Executive Officer, and shall have been approved in advance by the Board of Administration.

The "Board of Administration" is hereby created to serve the Florida DeMolay Association, its officers and members, in a general advisory capacity. It shall review and approve all legislation to come before the Association, shall have original jurisdiction over any proposition or grievance arising out of the activities of the Florida DeMolay Association. It shall have the authority to construe or dispense with any provision of the Constitution, Statutes, or rules of competition, when it deems such action to be in the best interest of the Order of DeMolay or this Association, and shall perform other such duties as may be enjoined upon it by the Executive Officer, and it shall serve at his Pleasure.

## Constitution of The Florida DeMolay Association

#### Article I Name, Purpose , Colors

Section 1: This organization shall be known as the Florida DeMolay Association, Order of DeMolay (hereinafter, Association).

Section 2: The purposes for which this organization are formed are exclusively educational, religious, and charitable. Not by way of limitation, such purposes shall encompass guidance of DeMolays in their physical, mental, and religious development through specific programs in the fields of physical education, sportsmanship, citizenship, public speaking and the arts, all designed to promote a keen sense of the principles of good citizenship, sportsmanship, of respect for parents and fellowman, and to establish and instill a philosophy of life that will sustain the members of each chapter in the future.

Section 3: The official colors of this Association shall be the royal colors of Purple and Gold.

# Article II Allegiance and Authority

Section 1: The Association, it's officers, advisors, and the individuals of member chapters of this Association pledge their allegiance to the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary and the Executive Officer in the State of Florida.

Section 2: This body is constituted with the power and authority to set forth standards in the inter-chapter relations; and to levy fees and dues, provided that these measures are in harmony with the International Supreme Council of the Order of DeMolay, its Grand Master, Grand Secretary and the Executive Officer in the State of Florida.

#### Article III Members

Section 1: The members of this Association shall be all the Chartered Chapters, and those holding Letters Temporary of the Order of DeMolay located in the State of Florida.

Section 2: The members of this Association shall meet annually for the purposes of conducting business, electing officers, holding sports and ritual competition and other activities provided for in the statutes of this Association.

Section 3: In order for the delegation of a member chapter to attend and register, the said delegation must be accompanied by a certified member of the Advisory Council or a Master Mason, approved by the Zone Director for each ten DeMolays or fraction

thereof in attendance. No Chapter shall be allowed to register its delegation if said chapter has not paid in full all assessments due this Association.

Section 4: Each member Chapter shall be entitled to be represented by three (3) delegates at the Annual Conclave. This Association shall provide by Statute the manner of voting at delegate sessions.

# Article IV Officers

Section 1: The officers of this Association shall consist of the State Master Councilor, State Senior Councilor, State Junior Councilor, State Parliamentarian, State Scribe/Treasurer, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Chaplain, State Marshall, State Orator, State Standard Bearer, Seven State Preceptors, State Committee Chairman, and all others selected by the State Master Councilor and/or Executive Officer of the State of Florida.

Section 2: The State Master Councilor, State Senior Councilor, and State Junior Councilor shall be elected during the general business session of this Association at Conclave assembled each year, and these officers shall serve until their successors are installed.

Section 3(a): The State Scribe/Treasurer shall be appointed by the Board of Administration from a list of two or more nominations submitted to it by the State Master Councilor. The State Scribe/Treasurer shall be appointed at the Annual Mini-Conclave of this Association, or as provided by Article IV Section 5 (c). He shall not be eligible to run for elected office for a period of one year after his appointment. All nominees for the Office of State Scribe/Treasurer must be a Past Master Councilor, have completed the Leadership Correspondence Course, and be a Reprepentative DeMolay. All candidates for State Scribe/Treasurer must have a personal savings and/or checking account.

Section 3(b): The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration. The State Scribe/Treasurer shall obtain three (3) or more bids for the cost of printing the Conclave proceedings before the registration of said Conclave.

Section 4: All other State Officers shall be filled by appointment of the State Master Councilor. These officers shall serve until the close of the following Conclave.

Section 5(a): No candidate shall be elected to a State Office who would reach the age of 21 years prior to June 1 of the year following his election. No State Officer may attend an out-of- state school or reside outside the State of Florida during his term of office. Any violation of these provisions shall automatically create a vacancy in the office.

Section 5(b): A vacancy in an appointed State Office may be declared by the State Master Councilor after evaluation of that State Officer's performance.

Section 5(c): A vacancy in an elective State Office may be declared by the State Master Councilor after evaluation of the of the State Officer's performance and with the approval of the Executive Officer. A vacancy will also occur in the State Scribe/ Treasurer upon the recommendation and approval of the State Master Councilor to the Board of the Administration.

Section 6(a): In the event of death, resignation or removal of a State Councilor, each lower State Councilor shall advance to the next highest office and a State Junior Councilor shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer.

Section 6(b): In the event of death, resignation or removal of the State Scribe/ Treasurer, a new State Scribe/ Treasurer shall be appointed by the State Master Councilor, subject to the approval of the Executive Officer.

Section 6(c): Vacancies in all other State Offices shall be filled by appointment of the State Master Councilor.

Section 7(a): A Candidate's Letter of Intent to run for elective State Office must include the following statement:" I have read and am familiar with the Charter, Constitution, and Statutes of this Association."

Section 7(b): All candidates for the office of State Parliamentarian must include the following statement:" I have read and am familiar with ROBERT'S RULES OF ORDER".

#### Article V Committees

Section 1: The following committees shall be considered as standing committees of this Association:

1. Executive

7. Athletics

2. Nominations

8. Ritual

3. Guidance

9. Public Relations and Publications

4. Jurisprudence

10. Membership

5. Credentials

11. Knighthood

6. Budget and Finance

12. Constitutional Revisions

#### Article VI Amendments

Section 1: The procedure for amending this Constitution is as follows:

(a) It shall the responsibility of any Florida DeMolay proposing an amendment to this Constitution to provide for the distribution of said proposal to the Constitutional Revisions Committee, Jurisprudence Committee, Elective State Officers, Executive

Officer, Board of Administration, and member Chapters of this Association not less than sixty days prior to the opening session of Conclave.

(b) The proposed amendment, after the approval of the Jurisprudence Committee and the Board of Administration,, shall be presented for consideration on the floor of Conclave. Upon the approval of two-thirds (2/3) of the delegates present and voting, it shall take effect upon the close of the Annual Conclave.

## Statutes of the Florida DeMolay Association

#### Chapter 1

#### Section 1.01:

Each chapter shall pay as dues the sum of fifteen (\$15.00) dollars for each initiate to the Florida State DeMolay Association, Inc., and shall be payable with the Form 10 reporting the initiation.

#### Section 1.02:

The revenue derived from the initiation fee in Section 1.01 shall be distributed as follows; 33 1/3 % to the General Account, 33 1/3 % Savings Account, 33 1/3 % as provided in Chapter 4, Section 4.04.

#### Chapter 2 State Conclave

#### Section 2.01:

There shall be Ritual Competition, Athletic Competition, State Sweetheart Competition, Election Of State Officers and any other business for the Good of the Order of this Association.

#### Section 2.02:

There shall be Ritual Competition conducted under the direction of the Executive Officer's Personal Representative for Ritual, assisted by the Chairman of the State Ritual Committee. This competition shall be governed by the rules and regulations of the Old South Tournament.

#### Section 2.03:

There shall be Athletic Competition conducted under the direction of the State Director of Athletics assisted by the State Athletics Committee. The State Director of Athletics appointed by the Executive Officer, shall appoint for each competition referees for each event who shall use the playing rules established by the Florida State High School Athletics Association.

#### Section 2.04:

There shall be State Sweetheart Competition. The rules and regulations as determined by the Executive Officer shall be published in the proceedings of the year's Conclave.

#### Section 2.05:

For the purpose of participation in the activities and/or competitions sanctioned by this Association, any person who has not yet reached the age of 21 years before the opening of Conclave shall be entitled to participate as an active DeMolay, and at any subsequent level of competition; provided that they have not been certified as an Advisor.

#### Section 2.06:

There shall a Mini-Conclave, to be held annually in or about the month of January at a specific time and place to be determined by the Executive Officer and State Master Councilor.

The Mini- Conclave shall consist of:

- Such meetings of the State Officers as are deemed necessary by the State Master Councilor.
- All State Committees shall be required to meet and report to the State Master Councilor.
- Any other Ritual and/or Athletic Competitions social activities which are deemed necessary and appropriate.
- The Installation of the State Scribe/Treasurer.

#### Section 2.07

Any Active DeMolay, Senior DeMolay, Advisor, or Master Mason, may attend any business session of this Association, unless their presence is prohibited as provided for in the Statutes of the International Supreme Council.

# Chapter 3 Elections

#### Section 3.01:

Any qualified DeMolay who desires to run for an Elective Office of this Association shall send a Letter of Intent to the Executive Officer, the State Master Councilor and the Chairman of the Nominating Committee by the deadline for Conclave registration. The Letter Of Intent will be read aloud before the DeMolay Delegation by the Nominations Chairman prior to elections.

#### Section 3.02(a):

All candidates must be residents of the State of Florida for at least six months prior to the election and shall be members in good standing of a member Chapter of this Association. All candidates for elective State Office must possess at the time of filing for their Letter of Intent, proof being a Representative DeMolay, Past Master Councilor and having completed three of the five parts of the Leadership Correspondence Course, copies of such proof shall accompany said letter.

#### Section 3.02(b)

The candidates for an elected State Office shall show, to the approval of a Ritual Evaluator, or a panel of Evaluators, designated by the Director of Ritual, his proficiency in the Opening and Closing Ceremonies in the Ritual of Secret Work for his sought Office. The criteria for the approval of said evaluation shall be determined by the Director of Ritual for the State of Florida. The approval shall be granted no earlier than the Mini-Conclave prior to his candidacy.

#### Section 3.03:

All candidates for the Office of State Master Councilor must be a high school graduate or its equivalent and have been a member of this organization for at least two (2) years.

#### Section 3.04:

A candidate shall not cause any distribution of materials written or oral pertaining to his candidacy before he has submitted his Letter of Intent to the proper persons (as stated in Chapter 3, Section 3.01). The date of submission shall be determined by the Letter of Intent's postmark. He will be authorized to distribute calling cards only. This card will be no larger than the standard Life Membership Card in overall size, and will contain no information other than the name, address, phone number , emblem of the Order of DeMolay, title and / or honors, and the title of the office being sought by the candidate. This card will be the only authorized material which may distributed in his behalf at Conclave or at anytime.

#### Section 3.05:

The election of Officers of this Association shall take place at the discretion of the State Master Councilor during a regular business session at each Annual State Conclave.

#### Section 3.06:

The election of Officers shall be in order of rank, the highest being first, the order as provided by this Constitution, by secret ballot of those entitled to vote, as otherwise provided in the Constitution, at each Annual Conclave of this Association. A majority of the ballots cast shall be necessary for a candidate to be elected.

#### Section 3.07:

Any qualified candidate who is not elected to the office for which he has submitted a Letter of Intent, may be nominated for a lower office from the floor during elections.

#### Section 3.08:

The ballots for the election of Officers shall be prepared by the State Scribe/Treasurer for each Annual Conclave. Prior to the opening of elections, the ballots shall be distributed to each delegate entitled to vote. Ballots shall be cast with the full name of the candidate for the particular office legibly written thereon and shall be folded only once. Blank ballots, ineligible ballots, and those otherwise deviating from the proper form provided herine shall be tabulated as abstentions.

#### Section 3.09(a):

Each member Chapter shall be entitled to be represented by three delegates at the Annual Conclave. Each delegate shall have one vote in all matters brought on the floor of the Conclave, providing he has been certified by his Chapter Advisor and has been registered with the Credentials Committee prior to the Opening Session of Conclave. In the event that less than three (3) delegates from a Chapter are in attendance at Conclave, any or all of the absent delegate votes may be given to a remaining Delegate from that Chapter. In order to accomplish this, the Chapter Advisor must submit written authorization to the Credentials Committee before the opening business section of Conclave.

#### Section 3.09(b):

All of a Chapter's delegates must be members of said Chapter.

#### Section 3.10(a):

Every Past State Master Councilor who has not reached the age of twenty-one (21) years and is properly registered will be entitled to one (1) delegate vote on all matters at the Annual Conclave.

#### Section 3.10(b):

The State Senior Councilor, the State Junior Councilor, and the State Scribe/Treasurer will be entitled to one (1) delegate vote on all matters at the Annual Conclave.

#### Section 3.11:

Each Chapter Delegation shall elect a Delegation Chairman during the business sessions, the vote of the delegation shall be announced by the Chairman of the delegation with the exception of secret ballot for State Officer Elections.

#### Chapter 4 **Duties of State Officers**

#### Section 4.01:

The State Master Councilor shall be the duly elected head of this Association, and it shall be his duty to perform all duties which naturally pertain to such an office or which may devolve upon him from time to time.

#### Section 4.02:

The State Master Councilor shall preside at the Annual Conclave.

#### Section 4.03(a):

The State Master Councilor shall appoint all committee chairmen of this association, and in consultation with each chairman, appoint the committee members.

#### Section 4.03(b):

When a vacancy in any committee chairmanship occurs, an interim chairman shall be elected by the remaining members of the committee to serve until such a time as a new chairman is appointed by the State Master Councilor.

#### Section 4.04:

The State Master Councilor shall have an expense account equal to 33 1/3 % of the amount collected for each initiate reported to the Florida State DeMolay Association Inc. on Form 10's which shall be used for reasonable expenses incurred in the performance of his and other State Officers's duties, with the State Master Councilor's approval.

#### Section 4.05:

An Elected State Officer shall in person, visit each Chapter in this state, at least once during his term of office.

#### Section 4.06:

The State Master Councilor shall report in writing to the Association at each Annual Conclave, all of his official acts, whether performed in person or by Personal Representative.

#### Section 4.07:

The State Senior Councilor, State Junior Councilor, and the State Scribe/Treasurer shall represent the State Master Councilor when so ordered, assist the State Master Councilor in every way possible in the discharge of his duties, and shall report to this association at each Annual Conclave, all of their official acts.

#### Section 4.08:

The State Scribe/Treasurer's records shall be subject to an audit conducted by the Executive Officer.

#### Section 4.09(a):

The State Scribe/Treasurer shall record the minutes of the Annual Conclave of this Association and any official State meeting. He shall then within sixty (60) days have the aforesaid minutes, together with the Constitution and Statutes of their latest revision, published with the rules of the Sweepstakes Competition, and distributed as follows:

- One copy to each member Chapter of this Association.
- Copies to the Executive Officer, one copy to each member of the Supreme Council
  residing in the state, and one copy to any advisor appointed by the Executive
  Officer in a supervisory capacity, including the Board of Administration.
- One copy to the State Master Councilor, State Senior Councilor, State Junior Councilor, and the State Parliamentarian.
- One copy to the International Supreme Council.
- One copy to of the State Committee Chairmen.
- One copy to each Jurisdiction in Region 3 of the International Supreme Council, sent to the Executive Officer.

#### Section 4.09(b):

The State Scribe/Treasurer with the approval of the State Scribe/Treasurer Advisor, shall have the authority to correct any grammatical and typographical errors as he deems necessary and appropriate.

#### Section 4.09(c):

The State Scribe/Treasurer shall work with an Advisor who is satisfactory to the Board of Administration, as well as a Past State Scribe/Treasurer, also satisfactory to the Board of Administration, who can offer guidance and assistance to the current State Scribe/Treasurer in the execution of the tasks of his office. The State Scribe/Treasurer

shall obtain three (3) or more bids for the cost of printing the Conclave Proceedings before the Registration of said Conclave.

#### Section 4.10:

The State Scribe/Treasurer shall, under the direction of the State Master Councilor, and/or the Association conduct all correspondence of this Association.

#### Section 4.11

The State Scribe/Treasurer shall keep and maintain a true copy of the Constitution and Statutes of the Florida DeMolay Association. He shall also supply a copy for the Board of Administration, and one for the Executive Officer of Florida.

#### Section 4.12:

The State Scribe/Treasurer shall make disbursement for this Association with the approval of the Executive Officer. The State Scribe/Treasurer shall make an itemized report of all transactions in connection with this office at the Annual Conclave.

#### Chapter 5 Committees

#### Section 5.01(a):

All committees shall be responsible for reporting on the fiscal and physical feasibility of their proposals.

#### Section 5.01(b):

All Committees shall be responsible for presenting an interim report to the Board of Administration at the Mini Conclave during their term. This interim report should describe the actions of the Committee, up to the date of presentation to the Board of Administration.

#### Section 5.02:

The duties of the Jurisprudence Committee shall be to determine the constitutionality of all motions, resolutions, and proposals presented by the standing committees or from the floor of Conclave. The State Parliamentarian shall act as Chairman of the Jurisprudence Committee.

#### Section 5.03:

The duties of the Nominations Committee shall be to receive and review letters of intent filed by person(s) seeking qualification as (a) candidate(s) for Elective State Office; upon completion of the review the Chairman shall notify the prospective candidate of approval or shall notify him of deficiencies therein; such review and notification shall be completed within twenty (20) days after receipt of the letter by the Chairman; a candidate may submit an amended Letter of Intent which shall also be reviewed as specified herein above.

#### Section 5.04:

The Membership Committee shall study and promote an active program for the acquisition of eligible youth in this Jurisdiction.

#### Section 5.05:

The duties of the Credentials Committee shall be to validate the credentials of all Delegates to Conclave in accordance with Chapter 3, Sections 3.11 and 3.12 of the Statutes. This committee shall be responsible for arranging the seating of said delegates.

#### Section 5.06:

The duty of the Public Relations and Publications Committee shall be to promote the image of DeMolay before the general public. It shall also be the duty of this committee to inform and assist member Chapters in the Annual DeMolay Week program. This committee shall oversee any publication of this Association and any related programs.

#### Section 5.07:

The State Ritual Committee shall promote uniformity in the ritual of the Order of DeMolay throughout this Association, and shall recommend to the Association for approval procedures for the performance of ritualistic matters not set forth specifically in the Ritual of Secret Work of the Order of DeMolay and methods of receiving introducing and accommodating those who are entitled to recognition in all Conclaves, meetings, and public ceremonies of the Association. It shall also develop, review, and revise any State ceremonies which may used by this Association.

#### Section 5.08: -

The Athletics Committee shall work with the State Sports Director in acquiring qualified, unbiased judging officials for all State Athletics Competitions. They are also to make certain that no Advisors shall judge their own Chapters. They shall also review and submit any proposals to the State Master Councilor.

#### Section 5.09:

The duty of the Constitutional Revisions Committee shall be to recommend pertinent and necessary revisions to the Constitution and Statutes.

#### Section 5.10:

The Knighthood Committee shall report to the Delegates on the activities of the State Priory.

#### Section 5.11:

The Budget and Finance Committee shall review the financial status of this Association and report the same to the Delegates of the Annual Conclave. Any proposals, including committee recommendations, containing fiscal impact shall be submitted to this committee for its review and recommendation. It shall also be the committee's responsibility to put together the Conclave Program and such advertisements necessary for its production. This committee shall also present a proposed comprehensive budget for this Association to the delegates and, upon approval, present the proposed budget

for this Association to the Executive Officer. The expenditures of this Association shall not exceed its income from Conclave to Conclave.

#### Section 5.12:

The Guidance Committee shall be the duly appointed State Master Councilor's Representatives of the of the several Areas and the State Appointed Line Officers and Committee Chairman. This Committee will function at the will of the State Master Councilor. It shall act in an advisory capacity to relay to the State Master Councilor the suggested needs of the individual zones and the State as a whole.

#### Section 5.13:

The Executive Committee shall be composed of the Elected State Officers, State Scribe/Treasurer, and all Past State Master Councilors who have not reached their majority. It shall be chaired by the State Master Councilor, and shall meet at his discretion. In addition to other duties deemed appropriate by the State Master Councilor, it shall be this committee's duty to work with the Conclave Director in planning and executing all miscellaneous activities at Conclave.

#### Section 5.14:

The State Master Councilor shall announce the names of the appointed Committee Chairman, Appointed State Officers, and State Master Councilor's Representatives at the last business session of the State Conclave. The names of the Chairman shall be published, with the exception of the State Credentials Committee Chairman, in the current proceedings of this Association.

#### Section 5.15:

The State Master Councilor shall have the authority to appoint one advisor to each committee with the consultation of the Committee Chairman and the Director, if one has been appointed.

#### Section 5.16:

It shall be the duty of each committee to submit to the State Master Councilor a report upon request. It shall also be the duty of each State Committee Chairman to gather suggestions and recommendations from the member Chapters and combine them with his own ideas and submit them to the State Master Councilor as a tentative agenda thirty (30) days prior to Conclave.

#### Section 5.17:

The final committee reports shall be typewritten and submitted to the State Scribe/Treasurer no later than the beginning of the last business session at each Conclave.

#### Section 5.18:

The final report from each state committee must be read and passed by a simple majority vote of the Delegates prior to the close of Conclave.

#### Section 5.19:

The State Master Councilor shall have the power to establish and abolish additional committees (with the exception of standing committees) as deemed necessary.

#### Section 5.20:

Each individual state committee shall be responsible for implementing the recommendations made by that committee and approved by the delegates, at the most recently conducted Conclave. The Executive Committee shall oversee and coordinate this implementation.

#### Section 5.21:

All committees shall physically meet at least three (3) times a year prior to the opening session of Conclave and submit minutes of these meetings to the State Master Councilor at the Annual Conclave, (with the exception of the Executive Committee).

#### Chapter 6 State Master Councilor's Representatives

#### Section 6.01:

It will be the duty of each State Master Councilor's Representative to promote Florida DeMolay and its communications to the members of this Association.

#### Section 6.02:

It will the duty of each State Master Councilor's Representative to provide monthly reports to the State Master Councilor, Guidance Committee Chairman, and State Officer in charge of his area, concerning the progress, activities, and the needs of his chapter and area.

#### Section 6.03:

State Master Councilor's Representatives will be required to attend all meetings of the Guidance Committee of this Association.

#### Section 6.04:

State Master Councilor's Representatives shall act as personal representatives of the State Master Councilor, to serve on his behalf when no other ranking State Officer is present.

#### Section 6.05:

Each Area will have one (1) State Master Councilor's Representative for every three Chapters or fraction thereof. State Master Councilor's Representatives shall be appointed by the State Master Councilor to serve at his will.

#### Section 6.06:

State Master Councilor's Representatives shall be obligated to attend both Mini-Conclave and Conclave.

#### Section 6.07:

All State Master Councilor's Representative shall be required to begin working on their L.C.C. and R.D. within 30 days of their appointment, if they have not previously been completed. Proof of completion must be furnished by his Chapter Advisor.

# Chapter 7 State Appointed Officers

#### Section 7.01:

State Appointed Officers shall include; the State Parliamentarian, State Senior Deacon, State Junior Deacon, State Senior Steward, State Junior Steward, State Orator, State Sentinel, State Chaplain, State Marshall, State Standard Bearer, State Almoner, and the State Seven Preceptors.

#### Section 7.02:

It shall the duty of each State Appointed Officer to promote the Florida DeMolay Association and its communications to the members of this Association.

#### Section 7.03:

It shall be said Officers duty to provide monthly reports to the State Master Councilor concerning the progress, activities and needs of their Chapter and Zone.

#### Section 7.04:

State Officers will be required to attend all meetings of the Public Relations and Publications Committee.

#### Section 7.05:

State Officers shall act as a Personal Representative of the State Master Councilor when no other ranking officer is present.

#### Section 7.06:

Said Officers will be required to memorize their portions of the Ritual Ceremonies.

#### Section 7.07:

Said officers shall be required to begin working on their L.C.C. and R.D. within thirty (30) after their appointment, if they have not previously completed them.

#### Section 7.08:

Said Officers shall be obligated to attend both Conclave and Mini-Conclave.

#### Section 7.09:

The State Parliamentarian shall decide the constitutionality of all motions, resolutions, and proposals presented by the standing committees or from the floor of Conclave, when so requested by the State Master Councilor.

#### Chapter 8

#### **Amendments**

#### Section 8.01:

These Statutes can be amended by a simple majority vote of the delegation, and such amendments may be substituted any time prior to the first Business Session of Conclave, and need only be submitted to the delegates of the Chapters in attendance at the Conclave.

#### Section 8.02:

These amendments, shall upon the approval of the Board of Administration and the delegation, take effect immediately.

# Charter of the Past State Officers' Association of the Order of DeMolay in Florida

The Past State Officers' Association of the Order of DeMolay in Florida, is hereby established subject to the following guidelines.

#### **Purpose**

The purpose of this Association shall be solely to aid and support the Order of DeMolay in Florida in any way (s) deemed appropriate by it's membership.

#### Membership

The membership of this Association shall consist of all Past Elected State Officers, Past State Scribes and Past State Scribe Treasurers of the Florida DeMolay Association who have reached the age of 21.

#### Meetings

This Association shall meet at least once each year at the Annual Conclave of the Florida DeMolay Association.

#### **Officers**

This Association shall have a Chairman, elected by a majority vote of the members present at the annual meeting, who shall serve for a term of one year. The Chairman shall preside at all meetings of this Association.

## Sweepstakes Competition Rules

Each areas can earn a maximum of two hundred points. Areas 1 and 2 are "all or nothing", areas 3-7 are a sliding scale based on the sweepstakes formula, with 50% based on raw numbers and 50% based on Chapter Membership.

# Rules and Regulations General Conclave Rules

One of the best, most pleasant of the DeMolay year is our Annual State Conclave. Everyone will have a much more enjoyable time if we all obey a few ground rules.

Our Statutes prohibit behavior likely to bring disrespect upon the Order of DeMolay and conduct unbecoming that expected a member of our Order. Additionally, the Laws of the host city, the State of Florida and the United States, are to be obeyed at all times by everyone attending Conclave.

The following General Rules are for the protection of everyone at Conclave:

- 1. Our Statutes prohibit possession, use or consumption by DeMolays at Conclave of beer, liquor or controlled substances, including but not limited to cannabis, hallucinogens or other substances defined as "Controlled" by Florida Law.
- 2. No tobacco products. The use of any tobacco products, cigars, cigarettes, snuff or chewing tobacco, will not be allowed by any DeMolay during Conclave or at any other DeMolay function.
- 3. For your own protection and the protection of others, possession of firearms, fireworks, other explosives, switchblade knifes and other like items or materials are prohibited.
- 4. No DeMolays are allowed on the floor where the Sweethearts are housed.
- 5. Dress for the evening meals will be shirt and tie, coats will be optional.
- 6. Shirt and tie are required for all Delegate Sessions and the General Opening. Dress for the banquet is formal or semi-formal.
- 7. Swimming suits are not allowed in the main lobby or in the video game room.
- 8. No Sweethearts or female guests are allowed in any DeMolay room.
- 9. Any damage to the hotel room will be billed to the persons registered in the room.
- 10. Room occupants are responsible for incidental charges such as telephone calls out of the hotel, special TV charges.
- 11. Anyone observing breach of these rules shall immediately report the activity to the Conduct Room or Conclave Office.
- In the event that the Conduct Committee determines that a breach of these rules has occurred in any area at Conclave, all persons involved will be subject to being immediately sent home. Provided, that if the event is an isolated occurrence and no actual or constructive knowledge of the breach or infraction can be attributed to all persons in the area, only those involved in the event will be sent home. If a person (s) are sent home, his/her parents are responsible for all transportation charges and will be immediately advised of the reason for the individual's expulsion from Conclave. No refund will be made to those persons sent home.

#### Sweetheart Rules

All Sweethearts and their Chaperones must abide by the rules of the Executive Officer, Conclave Director, and Sweetheart Committee.

There must be an adult female chaperone or legal parent for every three Sweethearts to attend any Conclave function. Chaperones must be at least 25 (twenty-five) years of age. No Exceptions. Contestants for State Sweetheart must room with their Chaperones.

Chaperones should conform to all rules and regulations including the dress code for female Chaperones. All Sweethearts and their Chaperones must be officially registered through an active DeMolay Chapter with the approval of the Advisory Council.

- 1. In case of problems or questions, contact only the State Sweetheart Chairman or Committee. Do not contact the hotel staff.
- 2. Each Sweetheart must be a current Chapter Sweetheart, only one entry per Chapter will be accepted.
- 3. Sweetheart Contestants must be between the ages of fifteen (15) and twenty (20) years old as of July 1st of the year they compete and attending a Florida school or be a High School Graduate. They must wear name tags at all times and they are required to attend the first briefing session.
- 4. All Sweethearts should exemplify the highest DeMolay ideal of womanhood and conduct themselves in a lady-like manner.
- 5. Sweetheart Contestants cannot be engaged to be married, married, annulled, divorced, be or ever have been pregnant.
- 6. Sweetheart Contestants must have their parent's or guardian's approval in writing and submitted to the State Sweetheart Committee Chairman before the beginning of Conclave, together with a completed standard Florida DeMolay medical release form
- 7. Each Sweetheart Contestant and her Chaperone must be registered and staying at Conclave (in the same room) the entire session. The Chaperone must know where her (his) Sweetheart is at all times. A Sweetheart Contestant Chaperone may not chaperone anyone else.
- 8. Sweetheart Contestants will be permitted to run no more than twice for State Sweetheart. Any girl who has been State Sweetheart is ineligible to run again.
- 9. A suitable 5 x 7 photo, preferably in color, must be submitted to the State Sweetheart Chairman the first day of Conclave. No other size photo will be accepted, and the photo will not be returned. (Photos with crown and sash will be permitted).
- 10. Pictures, cards, brochures, or any other campaign materials will not be distributed by a sweetheart or for her by any others. Sweethearts or female guests will not campaign in any way for candidates running for DeMolay State Office.
- 11. Any infraction of these rules by anyone may cause a Sweetheart Contestant to be disqualified from competition.

- 12. Sweetheart Contestants may not leave the hotel premises without a Chaperone and permission from a member of the State Sweetheart Committee.
- 13. No DeMolay will be permitted to enter a Sweetheart's room.
- 14. Sweetheart Contestants are not permitted in the vicinity of the ballot box while DeMolays are voting for State Sweetheart.
- 15. Each DeMolay will vote for three (3) girls for State Sweetheart, indicating their first, second, and third choice. Each first choice vote will receive three (3) points; second choice will receive two (2) points; and third choice will receive one (1) point. The girl receiving the highest number of points will be the State Sweetheart. There must be three different, eligible Sweetheart names on each ballot.
- 16. A member of the B.O.A. shall be present at the counting of the votes to assist the Sweetheart Committee.
- 17. The State Sweetheart cannot concurrently serve as a Chapter Sweetheart. She must resign from her chapter position upon election as State Sweetheart.
- 18. The State Sweetheart must notify the State Sweetheart Chairman within 15 Days of her election who her official Chaperone will be; any time the State Sweetheart attends any function wearing her Florida State Sweetheart sash and/or crown, she is under the State Sweetheart rules. The State Sweetheart must be Chaperoned from the time she leaves her home until the time she returns home.
- 19. It is the duty of the State Sweetheart to keep the State Sweetheart Chairman informed on all of her official activities.
- 20. Any engraving done on the State Sweetheart trophy or plaque will be paid for immediately by the F.S.D.A Sweetheart fund on presentation of a bill to the State Sweetheart Chairman.
- 21. The State Sweetheart is responsible for the crown, sash, cape, and crown box which will be returned to the State Sweetheart Chairman, in the same condition they were received in, at the beginning of conclave of upon request.
- 22. State Conclave registration for the out going State Sweetheart will be paid for by the Florida DeMolay association. (Contact the State Sweetheart Chairman.)
- 23. If the State Sweetheart marries, becomes engaged to be married, moves out of Florida, becomes pregnant, or leaves for 30 days, she must resign and return all State Paraphernalia. The first runner-up will replace her.
- 24. The State Sweetheart should be willing and able to travel to various parts of Florida to DeMolay activities, and also, to State DeMolay Functions when invited.

#### **Dress Code**

- 1. Contestants should at all times be dressed in good taste and appropriately for the occasion.
- 2. Dresses are recommended for most functions. It is understood that at all times bras, panties, slips, and hose will be worn with all dresses.
- 3. Backless dresses are acceptable must have bra and slip. Extremely tight clothing, skirts or dresses with high slits or low cut tops are unacceptable. When in doubt, don't wear it.

- 4. Slacks or dress jeans (not bare midriff or hiphugger type) may be worn to sports events or special activities. Shorts (not short shorts) will be permitted only if the occasion (sports, pool parties, etc.) warrants.
- 5. Bikini bathing suits (in good taste) may be worn. Robes must be worn over suits to and from the pool.
- 6. Formals will be worn at all formal functions -- Formal Introductions, Grand Banquet, or upon the request of the State Sweetheart Chairman.
- 7. Chapter sashes and crowns will not be worn at state conclave. Sashes will be provided. Sashes will not be worn with slacks or shorts.

- NO Bubble gum or loud obnoxious gum chewing that interferes with normal speech.
- NO Necking or petting
