MINUTES OF THE DELEGATE SESSION

First Business Session of Delegates: Sunday, July 22nd, 2012

The State Master Councilor, Bro. Gregor Berry, commenced the delegate session at 7:15pm.

The State Scribe then took the roll call of Chapter Delegates, the results of which appear in Appendix I of these Proceedings.

The roll call yielded that the First Delegate Session of the 79th Summer Conclave of the Florida Jurisdictional Chapter had 51 Delegates present, not including the State Master Councilor with a total of 57 Delegate votes, not including the State Master Councilor's vote, at the beginning of the session.

The motion submitted in its original format appears in these Proceedings as Appendix H.

Amendment to the Florida Jurisdictional Chapter Standard Operating Procedure Regarding Requirements to Run for State Office

The State Scribe read the motion that appears in Appendix I in their original format.

The State Master Councilor, Bro. Gregor Berry called for discussion.

The Delegation had no discussion for the motion.

The State Master Councilor called for a vote on the **Amendment to the Standard Operating Procedure Regarding Requirements to Run for State Office.**

The State Master Councilor, Bro. Gregor Berry commenced voting at sound of the gavel.

Once Voting was closed it showed that the **Amendment to the Standard Operating Procedure Regarding Requirements to Run for State Office** passed with unanimous approval.

The Announcement of Executive Staff approved candidates for the offices of State Master Councilor, State Senior Councilor, and State Junior Councilor read as follows:

- For the office of State Master Councilor: Bro. Harrison Sherwin
- For the office of State Senior Councilor: Bro. Ashton Abela, and Bro. Martin Cox
- For the office of State Junior Councilor: Bro. Erik Legge, and Bro. Alex Levy

Caucuses for the offices of State Line began with the candidates for State Master Councilor.

Caucuses began with opening remarks from Bro. Harrison Sherwin, Candidate for the office of State Master Councilor:

“When I found out that our esteemed Brother Jeff Meister would be passing on the role of State Master Councilor in order to pursue a career in the military, I immediately started thinking who could be the next State Master Councilor. A few people came to mind, but I realized why was I thinking of other people, when I was capable of running? So I did just that, I submitted my Letter of Intent. These last few months, I've been talking with Brother Gregor Berry, our state staff and several International Supreme Council members from Florida in order to gain a better sense of what I could do as the State Master Councilor to help Florida DeMolay. One of my priorities will be strengthening the districts through membership-focused programming. I also plan on being more available for Chapters, should they desire, by having a full corps of dedicated state officers and keeping a close line of communication with my other elected state officers. I plan on travelling as much as I can, and I'll be encouraging my other officers to as well. That said, I can't do it alone. I'll

need the support of everyone in this room and everyone who's a part of Florida DeMolay. I hear stories about Florida DeMolay that go 'Back in my day we...' I want to see us be the ones that the stories come from."

Caucuses continued with opening remarks from Bro. Ashton Abela, Candidate for the office of State Senior Councilor:

"Hey everyone, I'm Ashton Abela and I am one of your Candidates for State Senior Councilor. First off, I'd like to say that it's an honor to be considered for this position, and if elected, I will do all in my power to ensure that this state grows to its utmost potential. I feel that a solid cooperation with the state officers and state staff is key to effectively doing what YOU all want with this state, because that's what matters. I am willing to answer any questions or clear up any concerns you all may have, and hope that I effectively show to you all that I am dedicated and ready to serve you all. I feel that I am a very worthy candidate of this office, and I can only hope you see me fit to serve you all. It would be both a pleasure and an honor to serve you as your State Senior Councilor."

Caucuses continued with opening remarks from Bro. Martin Cox, Candidate for the office of State Senior Councilor:

"My Brothers, five years ago I stepped into my first meeting as a DeMolay at the age of twelve. Ever since that day I've been working for the betterment of not only my chapter, by my state, and even my country. At my first Conclave I saw the State Line, I was in awe, and I knew they were doing their best to better our Jurisdiction, and I knew I had to be a part of them, and so I began climbing the ladder, asking for any position or part possible. And I gained the office of State Junior Councilor."

Caucuses continued with opening remarks from Bro. Erik Legge, Candidate for the office of State Junior Councilor:

"I wanted to use this time to explain my motivations for seeking the office of State Junior Councilor. Ever since joining DeMolay I have been impressed with the level of autonomy that is granted to its members, which I feel is unparalleled in any other youth organization I have encountered. I've attended Conclaves and Knighthood events, travelled some to help with installations at chapters, and the more DeMolays that I meet and the more functions and chapters I attend and visit, the greater is my opinion of the quality of the organization as a whole and the character of the many DeMolays which make it up. That said, there is always something that can be done to improve and progress. Be it the world, our country, our state, or ourselves. I see things which can be made better, and I believe that if I contributed my thoughts and my time to the pool of many who are doing the same, that the organization will only improve."

I want the opportunity to do what I can to progress DeMolay, and the opportunity to grow my leadership skills and experience, and I believe that both of those opportunities rest with the state line. All of us at some point have heard the sentence "back when I was a DeMolay" from an advisor; usually right before launching into a story about the glory days. I want to be able to do the same, and say that during my time as a DeMolay, I took part in watching it rise and grow better. I feel like the best path to that end is through advancing things on the local chapter level while at the same time improving the state level, and meet in the middle where active district positions can link both. We are very fortunate in Florida to have an excellent Priory, and I believe that through close coordination on local, district, and state levels with the corresponding levels in the Priory, both

DeMolay and Knighthood can be made better than they already are. Only through using everything good that we have here to our advantage and working cohesively on all levels can we make Florida not only one of the best jurisdictions in the world, but the best jurisdiction in the world. I'm seeing progress, and I want the opportunity to add to that progress.

At this Conclave, for the first time in years, there are real elections for two offices, and while because of that there is a fair chance that I won't be elected, I will take an actual election over unanimous acclamation any day. Merely submitting a letter of intent shouldn't guarantee one's position because no one else is even interested in running. We should be glad that we are even allowed to elect our state line; so few jurisdictions and youth organizations in general are. I'm happy for what elections means for the future of DeMolay in Florida. Now you delegates have the opportunity to decide who you want to lead you of the three/two of us, because whoever is wearing those collars is representing you."

Caucuses continued with opening remarks from Bro. Alex Levy, Candidate for the office of State Junior Councilor:

"Hello, my name is Alex Levy. I believe that if I'm elected to the office of State Junior Councilor, I would do the best I can to help in every possible way to improve anything I possibly can. I'd love to improve membership and to also help so that the new members feel included and appreciated."

The State Master Councilor, Bro. Gregor Berry, declared the caucus opened for questions by the Delegates and those present at the Delegate meeting.

Bro. Nick Massanet, Delegate from St Petersburg Chapter posed a question for all Candidates.

What are your goals and how will you achieve them?

Candidate for State Master Councilor, Bro. Harrison Sherwin, said that he wants DeMolays' opinions to get what we want. He will plan events to get new members, and events that are what we want to do. Bro. Harrison Sherwin talked about the importance of the Standard Operating Procedures of the Florida Jurisdictional Chapter. How he is bringing forward programs to help Chapters. Bro. Harrison Sherwin plans to help chapters in what they want to do.

Candidate for State Senior Councilor, Bro. Martin Cox, stated that his position is to help the State Master Councilor. How he hopes to have a stronger district relation to the Florida Jurisdiction and to create it within the entire state.

Candidate for State Senior Councilor, Bro. Ashton Abela, explained how his personal goals is motivation and dedication through two things: getting in more members and getting them excited about DeMolay. He said, *"We all are physically able of working together to make this jurisdiction better."*

Candidate for State Junior Councilor, Bro. Alex Levy, said that to make everyone feel like they aren't left out. To create specific activities for new initiates so no one is left out.

Candidate for State Junior Councilor, Bro. Erik Legge, said his position is to help the State Master Councilor and his goals. As a group we need to hear more ideas from everyone. To make sure what we decide as a state is what we want to happen. So what we want to do we get to do. To improve all

levels of the organization, in the Chapter, District, and the State. To plan events that are to everyone's approval.

Bro. McLean Haughey, non-voting member from Paul Revere Chapter and Squire Commander of Col. James "Nick" Rowe Priory posed a question for the Candidate for the Office of State Master Councilor:

Tell me something about Florida DeMolay that I don't know?

Candidate for State Master Councilor, Bro. Harrison Sherwin, explained his International Supreme Council experience. Bro. Harrison Sherwin stated how our State Staff has our back 110%. Our Advisors are defending what is good for Florida DeMolay, not just for themselves. He went thinking the Executive Staff was good, but came back thinking the Executive Staff was amazing. How we are better off than many other jurisdictions through our Executive Staff.

Bro. Christian Campana Emard, Delegate from South Seminole Chapter posed a question for all the Candidates:

What are your past qualifications as a DeMolay that will help you as a state officer?

Candidate for State Senior Councilor, Bro. Martin Cox, said that he is the State Junior Councilor, Master Councilor twice. How he has his Past Master Councilor's – Meritorious Service Award, his Lamp of Knowledge, his Representative DeMolay, Chevalier, the Distinguished Service Award, and explained how he personally helped start chapter in Miami area.

Candidate for State Senior Councilor, Bro. Ashton Abela, stated how he has been Master Councilor twice, how he has his Representative DeMolay, his Lamp of Knowledge, his Founders Membership Award, and multiple merit bars.

Candidate for State Junior Councilor, Bro. Erik Legge, stated how he has multiple merit bars, and other qualification.

Candidate for State Junior Councilor, Bro. Alex Levy, stated how he has many qualifications. That he is the current scribe. That he has his Past Master Councilor – Meritorious Service Award. That he also possesses his #1 Pin.

Candidate for State Master Councilor, Bro. Harrison Sherwin, explained how he helped establish Sarasota Chapter. That he has his Founders Membership Award. That he is a Past State Scribe of the Florida Jurisdictional Chapter. He is a member of the Order of the Cross of Jerusalem. He is also the current state parliamentarian.

Bro. Tyler Mackey Delegate from Bahia Chapter posed a question for all Candidates:

What will you do for your chapter and for the state line to help and grow it all offices?

Candidate for State Junior Councilor, Bro. Alex Levy, explained how he increased membership by almost half.

Candidate for State Junior Councilor, Bro. Erik Legge, explained he revamped chapter ritual, and

planned many events for the Chapter.

Candidate for State Master Councilor, Bro. Harrison Sherwin, stated how his communications program that won the International Supreme Council Award. How his conclave proceedings were done. He explained how he as Page Commander of Colonel James "Nick" Rowe Priory revised investment qualifications. He also explained how he expanded Sarasota Chapter's membership.

Candidate for State Senior Councilor, Bro. Ashton Abela, said how his chapter was at ultimate low when he became Master Councilor. How he encouraged members get new guys in. How their motivation increased. How his second term plans were to expand previous terms plans. How he is finishing the requirements for his Past Master Councilor's - Meritorious Service Award. And now is focused on expansion of Michael A. Padron Sr. chapter.

Candidate for State Senior Councilor, Bro. Martin Cox, said his first term as Master Councilor had a high attendance rate. He explained how he has been District Deputy to the State Master Councilor of District 2 for two years while also having district conclave. Bro. Martin Cox also explained how his second term as Master Councilor; he started with 3 members and ended with 12 members. Bro. Mac Cox further explained how his members helped with PMC-MSA.

Bro. Cesar Castillo, Delegate from Oleeta-West Dade Chapter posed a question for the Candidates for the office of State Senior Councilor and State Junior Councilor:

How do you plan to serve the State Master Councilor and help Florida DeMolay?

**APPENDIX C:
CHARTER OF THE FLORIDA JURISDICTIONAL CHAPTER**

By directive of the Executive Officer, a Jurisdictional State Chapter is hereby chartered. The State Chapter shall be governed first by the Bylaws, Rules and Regulations of DeMolay International, second by directives of the Executive Officer, and third by its Standard Operating Procedures (SOP).

The State Chapter shall function through a Jurisdictional Staff to promote and achieve the Jurisdictional Management Plan and directives of the Executive Officer.

The State Chapter shall be inclusive of all components and members of Florida DeMolay.

Take due notice thereof, and govern yourselves accordingly.

**APPENDIX D:
STANDARD OPERATING PROCEDURES OF
THE FLORIDA JURISDICTIONAL CHAPTER**

The members of this State Chapter shall be every member of every Chartered Chapter, and those holding Letters Temporary of the Order of DeMolay located in the Jurisdiction of Florida. All members of the individual Chapters will be dual members of the State Chapter.

Any member who is initiated in, or moves to an area where there is no Chapter to readily accept him, the said member will be a part of the Florida-at-Large Chapter. The assembled Florida-at-Large Chapter members will meet the first day of the Annual State Conclave and Mini-Conclave for the purposes of conducting business, electing officers, holding athletic and Ritual competitions, and other activities that are seen fit by the Conclave Director.

The Elected Officers of this State Chapter shall consist of the State Master Councilor, State Senior Councilor, State Junior Councilor, State Scribe and Illustrious Knight Commander who also holds the office of Deputy to the State Master Councilor. This will not be a progressive role.

The State Senior Councilor and State Junior Councilor shall be elected at the Annual State Conclave assembled each year. These officers shall serve until their successors are installed, or until they resign or are removed.

The State Scribe shall work with an Advisor who is satisfactory to the Executive Staff. The Advisor must be a member of the Jurisdictional Staff.

No candidate shall be elected to a State Office who would reach the age of twenty-one (21) prior to his installation. No State Officer may attend an out-of-state school or reside outside the State of Florida during his term of office. Any violation of these provisions shall automatically create a vacancy in the office.

A vacancy in an elected State Office, with the exception of Illustrious Knight Commander, may be declared by the State Master Councilor with the approval of the State Chapter Dad and Executive Officer. A vacancy will also occur in the State Scribe position upon the recommendation and approval of the State Master Councilor, the State Chapter Dad, and the Executive Officer.

In the event of death, resignation or removal for the Elected Office of the State Senior Councilor, the State Junior Councilor shall advance to the next highest office and a State Junior Councilor shall be appointed by the State Master Councilor subject to the approval of the State Chapter Dad and the Executive Officer.

Any qualified DeMolay who desires to run for the Elected Office of State Senior Councilor, State Junior Councilor and State Scribe of this State Chapter, with the exception of the Illustrious Knight Commander, shall send a Letter of Intent to the Executive Officer, State Chapter Dad, the State Master Councilor, and the Chairman of the Nominations Committee, the State Scribe, no less than 20 days prior to the opening of said Conclave. The Letter of Intent will be read aloud before the Florida DeMolay Delegation by the Nominations Chairman prior to elections. Letters of Intent may be in the form of an email.

All candidates must be residents of the State of Florida for at least six months prior to the election and shall be member in good standing of a member Chapter of this Jurisdiction. All candidates for an Elected Office must possess at the time of filing their Letter of Intent: proof of being a recipient of the Representative DeMolay Award, a Past Master Councilor, and having completed the five modules of the Leadership Correspondence Course. Copies of such proof shall accompany said letter.

The candidate's for State Master Councilor, State Senior Councilor and State Junior Councilor shall show, to the approval of a Ritual Evaluator, or panel of Evaluators designated by the Director of Ritual, his proficiency in the Opening and Closing Ceremonies and Initiatory Degree in the Ritual of Secret Work for his sought Office. The criteria for the approval of said evaluation shall be determined by the Director of Ritual before the elections of the said office.

A candidate's Letter of Intent to run for an elected State Office must include the following statement: "I have read and am familiar with the Bylaws, Rules and Regulations of DeMolay International, and the Charter and Standard Operating Procedures of the Florida Jurisdictional Chapter." It shall also include the statement "I am proficient in the Ritualism of the office I am seeking." Candidates seeking office at conclaves, and their parents, shall be interviewed by the Executive Staff prior to Conclave. The Executive Staff will provide final guidance on a candidate's suitability for office, and refer them to the voting delegation at Conclaves.

All candidates for the office of State Master Councilor must have been a member of this organization for at least two (2) years prior to seeking said office. Candidates for the office of State Master Councilor must be, at the time of their election, at least one of the following: a past or current State Senior Councilor of the Florida Jurisdictional Chapter (FJC), a past or current State Junior Councilor of the FJC, a past State Scribe of the FJC, or a past Illustrious Knight Commander of the Col. James "Nick" Rowe Priory. Further, candidates for the office of State Master Councilor must submit a Letter of Intent at least 90 days before the opening of Conclave. Letters of Intent for State Master Councilor must include a Plan of Term, proof of completion of the LCCs, proof of receiving the Representative DeMolay award, and proof of being a Past Master Councilor. Any candidate of said office from the Florida-at-Large Chapter needs the approval of the Executive Staff.

All candidates that wish to run for State Master Councilor, State Senior Councilor, State Junior Councilor, and State Scribe shall have a letter approving their candidacy accompanying their Letters of Intent from a parent or legal guardian of the candidate.

A candidate shall not cause any distribution of materials, written or oral, pertaining to his candidacy before he has submitted his Letter of Intent's postmark. He will be authorized to distribute business size calling cards only. These cards will contain no information other than the candidate's name, post or email address, phone number, the emblem of the Order of DeMolay, titles and/or honors, and the title of the office being sought by the candidate. This card will be the only authorized material which may be distributed on his behalf at the Annual State Conclave or at anytime.

The election of Officers of this State Chapter with the exception of the Illustrious Knight Commander, shall take place at the discretion of the State Master Councilor during a regular business session at the respective conclaves.

The election of Officers shall be in order of rank, the highest being first, by secret (written) ballot of those entitled to vote or by unanimous acclimation if there is only one DeMolay running. A simple majority of the ballots cast shall be necessary for a candidate to be elected.

Any qualified candidate, who is not elected to the office for which he has submitted a Letter of Intent, may be nominated for a lower office from the floor during elections.

The ballots for the election of Officers shall be prepared by the State Scribe for each Annual State Conclave. Blank ballots, ineligible ballots, and those otherwise deviating from the proper form provided herein shall be tabulated as abstentions.

Each Chapter shall be entitled to three (3) votes and to be represented by up to three (3) delegates at the Annual Conclave. Each delegate shall have one vote in all matters brought on the floor of Conclave. Each delegate shall have one vote in all matters brought on the floor of Conclave, providing he has been certified by his Chapter Advisor and has been registered with the Credentials Committee prior to the Opening Session of Conclave, any or all of the absent delegate votes may be given to a remaining Delegate from that Chapter. In order to accomplish this, the Chapter Advisor or designee must submit written authorization to the Credentials Committee before the opening business session of Conclave. All of a Chapter's delegates must be members of said Chapter.

Every Past Elected State Officer, who has not yet reached the age of majority before the opening of Conclave, and who is properly registered, will be entitled to one (1) delegate vote on all matters at the Annual Conclave.

The State Senior Councilor, State Junior Councilor, State Scribe, and Illustrious Knight Commander will be entitled to one (1) vote on all matters at the Annual Conclave. The State Master Councilor will be given one (1) delegate vote only to be used in a tie breaker circumstance.

Each Chapter Delegation shall elect a Senior Delegate before the opening of Conclave. The vote of the Chapter Delegation shall be announced by the Senior Delegate with the exception of a secret (written) ballot.

The State Master Councilor shall be the duly elected head of this State Chapter, and it shall be his duty to perform all duties which naturally pertain to such an office or which may devolve upon him from time to time.

The State Master Councilor shall preside at the Annual State Conclave and Mini-Conclave.

The State Master Councilor shall appoint all State Officers that are not elected and the State Committee Chairmen of this State Chapter. In consultation with each chairman, the State Master Councilor shall appoint the committee members.

The State Master Councilor shall announce the names of the appointed Committee Chairman and Appointed State Officers, at the last business session of the State Conclave. The names of the Chairman shall be published in the current proceedings of this State Chapter.

When a vacancy in any Committee chairmanship occurs, it is the duty of the State Master Councilor to appoint a new chairman.

The State Master Councilor shall report in writing to the State Chapter at each Annual State Conclave his entire official acts, whether performed in person or by a Personal Representative.

The State Senior Councilor, State Junior Councilor, State Scribe and Illustrious Knight Commander shall: represent the State Master Councilor when so ordered; assist the State Master Councilor in every way possible in the discharge of his duties.

The State Scribe shall record the minutes of the business sessions of the Annual State Conclave and any official Jurisdictional meetings. He shall then within sixty (60) days have the aforesaid minutes, together with the Charter and Standard Operating Procedure or their last revision, compiled, published, and distributed as follows:

- One copy to the Executive Officer and one copy to each member of the International Supreme Council residing in the Jurisdiction of Florida.
- One copy to the State Master Councilor, State Senior Councilor, State Junior Councilor, and Illustrious Knight Commander.

The State Scribe, with the approval of the State Scribe Advisor, shall have the authority to correct any grammatical and typographical errors in the minutes and Standard Operating Procedure as he deems necessary and appropriate.

The State Scribe shall keep and maintain a true copy of the Charter, and Standard Operating Procedure of the Florida DeMolay Chapter. He shall also supply a copy for the State Master Councilor, Chief of Staff, Director of Conclave, and Executive Officer of Florida at the Annual State Conclave.

The State Appointed Officers of this State Chapter shall include the Officers necessary for the function of the State Chapter. The State Appointed Officers shall assist the State Master Councilor in his work.

The State Master Councilor may add or remove committees as he sees fit with the approval of the State Chapter Dad.

There shall be an Annual State Conclave, held in or about the month of July at a specific time and place to be determined by the Director of Conclave, Executive Officer, and State Master Councilor.

There shall be an Annual State Mini-Conclave, held in or about the month of January at a specific time and place to be determined by the Director of Conclave, Executive Officer, and State Master Councilor.

There shall be Ritual Competition, Sports Competition, Election and Appointment of State Officers and any other business for the Good of the Order held at the Annual State Conclave and Mini-Conclave.

The Director of Conclave shall make decisions concerning the registration of chapters. The SOP may be changed by vote of the DeMolays at any State Chapter meeting. The State Master Councilor can amend the SOP if he sees fit with the approval of the State Chapter Dad.

Chapters around the state may institute any programs sanctioned by the Bylaws Rules and Regulation of ISC including a Pages program that they wish.

**APPENDIX E:
CHARTER OF THE PAST STATE OFFICER'S ASSOCIATION
OF THE ORDER OF DEMOLAY IN FLORIDA**

The Past State Officer's Association of the Order of DeMolay in Florida is hereby established subject to the following guidelines.

Purpose

The purpose of this Association shall be solely to aid and support the Order of DeMolay in Florida in any way(s) deemed appropriate by its membership.

Membership

The membership of this Association shall consist of all Past Elected State Officer, Past State Scribe and Past State Scribe-Treasurers of the Florida DeMolay Association who have reached the age of 21.

Meetings

The Association shall meet at least once each year at the Annual Conclave of the Florida DeMolay Association. The immediate Past State Master Councilor shall lead this up.

Officers

This Association shall have a Chairman, elected by a majority vote of the members present at the annual meeting, who shall serve for a term of one year. The Chairman shall preside at all meetings of this Association.

APPENDIX F: STATE SWEETHEART RULES

1. Each Chapter which is in good standing may submit a candidate for competition. By her election as a Chapter Sweetheart, the Chapter Sweetheart who meets the qualifications as listed in paragraph #3, is entitled to participate in this competition. If she is not eligible or does not wish to run, the members of the Chapter may offer her position to an eligible Past Chapter Sweetheart. Any eligible past or present Chapter Sweetheart must be approved by the Chapter Advisory Council before submitting her intentions to run for State Sweetheart. Only one entry per Chapter.
2. Each candidate must submit a completed application form, qualifications form and consent form to the State Sweetheart Coordinator/or designee prior to the formal opening of Conclave with all required materials (i.e., photo, medical release form, etc., including all necessary signatures and approvals).
3. Qualifications:
 - a. Candidates must be a young lady at least 16 years of age, but not yet 21 on the first day of summer Conclave.
 - b. Candidates must be a Past of current Chapter Sweetheart.
 - c. Candidates must be willing to travel to various parts of Florida and other jurisdictions if asked, with a Chaperone as defined in the Rules and Regulations.
 - d. Candidates must work on a minimum of at least Part 1 of the DeMolay Leadership Correspondence Course at Conclave or prior to Conclave.
 - e. Candidates cannot be or have been married or pregnant at the time of election or at any time during her term as State Sweetheart.
 - f. In the event that the State Sweetheart resigns, or is removed from office, the EO will determine if the position is to be filled or vacated for the remainder of that term. Only those applications properly submitted during the effected term will be considered.

**AMENDMENT TO THE STANDARD OPERATING
PROCEDURE REGARDING REQUIREMENTS TO RUN
FOR STATE OFFICE**

Be it resolved, that the Standard Operating Procedure be amended such that Candidates for the office of State Master Councilor must be, at the time of their election, at least one of the following: a past or current State Senior Councilor of the Florida Jurisdictional Chapter (FJC), a past or current State Junior Councilor of the FJC, a past State Scribe of the FJC, or a past Illustrious Knight Commander of the Col. James “Nick” Rowe Priory. Further, candidates for the office of State Master Councilor must submit a Letter of Intent at least 90 days before the opening of Conclave. Letters of Intent for State Master Councilor must include a Plan of Term, proof of completion of five LCCs, proof of receiving the Representative DeMolay award, and proof of being a Past Master Councilor. Also, the previous qualification to be a high school graduate or its equivalent be struck from the current requirements for the office of State Master Councilor.

Be it also resolved, that Letters of Intent for all offices of this Jurisdictional Chapter must include, from a parent or legal guardian of the candidate, a letter approving their candidacy.

Be it also resolved, that all parts of the Standard Operating Procedure relevant to the automatic succession of State Senior Councilor to State Master Councilor be struck. There shall now be a traditional election process for the office of State Master Councilor.
